International Kirkland Minerals Inc. ("IKI" / the "Company") announces that effective today, the Company has abandoned its option on the Huskies property in the Lac Rocher area of northern Quebec.

The Huskies property was optioned by IKI in early February 1999 from a private vendor. The terms of this option agreement are outlined in the Company's February 9, 1999 press release. IKI along with Bushman Resources Inc., which optioned the Huskies property pursuant to the terms and conditions of an agreement announced April 8, 1999, collectively completed ground geophysical surveys and approximately 584 metres of drilling in three holes concluding on or about June 15, 1999. No results of economic significance for Cu, Ni, Au, Ag or Zn were encountered from the above-mentioned drilling.
