WEEKLY PRESS RELEASE ON TREASURY SHARES BUYBACK PLAN

Cernusco Lombardone (LC). *October 20, 2025* - Technoprobe S.p.A., a leading company in the design and production of probe cards (the “**Company**” or “**Technoprobe**”) listed on Euronext Milan, declares the purchase on the Euronext Milan market, according to the Shareholders’ Meeting on July 10, 2025 approval and initiated by the Board of Directors on July 23, 2025 (already object of informative also according to art.144 bis of the Consob Regulation 11971/99 and art. 132 of Legislative Decree no. 58/98), in the period from October 13, 2025 to October 17, 2025, of n. 150,000 ordinary shares (equal to 0.02296% of the share capital) at the weighted average price of Euro 8.78641 for a total value of EUR 1,313,799.70.

Purchases were made through the intermediary Intesa SanPaolo S.p.A.
