SUPPLEMENT TO THE PRESS RELEASE REGARDING THE APPROVAL OF CONSOLIDATED **RESULTS AS AT SEPTEMBER 30,25**

Cernusco Lombardone (LC), November 12th, 2025 - With reference to the press release issued on November 10, 2025, concerning the approval of consolidated results as of September 30, 2025, and to the subsequent earnings conference call held at 6:00 PM on the same day, Technoprobe S.p.A. provides the following clarification.

In response to the anticipated growth in testing demand within its reference market, the Company confirms that the planned increase in production capacity is expected to approximately double the current levels. This expansion will be supported by investments to be carried out over the next 24 months.

Furthermore, in light of improved market growth prospects compared to those outlined during the Capital Market Day held on April 14, 2025 - where Technoprobe presented its growth drivers, strategic roadmap, and medium-term target model - the Company now expects to achieve its previously announced targets of Revenues (€850–€900 million) and Ebitda Margin (38%–40%) by 2027, one year ahead of schedule, as also highlighted during the aforementioned conference call.
