IBC is a company incorporated under the laws of British Columbia. IBC’s common shares are currently listed on the TSX Venture Exchange under the symbol “IBC”.

On June 9, 2017 IBC disposed of 6,000,000 common shares (the “**Shares**”) of the Issuer at a price of \$0.04 per Share in connection with 4,000 Shares and at a price of \$0.035 per Share in connection with 5,996,000 Shares.

On June 9, 2017, IBC disposed of 6,000,000 Shares of the Issuer, reducing its shareholdings in the Issuer by approximately 8.6%.

IBC disposed of ownership of the Shares.
