Termination of acquisition of Anhydrite Minerals Inc. and change of management.

The previously announced proposed qualifying transaction involving the acquisition of all the issued and outstanding shares of Anhydrite Minerals Inc. has been terminated by the Corporation and will not be proceeded with.

Peter Guest, James Martin and Brigitte McArthur have resigned as directors and officers of the Corporation; Timothy Noble and Benjamin Ainsworth have been appointed as directors of the Corporation; Larry Whitehead has been appointed as President, Chief Executive Officer, Chief Financial Officer and Secretary of the Corporation. In conjunction with the changes to the board, Peter Guest, James Martin and Brigitte McArthur have sold an aggregate of 300,000 common shares of the Corporation to Messrs. Noble and Ainsworth, each receiving 150,000 common shares. All of the 300,000 common shares of the Corporation are held in escrow and will not be released from escrow unless the Corporation completes a qualifying transaction.
