DARELLE ANNOUNCES FINANCIAL RESULTS

Vancouver, B.C. – April 17, 2023 – Darelle Online Solutions Inc. (“darelle” and/or the “**Company**”) (TSXV: “DAR”) today released its interim financial and operational results for the six-month period ended February 28, 2023.

Quarterly Financial Results

- The Company generated revenue of \$20,756 during the period compared with \$54,733 during the same six month period in 2022. Revenue is comprised of a set-up fee and a flat administration fee (“Processing Fees) per raffle ticket sold by organizations. The Company realized set-up fees of \$6,750 with the remaining revenue (\$14,006) in processing fees. Processing fees are recognized once the raffle draw is complete and/or the organization has sold all available tickets.
- The Company reported a 128,853 (ive loss of \$77,631 ((\$0.00) per share) during the six month period ended February 28, 2023 compared to a comprehensive loss of \$128,853 ((\$0.00) per share) during the same six month period in the 2022 fiscal year.

Darelle.com is an online marketplace which has developed a platform in which charitable and nonprofit organizations can create, sell, deliver, and manage their raffle ticket and 50/50 draws completely online. The Company is listed on the TSX Venture Exchange as a Tier 2 Technology Issuer. The Company has a total of 73,708,147 common shares issued and outstanding.
