DARELLE ANNOUNCES FINANCIAL RESULTS

Vancouver, B.C. – January 27, 2025 – Darelle Online Solutions Inc. (“darelle” and/or the “Company”) (TSXV: “DAR”) today released its interim financial results for the three-month period ended November 30, 2024.

The full text of darelle’s first quarter financial results is contained in its unaudited condensed interim consolidated financial statements for the three-month periods ended November 30, 2024 & 2023 and the related management’s discussion and analysis, copies of which are available electronically on darelle’s profile on the System for Electronic Document Analysis and Retrieval (“SEDAR”) at <https://www.sedarplus.ca/darelle>

Annual Financial Results

- The Company generated revenue of \$20,064 during the period compared with \$27,643 during the same three-month period in 2023. Revenue is comprised of a set-up fee and a flat administration fee (“Processing Fees”) per raffle ticket sold by organizations. The Company realized set-up fees of \$1,750 with the remaining revenue (\$18,314) in processing fees. Processing fees are recognized once the raffle draw is complete and/or the organization has sold all available tickets.
- The Company reported a comprehensive loss of \$34,032 (\$0.01 per share) compared to a comprehensive loss of \$21,780 during the three-month period ended November 30, 2023 (\$0.01 per share).

Operational Update

The Company continues to look at opportunities to expand the geographical scope of the darelle.com platform. Currently the Company only operates in the province of British Columbia. Opportunities for expansion include the provinces of Manitoba, Saskatchewan, Alberta, Nova Scotia, and Ontario. The Company is also reviewing opportunities for expansion into the United States. Expansion will be dependent upon the Company securing a strategic partner and/or equity financing.

The Company also continues to seek opportunities to create shareholder value through strategic acquisitions and/or transactions.

Darelle Online Solutions Inc. is a British Columbia corporation with its head office in Vancouver, British Columbia. Darelle.com is an online marketplace which has developed a platform in which charitable and nonprofit organizations can create, sell, deliver, and manage their raffle ticket and 50/50 draws completely online. The Company is listed on the TSX Venture Exchange as a Tier 2 Technology Issuer. The Company has a total of 2,456,939 common shares issued and outstanding.
