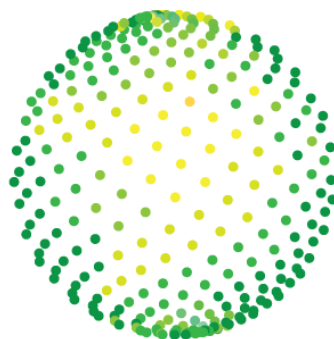

GENERAL

This Management's Discussion and Analysis ("MD&A") supplements, but does not form part of, the annual audited financial statements of Pan Global Resources Inc. (the "Company" or "Pan Global" or "PGZ") for the fiscal year ended January 31, 2016. The following information, prepared as of May 30, 2016 should be read in conjunction with the audited financial statements for the year ended January 31, 2016 and the related notes therein. The Company reports its financial position, results of operations and cash flows in accordance with International Financial Reporting Standards ("IFRS") as issued by the International Accounting Standards Board ("IASB"). All amounts are expressed in Canadian dollars unless otherwise indicated. Additional information relevant to the Company's activities can be found on SEDAR at www.sedar.com and on the Company's website at www.panglobalresources.com.

COMPANY OVERVIEW

The Company was incorporated under the provisions of the Business Corporations Act (British Columbia) on February 1, 2006 and is classified as a Tier II mining company, effective June 8, 2009 and trades on the TSX Venture Exchange. On December 21, 2009 the Company changed its name from Mosam Capital Corp. to Pan Global Resources Inc.

Pan Global was primarily focused on the early stage exploration through to development of resources of borate (B) and associated lithium (Li) in the Balkans. Through a share purchase agreement ("Purchase Agreement") for the private company Lithium Li Holdings Inc. ("Lithium Li"), PGZ was directly targeting analogs of Rio Tinto's nearby Jadar Deposit. Via wholly-owned subsidiaries, Lithium Li was granted 15 exploration licenses in the Republic of Serbia totaling approximately 1300km², and one in the Republic of Bosnia and Herzegovina.

On February 14, 2011 the Company signed a definitive option agreement to earn an undivided 51% interest, with further options to earn an undivided 65% or 80% interest, in Lithium Li. This agreement was superseded on August 28, 2013 when the Company executed the Purchase Agreement to purchase a 100% interest in Lithium Li and all its current and future licences for consideration of cash payments totaling \$5,800,000, and the issuance of a total of 7,000,000 Pan Global shares to the current vendor of Lithium Li, Mr. Petr Palkovsky, over a period of four years and linked to the Company's ability to raise financing in the future. In February 2015, the Company and Mr. Palkovsky amended the terms of the Purchase Agreement. Under the new amended agreement, all future cash and share considerations were replaced by the issue of additional Pan Global shares to Mr. Palkovsky. The terms of the agreement are detailed in the Company's news release dated February 16, 2015 (www.panglobalresources.com). The amended agreement was approved by the TSX Venture Exchange.

The Company proceeded to drill select licences selected as the better targets for both borates and lithium. Although results were encouraging and indicated that there is potential for a large basin of mineralization, drilling did not intersect intervals mineralization of the grades and widths that could prove economic. The Company could not attract partners to invest and advance the projects. Furthermore the Company could not attract any additional investment from the financial markets. Based on these factors the Company has relinquished all licences and is actively seeking other opportunities in the mineral sector going forward.

OPERATIONS REVIEW

In Serbia, exploration was ongoing since early 2011 with emphasis on a program of geological mapping, geochemical sampling and gravity geophysics to help generate and prioritize drill targets in an original portfolio of 15 approved exploration licences. Due to a continuing inability to raise financing in a very difficult market, and consequent lack of funds to undertake exploration, work during 2014 was confined to a continued reduction in fixed costs and government relations focused on retention of the exploration licences. The field work program requirements of the Serbian Ministry of Mining and Energy for calendar 2014 were not completed. This continued into 2015 and the Company decided to relinquish all licences.

OUTLOOK

In the coming months, Pan Global will focus on a new opportunity in the mineral sector. The focus will be to acquire or joint venture projects that the Company believes can be advanced to pre- feasibility or feasibility

stage. The Company is currently reviewing several projects and we expect to finalize discussions over the next few months.

CHANGE OF MANAGEMENT

In June 2015, Mr. Julian Bavin resigned as President and CEO of the Company. He remains a director of Pan Global. Mr. Brian Kerzner, Pan Global director, is acting as interim-CEO.

RESULTS OF OPERATIONS

For the Three Months Ended January 31, 2016

The net loss for the quarter was \$85,480 of which \$41,563 related to the fair value of common shares issued to Mr. Palkovsky pursuant to the amended share purchase agreement, compared to a net loss of \$1,014,022 for the prior year's comparative quarter. The prior year's quarter included an impairment charge of \$998,750 due to the write-off of the mineral licenses in Serbia. The Company is currently incurring minimal costs for accounting, office, regulatory and legal.

For the Twelve Months Ended January 31, 2016

The net loss for the year ended January 31, 2016 was \$235,291 compared to a net loss of \$1,638,054 for the prior year. In the prior year the Company was still spending funds on its formerly held Serbian licenses and there was a \$998,750 impairment charge. In the current year, there were no exploration activities, and the CEO resigned at the beginning of Q2, reducing management fees accordingly.

LIQUIDITY AND CAPITAL RESOURCES

Requirement of Additional Equity Financing

The Company has relied entirely on equity financings for all funds raised to date for its operations. As noted above, the Company needs more funds to operate. Capital markets may not be receptive to offerings of new equity, whether by way of private placements or public offerings. This may be further complicated by the limited liquidity for the Company's shares, restricting access to some institutional investors. The Company's growth and success is dependent on external sources of financing which may not be available on acceptable terms.

In October 2010, the Company signed a management services agreement with the President and CEO of the Company. Effective October 15, 2010, the Company is committed to pay annual management fees of \$250,000 to the officer for an indefinite term. The agreement can be terminated by both parties giving a notice of termination. Mr. Julian Bavin, President and CEO, resigned in June 2015.

In August 2013, the Company signed a management services agreement with a company controlled by a director of the Company. Effective August 28, 2013, the Company is committed to pay annual management fees of \$240,000 for an indefinite term, subject to certain termination provisions. In February 2015, the Company amended the terms of the agreement (see Company news release dated February 16, 2015 at www.panglobalresources.com) and do not have any further obligations under the August 28, 2013 agreement.

Fair value hierarchy

Financial instruments recorded at fair value on the statement of financial position are classified using a fair value hierarchy that reflects the significance of the inputs used in making the measurements. The fair value hierarchy has the following levels:

- a) Level 1 - Unadjusted quoted prices in active markets for identical assets or liabilities;
- b) Level 2 - Inputs other than quoted prices that are observable for assets or liabilities, either directly or indirectly; and
- c) Level 3 - Inputs for assets and liabilities that are not based on observable market data.

The fair value hierarchy requires the use of observable market inputs whenever such inputs exist. A financial instrument is classified to the lowest level of the hierarchy for which a significant input has been considered in measuring fair value. The carrying value of receivables and accounts payable and accrued liabilities approximated their fair value because of the short-term nature of these instruments.

Financial Instrument Risk Exposure and Risk Management

The Company's activities expose it to a variety of financial risks: market risk (including currency risk, cash flow interest rate risk and price risk), credit risk and liquidity risk. The Company's overall risk management program focuses on the unpredictability of financial markets and seeks to minimize potential adverse effects on the financial performance of the Company.

Credit Risk

Credit risk arises from cash and deposits with banks, as well as credit exposure to customers, including outstanding receivables and committed transactions. There is no significant concentration of credit risk other than cash deposits. The Company's cash deposits are primarily held with a Canadian chartered bank. The

Company has minimal accounts receivable exposure as it relates to amounts due from the Government of Canada pursuant to sales tax credits.

Interest Rate Risk

As the Company does not have significant interest-bearing assets, the Company's income and operating cash flows are not significantly affected by changes in market interest rates.

Liquidity Risk

Liquidity risk is the risk that the Company will not be able to meet its financial obligations as they fall due. The Company has in place a planning and budgeting process to help determine the funds required to ensure the Company has the appropriate liquidity to meet its operating and growth objectives. The Company has historically relied on issuance of shares and warrants to fund exploration programs and will require doing so again in the future.

Foreign Currency Risk

The Company has identified its functional currency as the Canadian dollar. Certain of the Company's accounts payable are denominated in Serbian Dinar (RSD). The Company's exposure to foreign currency risk arises primarily on fluctuations between the Canadian dollar and this currency.

RISKS AND UNCERTAINTIES

In addition to the usual risks associated with an investment in an exploration-stage company, management and the directors of the Company believe that, in particular, the following risk factors should be considered. It should be noted that the list is not exhaustive and that other risk factors may apply. An investment in the Company may not be suitable for all investors.

No Assurance of Titles or Borders

The acquisition of the right to exploit mineral properties is a very detailed and time consuming process. There can be no guarantee that the Company has acquired title to any such surface or mineral rights or that such rights will be obtained in the future. To the extent they are obtained, titles to the Company's surface or mineral properties may be challenged or impugned and title insurance is generally not available. The Company's surface or mineral properties may be subject to prior unregistered agreements, transfers or claims and title may be affected by, among other things, undetected defects. Such third party claims could have a material adverse impact on the Company's operations.

Mineral Property Exploration and Mining Risks

The business of mineral deposit exploration and extraction involves a high degree of risk. Few properties that are explored ultimately become producing mines. At present, the Company has relinquished its licenses and is looking for new opportunities in the mineral exploration arena. The main operating risks include: ensuring ownership of and access to mineral properties by confirmation that option agreements, claims and leases are in good standing and obtaining permits for drilling and other exploration activities.

The Company may earn an interest in certain properties through option agreements and acquisition of title to the properties is only completed when the option conditions have been met. These conditions generally include making property payments, incurring exploration expenditures on the properties and can include the satisfactory completion of pre-feasibility studies. If the Company does not satisfactorily complete these option conditions in the time frame laid out in the option agreements, the Company's title to the related property will not vest and the Company will have to write-off the previously capitalized costs related to that property.

The market prices for silver, gold and other metals can be volatile and there is no assurance that a profitable market will exist for a production decision to be made or for the ultimate sale of the metals even if commercial quantities of precious and other metals are discovered.

Financing and Share Price Fluctuation Risks

The Company has limited financial resources, has no source of operating cash flow and has no assurance that additional funding will be available to it for further exploration and development of its projects. The Company's ability to secure a new project is dependent upon the Company's ability to obtain financing through equity or debt financing or other means.

The securities markets can experience a high degree of price and volume volatility, and the market price of securities of many companies, particularly those considered to be exploration stage companies such as the Company, may experience wide fluctuations in share prices which will not necessarily be related to their operating performance, underlying asset values or prospects. There can be no assurance that these kinds of share price fluctuations will not occur in the future, and if they do occur, how severe the impact may be on the Company's ability to raise additional funds through equity issues.

Insured and Uninsured Risks

In the course of exploration, development and production of mineral properties, the Company is subject to a number of risks and hazards in general, including adverse environmental conditions, operational accidents, labor disputes, unusual or unexpected geological conditions, changes in the regulatory environment and natural phenomena such as inclement weather conditions, floods, and earthquakes. Such occurrences could result in the damage to the Company's property or facilities and equipment, personal injury or death, environmental damage to properties of the Company or others, delays, monetary losses and possible legal liability. Although the Company may maintain insurance to protect against certain risks in such amounts as it considers reasonable, its insurance may not cover all the potential risks associated with its operations. The Company may also be unable to maintain insurance to cover these risks at economically feasible premiums or for other reasons. Should such liabilities arise, they could reduce or eliminate future profitability and result in increased costs, have a material adverse effect on the Company's results and a decline in the value of the securities of the Company. Some work is carried out through independent consultants and the Company requires that all consultants carry their own insurance to cover any potential liabilities as a result of their work on a project.

Environmental Risks and Hazards

The activities of the Company are subject to environmental regulations issued and enforced by government agencies. Environmental legislation is evolving in a manner that will require stricter standards and enforcement and involve increased fines and penalties for non-compliance, more stringent environmental assessments of proposed projects, and a heightened degree of responsibility for companies and their officers, directors and employees. There can be no assurance that future changes in environmental regulation, if any, will not adversely affect the Company's operations. Environmental hazards may exist on properties in which the Company holds interests which are unknown to the Company at present.

Competition

The Company will compete with many companies and individuals that have substantially greater financial and technical resources than the Company for the acquisition and development of its projects as well as for the recruitment and retention of qualified employees.

Conflicts of Interest

The Company's directors and officers may serve as directors or officers of other companies or have significant shareholdings in other resource companies and, to the extent that such other companies may participate in ventures in which the Company may participate, the directors of the Company may have a conflict of interest in negotiating and concluding terms respecting the extent of such participation. In the event that such a conflict of interest arises at a meeting of the Company's directors, a director who has such a conflict will abstain from voting for or against the approval of such participation or such terms. In accordance with the laws of British Columbia, the directors of the Company are required to act honestly, in good faith and in the best interests of the Company. In determining whether or not the Company will participate in a particular program and the interest therein to be acquired by it, the directors will primarily consider the degree of risk to which the Company may be exposed and its financial position at that time.

Outstanding Share Data

As of May 30, 2016 there were 42,636,515 common shares issued and outstanding. There were also 2,522,000 stock options outstanding with exercise prices ranging between \$0.20 and \$1.03 per option.
