This Management's Discussion and Analysis ("MD&A") of Nickel Creek Platinum Corp. and its subsidiaries (collectively referred to as "**Nickel Creek Platinum**" or the "**Company**") is prepared as of August 9, 2021 and provides analysis of the Company's financial results for the three and six months ended June 30, 2021. This MD&A should be read in conjunction with the Company's audited consolidated financial statements for the year ended December 31, 2020 and the related notes for the year then ended which have been prepared in accordance with International Financial Reporting Standards ("IFRS") issued by the International Accounting Standards Board ("IASB") as set out in the Chartered Professional Accountants of Canada Handbook ("CPA Canada Handbook") and the accompanying unaudited condensed consolidated interim financial statements for the three and six months ended June 30, 2021 and the related notes for the period then ended ("June 30, 2021 Financial Statements") also prepared in accordance with IFRS. This MD&A should also be read in conjunction with the MD&A for the year ended December 31, 2020.

Financial information contained herein is expressed in Canadian dollars, unless otherwise stated. Readers are cautioned that this MD&A contains "forward-looking statements" and that actual events may vary from management's expectations. Readers are encouraged to read the cautionary note contained herein regarding such forward-looking statements. This MD&A was reviewed, approved and authorized for issuance by the Audit Committee of the Company's Board of Directors on August 9, 2021.

Nickel Creek Platinum is a public company incorporated in British Columbia, and its common shares (the "Shares") are listed on the Toronto Stock Exchange (the "**TSX**"), trading under the symbol "NCP", and on the OTCQB under the symbol "NCPCF". The Company maintains its registered and head office at 1700-666 Burrard Street, Vancouver, British Columbia, V6C 2X8.

The Company's principal business activity is the exploration and evaluation of nickel and platinum group metals ("PGM") mineral properties in North America. The Company's flagship asset is its 100%-owned Nickel Shāw Project (the "Project"), formerly known as the "Wellgreen Project", located in southwestern Yukon, Canada. The Project contains the nickel-copper-PGM ("Ni-Cu-PGM") Wellgreen deposit ("Wellgreen deposit"), as well as the Arch, Burwash, Formula, Musk and Quill claims, comprised of 711 mineral claims and 91 quartz mining leases, totalling 14,650 hectares. The Wellgreen deposit is a polymetallic deposit with mineralization that includes the significant co-occurrence of nickel, copper, cobalt, PGM and gold. The Wellgreen deposit and the Arch, Burwash and Quill claims are subject to a 1% net smelter return ("NSR") royalty ("Wellgreen NSR Royalty") on future production.

The Project is accessible via the Alaska Highway, a paved highway that provides access to all-season, deep sea ports in Haines and Skagway, Alaska approximately 300 kilometres west-northwest from Whitehorse and 30 kilometres from Burwash Landing. The Project is one of the largest undeveloped nickel, copper, cobalt and PGM deposits outside of South Africa and Russia.

2. BUSINESS OVERVIEW SUMMARY

COVID-19

Since the month of March 2020, significant measures have been implemented in Canada and the rest of the world in response to the increased impact from novel coronavirus ("COVID-19"). The Company continues to operate the business and, to date, COVID-19 has not had a significant impact on our operations. While the impact of COVID-19 is expected to be temporary, the current circumstances are dynamic and the future impact of COVID-19 on our business operations cannot be reasonably estimated at this time. The Company closed on an equity financing during the month of April 2021 (see "Financing Activities") and closed on a \$3.625 million financing during the second quarter of 2020. Further, the Company conducted an exploration program in 2020 and is currently conducting an exploration program that commenced during the first week of July 2021; however, COVID-19 may still have an adverse impact on project exploration plans, financial position, cash flows and results of operations during 2021 and beyond.

Financing Activities

On April 26, 2021, the Company announced that it closed its previously announced private placement whereby the Company issued 31,753,222 units ("Units") for aggregate gross proceeds of approximately \$2.9 million and 6,363,635 "flow-through" units ("FT Units") for gross aggregate proceeds to the Company of \$0.7 million, for total gross proceeds of approximately \$3.6 million (collectively the "2021 Private Placement").

The Units were priced at \$0.09 with each Unit consisting of one common share in the capital of the Company (each, a "Common Share") and one Common Share purchase warrant (each, a "Warrant"), with each Warrant exercisable for one Common Share (each, a "Warrant Share") at an exercise price of \$0.15 for a period of five (5) years from the date of issuance, subject to adjustment upon certain customary events. Each FT Unit was priced at \$0.11 with each FT Unit consisting of one "flow-through" Common Share (each, a "FT Share") and one Common Share purchase warrant (each, a "FT Warrant"), with each FT Warrant exercisable for one Common Share (each, a "FT Warrant Share") at an exercise price of \$0.15 for a period of five (5) years from the date of issuance, subject to adjustment upon certain customary events.

The Company's major shareholders Electrum Strategic Opportunities Fund L.P. and Drake Private Investments LLC acquired 11,881,000 and 4,444,444 Units, respectively, under the 2021 Private Placement.

The gross proceeds from the 2021 Private Placement will be used to fund the Company's exploration program, which commenced during the first week of July 2021 ("2021 Exploration Program"), the investigation of strategic opportunities, ongoing permitting activities and holding costs at the Nickel Shāw Project, and for general corporate expenses and working capital purposes, with the gross proceeds derived from the sale of the FT Units being used by the Company solely to fund "Canadian exploration expenses" that will qualify as "flow-through mining expenditures", each as defined under the Income Tax Act (Canada) ("Resource Expenditures").

In addition, in connection with the issuance of 5,000,000 Units and 6,363,635 FT Units, certain finders received payment of a finder's fee equal to 6% of the gross proceeds received by the Company from the sale of Units and FT Units, which finder's fee were payable in Units (766,666) at an implied issue price of the Units.

All shares and warrants issued under the 2021 Private Placement are subject to a statutory four-month hold period from the date of closing.

Nickel Shāw Project, Yukon, Canada

On June 26, 2017, the Company announced that, due to changes in the resource estimate, improved understanding of the geologic model, updated metallurgical results, work underway on relocation of the plant and tailings facilities, mine planning optimization and other factors that changed since the publication of the preliminary economic assessment ("PEA") on March 19, 2015 (the "2015 PEA"), the 2015 PEA for the Project had become outdated and should not be relied upon.

On September 25, 2018, the Company announced that it would not be completing its previously announced PEA on the Project and would revisit completing a PEA when financial market conditions improve and higher commodity prices are realized, including once nickel prices settle in the range of at least US\$9.00-US\$11.00 per pound. Any decision at that time will need to factor in all relevant considerations, including but not limited to commodity pricing, mine plan, capital and operating costs, metal recoveries and capital market conditions.

On November 9, 2018, pursuant to National Instrument 43-101 ("NI 43-101") – Standards of Disclosure for Mineral Projects, the Company filed a technical report with an effective date of September 25, 2018 entitled, "Ni-Cu-PGM Project, 2018 NI 43-101 Resource Update, Yukon, Canada" ("Technical Report"), prepared by Independent Mining Consultants, Inc. ("IMC"), with the participation and contribution of AGP Consultants Inc. ("AGP").

On an ongoing basis, the Company continues to maintain environmental baseline activities, consider optimization alternatives and investigate additional opportunities. Further, as described below, the Company conducted a 2020 exploration program and is currently conducting the 2021 Exploration Program.

Readers are cautioned that mineral resources are not mineral reserves and do not have demonstrated economic viability.

Readers are also cautioned that Inferred mineral resources are considered too speculative geologically to have economic considerations applied to them.

2021 Exploration Program

The Company commenced its 2021 Exploration Program during the first week of July 2021 and is anticipated to be completed by the end of August 2021. The 2021 Exploration Program is being financed by the remaining dollars available from the \$1.425 million of flow-through dollars received during June 2020 ("2020 FT Private Placement") and the \$700 thousand of flow-through dollars raised during the month of April 2021 ("2021 FT Private Placement"). See additional details in Section 4, under Contractual Commitments, Flow-through Financings on page 10 of this MD&A. The rationale for the 2021 Exploration Program is described below.

On December 10, 2020, the Company announced the results of its 2020 ground-based EM geophysics and drilling program ("2020 Geophysics Program"). Using a large loop transient electromagnetic ("TEM") survey, the 2020 Geophysics Program tested the Arch and Burwash exploration target areas, which are along trend approximately 2.0 kilometres to the northwest and 5.0 kilometres southeast (respectively) of the main Wellgreen deposit. This program resulted in identification of 42 conductive anomalies, with 11 of these determined to be potentially massive nickel-copper sulphide. The Company is conducting the 2021 Exploration Program with the focus to drill the 11 high priority targets identified in the Arch and Burwash target areas. These priority targets were field-checked and ranked for testing as part of the 2021 Exploration Program.

Permitting

The Company is continuing environmental baseline studies and community engagement to support a potential project proposal to the Executive Committee of the Yukon Environmental and Socio-economic Assessment Board ("YESAB").

Expenditures

During the three and six months ended June 30, 2021, the Company incurred net expenditures of \$0.2 million and \$0.3 million, respectively, on the Project which were primarily related to environmental and permitting activities.

Qualified Persons

The scientific and technical information disclosed in relation to the 2020 Geophysics Program was reviewed and approved by Brian Bengert, P. Geo., who is a Qualified Person ("QP") as defined in National Instrument 43-101 – Standards of Disclosure for Mineral Projects ("NI 43-101"), and an independent consultant to the Company. All other scientific and technical information disclosed in this MD&A was reviewed and approved by Cam Bell, an independent geologist on a consulting retainer contract with the Company, and a QP as defined in NI 43-101.

Impairment Analysis

In accordance with the Company's accounting policy, long lived assets are reviewed for impairment at the end of each reporting period or whenever events or changes in circumstances may indicate that their carrying amount may exceed their recoverable amount. The Company's conclusion is that there were no impairment indicators at June 30, 2021; hence an impairment test is not required at this time but that the Company will continue to monitor impairment indicators on a quarterly basis.

In the event that the prospects for the development of the Project are enhanced in the future, an assessment of the recoverable amount of the Project will be performed at that time, which may lead to a reversal of part or all of the impairment adjustment recorded during the 2018 calendar year.

Use of Proceeds from 2020 Private Placement

During 2020, the Company raised \$3.625 million with the issuance of 44.0 million 2020 Units (\$2.2 million) and approximately 6.4 million 2020 FT Units (\$1.425 million) (collectively the "2020 Private Placement"). The 2020 Units were priced at \$0.05 with each 2020 Unit consisting of one Common Share in the capital of the Company and one Common Share purchase warrant (each, a "2020 Warrant"), with each 2020 Warrant exercisable for one Common Share (each, a "2020 Warrant Share") at an exercise price of \$0.10 for a period of five (5) years from the date of issuance. Each 2020 FT Unit was priced at \$0.055 with each 2020 FT Unit consisting of one "flow-through" Common Share (each, a "2020 FT Share") and one Common Share purchase warrant (each, a "2020 FT Warrant"), with each 2020 FT Warrant exercisable for one Common Share (each, a "2020 FT Warrant Share") at an exercise price of \$0.10 for a period of five (5) years from the date of issuance.

The net proceeds from the 2020 Private Placement are being used to fund exploration programs, investigation of strategic transactions, ongoing permitting activities, and holding costs at the Nickel Shāw Project, and for general corporate costs and working capital purposes.

At June 30, 2021, the Company has expended approximately \$854 thousand (December 31, 2020 - \$808 thousand) of the \$1.425 million raised in the 2020 FT Private Placement, and intends to spend the remaining amount of approximately \$571 thousand on the 2021 Exploration Program.

Annual General Meeting

On June 2, 2021, the Company announced that all of the following business items were approved by the requisite majority of shareholder votes cast at the annual general meeting of shareholders:

- setting the size of the Board of Directors at seven;
- electing each management-nominated director; and
- appointing PricewaterhouseCoopers LLP as the Company's auditor

Company Outlook

The Company will continue to maintain environmental baseline studies and community engagement and ensure the Project's quartz claims and surface leases remain in good standing. As noted earlier, the Company is currently conducting the 2021 Exploration Program. In addition to the activities on the Project, the Company continues to be focused on reviewing and evaluating potential acquisitions and additional opportunities.

The Company's general and administrative ("G&A") expenses during the three-month period June 30, 2021 were higher than the recent quarters primarily due to the increased non-cash share-based compensation expense.

Three Months Ended June 30, 2021 Compared with the Same Period in 2020

The Company reported a net loss of \$0.2 million (\$0.00 loss per Share) for the three-month period ended June 30, 2021, which is \$0.5 million less than the net loss reported during the same period in 2020 and is primarily due to the \$0.5 million gain on marketable securities recorded during the three-month period ended June 30, 2021.

Marketable securities consist of common shares in a publicly traded mining company in connection with a prior year transaction. During the 2017 calendar year, the Company sold Ursa Major Minerals Inc. ("URSA"),

a wholly-owned subsidiary that held property in Ontario, to a private company (the "Purchaser"). The proceeds on the sale included cash consideration of \$200,000 (paid in instalments over three calendar years), 0.5% - 1.0% NSR on various properties held within URSA and common shares in the Purchaser. During the month of May 2021, the common shares of the Purchaser became publicly traded on the TSXV under Magna Mining Inc. At June 30, 2021, the Company owns 1,085,927 common shares of Magna Mining Inc. and the quoted market value of these common shares amounts to \$488,600 (December 31, 2020 - \$nil). The common shares of Magna Mining Inc. are recorded at quoted market value at each reporting period and gains or losses arising from changes in quoted market value are recognized in the consolidated statement of loss.

The \$0.1 million increase in G&A expenses when compared with the same period in 2020 is primarily due to a \$0.2 million increase in non-cash share-based compensation expense partially offset by a \$0.1 million reduction in salaries and wages. The increased non-cash share-based compensation expense is primarily due to the timing of this year's annual stock option grant (March 2021) compared to last year (June 2020) and the RSUs granted in December 2020.

Six Months Ended June 30, 2021 Compared with the Same Period in 2020

The Company reported a net loss of \$0.7 million (\$0.00 loss per Share) for the six-month period ended June 30, 2021, which is \$0.6 million less than the net loss reported during the same period in 2020 and is primarily due to the aforementioned \$0.5 million gain on the marketable securities recorded during the six-month period ended June 30, 2021.

The G&A expenses recorded during the six-month periods ended June 30, 2021 and 2020 amounted to \$1.1 million. The \$0.3 million reduction in salaries and wages was offset by increases in non-cash share-based compensation expense and other expenses. The \$0.3 million decrease in salaries and wages is primarily due to reduced headcount.

Operating activities

During the six-month period ended June 30, 2021, cash used in operating activities was \$0.2 million lower when compared to the same period in 2020 and the reduction was primarily due to reduced salaries and wages.

Investing activities

During each of the six months ended June 30, 2021 and June 30, 2020, cash used in investing activities amounted to \$0.2 million. The amounts used in investing activities during the six-month period ended June 30, 2021 were primarily for expenditures on environmental and permitting activities and the 2021 Exploration Program.

Financing activities

During the six months ended June 30, 2021, net cash proceeds from financing activities amounted to \$3.7 million. The \$3.7 million consisted of net proceeds of \$3.5 million derived from the sale of Units and the sale of FT Units described earlier in "Financing Activities", and proceeds of \$349 thousand on the exercise of stock options during the first quarter of 2021 partially offset by \$0.1 million used in financing activities relating to office lease payments as required under IFRS 16 – Leases ("IFRS 16").

The net cash proceeds of \$3.5 million received during the second quarter of 2021 from the closing of the 2021 Private Placement resulted in the issuance of an aggregate of 31.75 million Units at a price of \$0.09, 6.36 million FT Units at a price of \$0.11 and 0.77 million Units regarding the aforementioned finders fee. Each Unit consisted of one Common Share and a Warrant exercisable for one Common Share issued at an exercise price of \$0.15 for five years from the date of issuance.

The net cash proceeds of \$3.5 million from financing activities during 2020 consisted of net proceeds of \$3.6 million from the 2020 Private Placement partially offset by \$0.1 million used in financing activities relating to office lease payments as required under IFRS 16.

Liquidity and Capital Resources

The Company's sole source of funding has been the issuance of equity securities for cash and the sale of the Wellgreen NSR Royalty in 2015. The Company has not generated any revenue from its operations and does not expect to generate any revenue from its operations during the next twelve months.

The Company's liquidity is subject to fluctuations in the timing and occurrence of financing activities, general corporate costs and exploration, evaluation and development activities. Financing activities and certain general corporate costs can be highly uncertain.

At June 30, 2021, the Company had \$4.3 million in cash and cash equivalents (December 31, 2020- \$1.5 million). The Company had cash and cash equivalents balance of approximately \$3.7 million at August 9, 2021. For the foreseeable future, the Company will continue to seek capital through the issuance of equity, strategic alliances or joint ventures, and debt.

The Company had working capital of \$4.4 million at June 30, 2021 (December 31, 2020 - \$1.2 million).

The Company will continue requiring cash for operations and exploration and evaluation activities as expenditures are incurred while no revenues are generated. Therefore, its continuance as a going concern is dependent upon its ability to obtain adequate financing to fund future exploration, evaluation and development of the Project and the potential construction of a mine, in order to reach profitable levels of operation. These factors may cast significant doubt as to the Company's ability to continue as a going

concern and, accordingly, the ultimate use of accounting principles applicable to a going concern. The Company will be seeking additional funds during the 2022 calendar year. Management believes that the Company will be able to continue as a going concern for the foreseeable future and realize its assets and discharge its liabilities and commitments in the normal course of business. The June 30, 2021 Financial Statements do not reflect the adjustments to the carrying value of assets and liabilities and the reported expenses and balance sheet classifications that would be necessary should the going concern assumption be inappropriate, and those adjustments could be material.

The Company has managed its working capital by controlling its spending on its properties and operations. The Company will continue to incur costs while no revenues are being generated. If the Company is unable to obtain adequate additional financing, the Company will need to further curtail its activities until additional funds can be raised.

On an ongoing basis, the Company examines various financing alternatives to address future funding requirements. Although the Company has been successful in these activities in the past (see "Financing Activities" in Section 2), the Company has no assurance of the success or sufficiency of these initiatives in the future. The Company's ability to secure future financing is dependent on a variety of factors outside of the Company's control, including but not limited to, general market conditions, changes in economic conditions and fluctuations in commodity prices. See Section 7 "Risks and Uncertainties" below and the risk factors set out in the Company's AIF.

Contractual Commitments

Kluane First Nation Exploration Cooperation Agreement

The Company entered into an Exploration Cooperation Agreement ("ECA") in August 2012 with the Kluane First Nation ("KFN") in the Yukon to support the Company's exploration program and environmental studies associated with the development of the Nickel Shāw Project.

Flow-through Financings

Historically, the Company has entered into Flow-Through Share private placements ("FT Private Placement") to fund exploration activities. The most recent FT Private Placement was the \$700,000 thousand raise announced on April 26, 2021 (see "Financing Activities"). Under Canadian tax rules, the Company is obligated to spend these flow-through funds on Resource Expenditures by the end of the 2022 calendar year.

Subsequent to the closing of the 2020 FT Private Placement, the Government of Canada extended, by twelve (12) months for FT Private Placements completed during the 2019 and 2020 calendar years, the period to incur Resource Expenditures. Therefore, the Company also has until December 31, 2022 to spend the remaining outstanding balance of approximately \$571 thousand of the 2020 FT Private Placement on Resource Expenditures.

The Company has indemnified the subscribers of flow-through shares from any tax consequences arising should the Company, notwithstanding its plans, fail to meet its commitments under the flow-through subscription agreements.

The Company may be subject to interest on flow-through proceeds ("Part XII.6 tax") renounced under the look-back rules in respect of prior years, and penalties, in accordance with regulations in the Income Tax Act (Canada), if it is determined that flow-through proceeds were not properly or timely spent on prescribed Canadian exploration expenses. Any Part XII.6 tax is expensed as incurred, as an operating expense.

Environmental Regulations

The Company's exploration activities are subject to various provincial and federal laws and regulations governing the protection of the environment. These laws and regulations are continually changing and are generally becoming more restrictive. The Company conducts its operations so as to protect public health and the environment, and believes its operations are materially in compliance with all applicable laws and regulations. The Company has made, and expects to continue to make in the future, filings and expenditures to comply with such laws and regulations.

Contingencies

The Company accrues for liabilities when they are probable and the amount can be reasonably estimated.

The Company is reviewing a potential financial liability for the reclamation of land related to mining conducted near the Nickel Shāw Project in the 1970's, prior to the Company's acquisition of the property. The financial effect and timing of any reclamation work is indeterminable at this time. Once an assessment is completed and should a contractual agreement be entered into, a portion of the financial cost for reclamation may be incurred by the Company. As such, no provision has been recognized. For additional detailed information, see "Risk Factors - Environmental Risks" in the AIF.

The Company may be involved in legal proceedings from time to time, arising in the ordinary course of its business. Based on the Company's knowledge and assessment of events as at June 30, 2021, the Company does not believe that the outcome of any of the matters not recorded in the June 30, 2021 Financial Statements, individually or in aggregate, would have a material adverse effect.

Capital Risk Management

The Company considers its capital structure to consist of share capital, deferred Share units ("DSUs"), restricted share units ("RSUs"), stock options, stock appreciation rights ("SARs") and Warrants. The Company manages its capital structure and adjusts it, based on available funds, to support the acquisition and exploration of mineral properties and to ensure the entity continues as a going concern. The Company's Board of Directors (the "Board") does not establish quantitative returns on capital criteria for management.

The mineral properties in which the Company currently has an interest are in the exploration and evaluation stage; as such, the Company is dependent on external financing to fund its activities. Additional sources of funding, which may not be available on favourable terms, if at all, include: Share equity and debt financings; equity, debt or property level joint ventures; and sale of interests in existing assets. To execute future exploration, evaluation and development activities and to pay for ongoing operating costs, the Company will spend its existing working capital and raise additional amounts as needed.

Management reviews its capital management approach on an ongoing basis and believes that this approach, given the relative size of the Company, is reasonable. There were no changes in the Company's approach to capital management during the six months ended June 30, 2021. Neither Nickel Creek Platinum nor its subsidiaries are subject to externally imposed capital requirements. The Company's investment policy is to invest its surplus cash in highly liquid short-term interest-bearing investments with maturities of less than one year from the original date of acquisition, all held in major Canadian financial institutions.

The \$0.1 million and \$0.2 million reduction in salaries and wages for the three and six months ended June 30, 2021 is primarily due to reduced headcount. The \$0.1 million increase in non-cash share-based compensation expense for the three and six months ended June 30, 2021 is primarily due to timing of the annual stock option grant and the issuance of RSUs in December 2020.

6. FINANCIAL INSTRUMENTS AND RELATED RISKS

The Company's current financial instruments consist primarily of cash and cash equivalents, amounts receivable, and accounts payable and other current liabilities. The fair values of these financial instruments approximate their carrying values. The Company has not used any hedging or any other financial derivatives.

The Board, through the Audit Committee, is responsible for identifying the principal risks facing the Company and ensuring that risk management systems are implemented. The Company manages its exposure to financial risks, including liquidity risk, foreign exchange rate risk, interest rate risk, and credit risk in accordance with its risk management framework. Related Risks

Credit Risk

The Company does not currently generate any revenues from sales to customers nor does it hold derivative type instruments that would require a counterparty to fulfil a contractual obligation. The Company does not have any asset-backed commercial instruments. Financial instruments that potentially subject the Company to credit risks consist principally of cash and cash equivalents and amounts receivable. To minimize credit risk, the Company places cash and cash equivalents and GIC deposits with reputable financial institutions. The Company does not consider its exposure to credit risk to be significant.

Liquidity Risk

Liquidity risk is the risk that the Company cannot meet its financial obligations. The Company manages liquidity risk by maintaining sufficient cash and cash equivalent balances and/or through additional financings to ensure that there is sufficient capital to meet short-term obligations. At June 30, 2021, the Company had working capital of \$4.4 million. See "Financing Activities" in Section 2 above. The Company will continue to require additional sources of financing to fund its ongoing operations. If the Company is not able to obtain adequate additional funding to continue as a going concern, material adjustments would be required to both the carrying value and classification of assets and liabilities on the consolidated statement of financial position. It is not possible to predict, due to many external factors, including commodity prices and equity market conditions, whether future financing will be successful.

Foreign Exchange Risk

The Company has operations in Canada and undertakes transactions in Canadian and United States currencies. The Company has very limited exposure to foreign currency risk arising from transactions denominated in a foreign currency. The Company's reporting and functional currency is Canadian dollars. The Company holds a small amount of cash denominated in United States dollars ("USD"). A 10% strengthening (weakening) of the USD would have an insignificant impact on total assets and loss. The Company currently does not use any foreign exchange contracts to hedge this currency risk.

Interest Rate Risk

Interest rate risk is the risk that the fair value of future cash flows of a financial instrument will fluctuate due to changes in market interest rates. The Company has cash balances and no interest-bearing liabilities. The Company invests excess cash in investment grade short-term deposit certificates issued by its banking institutions. The Company monitors its cash balances and is satisfied with the creditworthiness of its banks. As a result, the Company's exposure to interest rate risk is minimal.

Market risk

Market risk is the risk that the fair value of, or future cash flows from, the Company's financial instruments will significantly fluctuate due to changes in market prices. The sale of financial instruments can be affected by changes in interest rates, foreign exchange rates, and equity prices. With the exception of the value of the Company's marketable securities which can vary from period to period, the Company currently has very limited exposure to market risk in trading its investments. However, in the future when the Company may have larger investments in the market, unfavourable market conditions could result in dispositions of investments at less than favourable prices. The Company's investments are accounted for at estimated fair values and are sensitive to changes in market prices, such that changes in market prices result in a proportionate change in the carrying value of the Company's investments. The Company's ability to raise capital to fund mineral resource exploration is subject to risks associated with fluctuations in commodity,
