Between September 29, 2025 and June 8, 2026, CPI sold an aggregate of 4,885,000 common shares (each, a "Common Share") in the capital of the Company through the facilities of the CSE (the "Dispositions").

Prior to the completion of the Dispositions, CPI beneficially owned and controlled an aggregate of 55,000,000 Common Shares representing approximately 21.07% of the issued and outstanding Common Shares as at September 26, 2025, on an undiluted basis and on a partially diluted basis. Upon closing the Dispositions, being June 8, 2026, and as of the date hereof, CPI beneficially owned and controlled an

aggregate of 5,093,212 Common Shares representing approximately 14.22% of the issued and outstanding Common Shares as at June 8, 2026, on an undiluted basis and on a partially diluted basis, as approximately 14.21% of the issued and outstanding Common Shares as at the date of this Report, on an undiluted basis and on a partially diluted basis.
