You can also write the name of someone else whom you wish to attend the meeting and vote on your behalf. Unless prohibited by law, the person whose name is written in the space provided will have full authority to present matters to the meeting and vote on all matters that are presented at the meeting, even if those matters are not set out in this form or the information circular. (b) any fractional Common Shares resulting from the Consolidation shall be converted to whole Common Shares pursuant to the provisions of Section 83 of the British Columbia Business Corporations Act;

(c) the Board is hereby authorized, at any time in its absolute discretion, to determine whether or not to proceed with the above resolutions without further approval, ratification or confirmation by the shareholders; and

(d) upon the date determined by the Board, these resolutions described herein shall be deposited at the Company's records office.
