On July 3, 2024, TML acquired all of the issued and outstanding Blackwolf Shares for consideration of 0.607 of a common share of TML for each Blackwolf Share pursuant to a plan of arrangement under the *Business Corporations Act* (British Columbia) (the "**Arrangement**").

Pursuant to the Arrangement, TML acquired 144,355,589 Blackwolf Shares, representing 100% of the issued and outstanding Blackwolf Shares. Prior to the Arrangement, TML did not own any Blackwolf Shares, and accordingly, TML's ownership increased from nil to

100% of the issued and outstanding Blackwolf Shares following completion of the Arrangement.

TML directly acquired the Blackwolf Shares pursuant to the Arrangement.

Pursuant to the terms of the Arrangement, each holder of Blackwolf Shares received 0.607 of a common share of TML per Blackwolf Share. An aggregate of 87,623,800 common shares of TML were issued pursuant to the Arrangement.
