Dream Industrial Real Estate Investment Trust ("Dream Industrial"), is a guarantor for the due and punctual payment of the public debt issued by its subsidiary DIR Industrial Properties Inc. ("DIR Industrial") of which Dream Industrial LP ("DILP"), is a co-obligor and the interest thereon and all other monies payable under the indentures governing the public debt. Accordingly, the following summary financial information is provided by DIR Industrial in compliance with the requirements of a decision of the Ontario Securities Commission, as principal regulator, from the requirements of National Instrument 51-102 - Continuous Disclosure Obligations.
