This supplement (the "**4th Supplementary Prospectus**") to the Prospectus dated 26 November 2020 (as supplemented, the "**Prospectus**"), which comprises a base prospectus for the purpose of Regulation (EU) 2017/1129, constitutes a supplementary prospectus for the purposes of Article 23 of the Regulation (EU) 2017/1129 as it forms part of domestic law in the United Kingdom by virtue of the European Union (Withdrawal) Act 2018 (the "**UK Prospectus Regulation**") and has been prepared in connection with the £40,000,000,000 Euro Medium Term Note Programme (the "**Programme**") established by, NatWest Group plc (the "**Issuer**" or "**NatWest Group**"). Terms defined in the Prospectus have the same meaning when used in this 4th Supplementary Prospectus. This 4th Supplementary Prospectus is supplemental to, and should be read in conjunction with, the Prospectus and the documents incorporated by reference therein.

This 4th Supplementary Prospectus has been approved by the United Kingdom Financial Conduct Authority (the "**FCA**"), as competent authority under the UK Prospectus Regulation. The FCA only approves this 4th Supplementary Prospectus as meeting the standards of completeness, comprehensibility and consistency imposed by the UK Prospectus Regulation. Such approval should not be considered as an endorsement of the Issuer that is the subject of this 4th Supplementary Prospectus. With effect from the date of this 4th Supplementary Prospectus the information appearing in, or incorporated by reference into, the Prospectus shall be supplemented in the manner described below.

The Issuer accepts responsibility for the information contained in this 4th Supplementary Prospectus. To the best of the knowledge of the Issuer such information is in accordance with the facts and makes no omission likely to affect its import.

Purpose of the Supplementary Prospectus

The purpose of this 4th Supplementary Prospectus is to:

- (a) incorporate by reference into the Prospectus:
 - (i) the Share Buyback Announcement (as defined below);
 - (ii) the NatWest Group Interim Results 2021 (as defined below); and
 - (iii) the Moody's Ratings Announcement (as defined below);

- (b) following publication of the NatWest Group Interim Results 2021, update the statements of no significant change and no material adverse change for NatWest Group; and
- (c) update certain information relating to legal proceedings, litigation and regulatory matters.

Incorporation of Information by Reference

By virtue of this 4th Supplementary Prospectus:

- (a) the announcement entitled "Commencement of Share Buyback Programme" (the "**Share Buyback Announcement**"), which was published via the regulatory news service of the London Stock Exchange plc on 2 August 2021
- (b) the unaudited Interim Results 2021 of NatWest Group (except for the row entitled "*Pro forma CET 1 ratio, pre dividend accrual*", in, and footnote 6 to, the table under the heading "*Business performance summary*" on page 4) (the "**NatWest Group Interim Results 2021**"), which were published via the regulatory news service of the London Stock Exchange plc on 30 July 2021; and
- (c) the announcement entitled "NatWest Group notes positive credit rating actions by Moody's" (the "**Moody's Ratings Announcement**"), which was published via the regulatory news service of the London Stock Exchange plc on 14 July 2021,

each of which has been (1) previously published and (2) filed with the Financial Conduct Authority, shall be incorporated in, and form part of, the Prospectus.

If a document which is incorporated by reference in the Prospectus by virtue of this 4th Supplementary Prospectus itself incorporates any information or other documents therein, either expressly or implicitly, such information or other documents will not form part of the Prospectus except where such information or other documents are specifically incorporated by reference in, or attached to, the Prospectus by virtue of this 4th Supplementary Prospectus.

It should be noted that, except as set forth above, no other portion of the above documents is incorporated by reference into the Prospectus. Those parts of the documents incorporated by reference which are not specifically incorporated by reference in this 4th Supplementary Prospectus are either not relevant for prospective investors or the information is included elsewhere in the Prospectus.

Statement of No Significant Change and No Material Adverse Change
