This MD&A should be read in conjunction with the audited consolidated annual financial statements and notes thereto for the years ended June 30, 2025, and 2024 (the "**Annual Financial Statements**"). The information contained in this MD&A is current as of October 27, 2025. All dollar amounts referred to in this MD&A are expressed in Canadian dollars, except where indicated otherwise.

The accompanying June 2025 Financial Statements have been prepared by management and are prepared in accordance with International Financial Reporting Standards ("**IFRS**"), and all amounts are expressed in Canadian dollars unless otherwise noted.

OVERVIEW

The Company was incorporated on August 26, 2010, under the *Business Corporation Act* (Ontario) under the name “Pacific Coal Corp.”. On April 12, 2011, the Company changed its name to “Canada Coal Inc.”. On March 26, 2021, the Company closed a three-cornered amalgamation with Ayurcann Inc. and 12487772 Canada Inc. (the “RTO”). In connection with completing the RTO, the Company delisted from the TSX Venture Exchange, listed on the Canadian Securities Exchange (“CSE”) and changed its name to “Ayurcann Holdings Corp.”.

The Company is a reporting issuer in the Provinces of Ontario, British Columbia and Alberta and is listed under the symbol “AYUR” on the CSE, and under the symbol “3ZQ0” on the Frankfurt Stock Exchange. The Company is delisting from the OTCQB effective October 30 2025 and will no longer be trading on that exchange

The Company’s head office and registered office is 1080 Brock Road, Pickering, Ontario L1W 3H3.

Ayurcann Holdings Corp, through its wholly owned subsidiary Ayurcann Inc, is a licensed producer under the Cannabis Act (Canada) focused on providing high quality cannabis products in verity of categories for the recreational and medical use in Canadian Market. Ayurcann Inc.’s head office and registered office is 1080 Brock Road, Pickering, Ontario L1W 3H3.

The Company operates a fully licensed 13,585 square foot state-of-the-art extraction and manufacturing facility based in Pickering, ON.

BUSINESS OVERVIEW

Description of the Business

The Company is a leading Canadian cannabis extraction company specializing in the processing and co-manufacturing of pharma grade cannabis to produce various derivative cannabis products in the medical and recreational markets. The Company focuses on the development of new product lines to enable exponential growth and exposure with a wide array of products in leading market categories.

The Company is focused on building a portfolio of leading brands in the Canadian market, including its flagship mainstream brand ‘Fuego’, value brand ‘XPLOR’ and mainstream brand ‘Happy and Stoned’ (“H&S”).

Under its house brands Fuego, XPLOR and H&S, the Company has over 80 unique stock keeping units available for sale across Canada, with over 60% coverage of the addressable market The Company has direct supply agreements in place with the British Columbia Liquor Distribution Branch, Alberta Gaming, Liquor and Cannabis Commission, Ontario Cannabis Stores, Cannabis NB, and Yukon Liquor Corporation and sells directly to Manitoba Liquor & Lotteries. The Company also has distribution agreements with distributors in Saskatchewan who distribute the Company’s products to provincial retailers

The Company presently does not pay and does not anticipate paying any dividends on its Common Shares, as all available funds will be used to develop the Company's business for the foreseeable future. At the end of June 30, 2025, compared to June 30, 2024, assets decreased by \$2,178,178. Most notable decreases occurred in inventories (- \$1,643,199), trade and other receivables (-\$1,273,374) and intangible assets (-\$550,000). These were partially offset by an increase in Cash (+\$1,596,409). The increase in Liabilities was due to higher trade and other payables (+\$1,959,573), partially offset by decreases in all other lines.

RESULTS OF OPERATIONS AND FINANCIAL CONDITION

For the year ended June 30, 2025, compared to prior year ended June 30, 2024

The Company reported a consolidated net loss and comprehensive loss of \$3,485,784 or \$0.02 loss per common share, for the year ended June 30, 2025, compared to the net loss and comprehensive loss of \$3,967,736 or \$0.02 loss per Common share for the year ended June 30, 2024.

Net revenues increased by 24% while cost of goods sold increased by 17% in fiscal 2025 year-over-year, as the Company focused on cost-efficient developing, manufacturing and promoting of its own brand vape and flower products. Gross margin increased by over 3.5% year-over-year, from 33.6% in fiscal 2024 to 37.2% in fiscal 2025. The inventory adjustment recorded during the year reflects cost-finalization of provisional SKU costs and does not represent a write-down for obsolete or impaired inventory.

During the year ended June 30, 2025, G&A expenses increased by 11% (or \$1,267,706) year-over-year, much below year-over-year growth in Net revenue of 24% (or \$5,952,116) and in Gross profit of 37% (or \$3,096,543). Most of the year-over-year increase in G&A expenses was related to higher Salaries and wages (\$1,087,990 or +40%, as the Company increased compensation of the existing employees to ensure retention and added new hires), and higher expenditure on Sales and marketing (\$887,835 or +20%, in line with growth in revenue).

During the year ended June 30, 2025, the Company amortized the intangible asset (brand) by \$550,000 based on its 5-year estimated life. Total accumulated amortization since inception was \$1,546,027 with two years remaining in original estimated life. The brand performance so far has been above management expectations, and the Company is considering extending the useful life of the intangible asset by another three years.

During fiscal 2025, the Company recorded inventory write-downs of \$364,649 (fiscal 2024 - \$461,103), representing legally mandated retention of product samples.

Finance costs decreased by \$54,084 to \$662,772 in fiscal 2025 (fiscal 2024 - \$716,856).

RELATED PARTY TRANSACTIONS

Key management personnel

Related parties include directors, officers, close family members, certain consultants and enterprises that are controlled by these individuals as well as certain persons performing similar functions.

In accordance with International Accounting Standards 24, key management personnel are those people who have authority and responsibility for planning, directing and controlling the activities of the Company directly or indirectly, including any directors (executive and non-executive) of the Company.

As disclosed in Notes 13 and 14 of the June 2025 Financial Statements, cash compensation (including in lieu of stock compensation) of key management personnel including President/COO, Chief Executive Officer, Chief Financial Officer and Directors of the Company for the years ended June 30, 2025, and 2024 was \$1,073,221 and \$959,250, respectively. Stock option/RSU share based compensation in fiscal 2025 was \$nil (fiscal 2024 - \$nil).

As at June 30, 2025, the Company fully repaid the promissory notes to the Company's CEO and President (June 30 2024 - \$200,000 payable to each). Interest incurred on promissory notes to the CEO and COO was \$84,855 for the year ended June 30, 2025 (year ended June 30 2024 - \$143,133).

Included in the accounts payable and accrued liabilities as at June 30, 2025 is \$197,500 (June 30, 2024 - \$197,000) due to directors for consulting fees.

CRITICAL ACCOUNTING ESTIMATES AND CHANGES IN ACCOUNTING POLICIES

All significant critical accounting estimates are fully disclosed in Note 3 of the Annual Financial Statements.

LIQUIDITY AND CAPITAL RESOURCES

As at June 30, 2025, the Company had working capital of -\$4,878,366 (-\$2,107,700 as at June 30, 2024). The decrease in working capital was due to both decrease in Current assets (-\$1,282,266 year-over-year) and increase in Current liabilities (+\$1,488,400 year-over-year).

Out of total year-over-year increase in Cash of \$1,596,409, operating activities contributed \$2,371,547, growing operations required an investment of \$92,531 in property and equipment additions, and financing activities consumed \$682,609.

There were no shares issued in fiscal 2025.

FINANCIAL INSTRUMENTS AND FINANCIAL RISK FACTORS

As outlined in Note 16 of the Annual Financial Statements the Company recognizes all financial instruments as follows:

IFRS require that the Company disclose information about the fair value of its financial assets and liabilities. Fair value estimates are made at the statement of financial position date, based on relevant market information and information about the financial instrument. These estimates are subjective in nature and involve uncertainties in significant matters of judgment and therefore cannot be determined with precision. Changes in assumptions could significantly affect these estimates.

Fair value measurements are classified using a fair value hierarchy that reflects the significance of the inputs used in making the measurements. As at June 30, 2025 and 2024, the Company has no financial instruments carried at fair value to classify in the fair value hierarchy.

As at June 30, 2025 and 2024, carrying amounts of cash and cash equivalents, amounts receivable, accounts payable and accrued liabilities on the statement of financial position approximate fair market value because of the limited term of these instruments.

The Company's risk exposures and the impact on the Company's financial instruments are summarized below. There have been no changes in the risks, objectives, policies and procedures from previous periods.

(a) Credit Risk

The Company's credit risk is primarily attributable to cash and cash equivalents. The Company has no significant concentration of credit risk arising from operations. Management believes that the credit risk concentration with respect to cash and cash equivalents, and financial instruments included in amounts receivable is remote.

The Company's cash is held through large Canadian financial institutions.

The Company's accounts receivable consists of Harmonized Goods and Services Tax due from the Federal Government of Canada and amounts receivable from customers. The Company's maximum exposure to credit risk as at June 30, 2025 is \$3,961,740 (\$5,235,114 as at June 30, 2024), representing trade and other receivables.

For amounts due from customers, the Company performs ongoing credit evaluations of its customers and monitors the receivable balance, and the payments made to determine if an allowance for estimated credit losses is required.

When determining the allowance for estimated credit losses the Company will consider historical experience with the customer, current market and industry conditions and any specific collection issues. As at June 30, 2025, the Company did not have any material overdue accounts.

(b) Liquidity Risk

Liquidity risk is the risk that the Company will not be able to meet its financial obligations as they become due. Accounts payable and accrued liabilities are due within the current operating period. The Company's accounts payable and accrued liabilities and convertible debt are due within the next operating period, except that convertible debt may be converted to Common Shares at the option of the holders prior to the maturity date. The Company manages its liquidity risk through its operating budgets and financing activities.

The Company attempts to have sufficient liquidity to meet its obligations when due. As at June 30, 2025, the Company's cash and cash equivalents portion of the total working capital was \$2,235,501 (\$639,093 as at June 30, 2024) available to settle current liabilities of \$15,092,810 (\$13,604,410 as at June 30, 2024). The Company's accounts payable are subject to normal trade terms.

(c) Market Risk

The Company is exposed to the following market risks:

(i) Interest Rate Risk

Interest rate risk is the risk that the fair value of future cash flows of a financial instrument will fluctuate because of changes in market interest rates. The Company is exposed to interest rate risk from its secured loans and convertible debentures. The Company's interest rates on these loans are fixed and the sensitivity of the Company's loss before tax to a reasonably possible change in market interest rates is considered minimal.

(ii) Foreign Exchange Risk

While the Company's functional currency is the Canadian dollar, major purchases could be transacted in Canadian dollars or United States dollars. As at June 30, 2025, the Company does not hold foreign currency balances.

(iii) Price Risk

The Company is exposed to price risk with respect to cannabis prices. The Company closely monitors cannabis prices to determine the appropriate course of action to be taken by the Company.

(d) Sensitivity Analysis

The Company may hold balances in United States dollars that give rise to foreign exchange risk. Based on the management's knowledge and experience of the financial markets, the Company does not believe there will be any material movements because of changes in interest rates.

OFF-BALANCE SHEET ARRANGEMENTS

The Company is not aware of any off-balance sheet arrangements.

COMMITMENTS AND CONTINGENCIES

Other than as described in the Annual Financial Statements, the Company has no additional commitment disclosure.

ACCOUNTING POLICIES, CRITICAL JUDGEMENTS AND ACCOUNTING ESTIMATES

The preparation of the Company's June 2025 Financial Statements in conformity with IFRS, requires management to make judgments, estimates and assumptions that affect the reported amounts of assets, liabilities, revenues and other items in net earnings or loss, and the related disclosure of contingent assets and liabilities, if any. Critical judgments and estimates represent estimates made by management that are, by their very nature, uncertain. The Company evaluates its estimates on an ongoing basis. Such estimates are based on historical experience and on various other assumptions that the Company believes are reasonable under the circumstances, and these estimates form the basis for making judgments about the carrying values of assets and liabilities and the reported amounts of revenues and other items in net earnings or loss that are not readily apparent from other sources. Actual results may differ from these estimates under different assumptions or conditions. Summaries of the significant accounting policies applied, and significant judgments, estimates and assumptions made by management in the preparation of its financial statements are provided in Notes 2 and 3 to the 2025 Audited Financial Statements.

Notwithstanding the filing of a Venture Issuer Basic Certificate, the Company makes significant efforts to maintain disclosure controls and procedures designed to ensure that information required to be disclosed in the reports filed or

submitted is accumulated and communicated to management, including the Chief Executive Officer and Chief Financial Officer of the Company, as appropriate, to allow timely decisions regarding required disclosure.
