 - (b) 4,760,000 Units were distributed at \$0.05 per Unit, for gross proceeds of \$238,000 and 700,000 Flow Through Units were distributed at \$0.05 for gross procedures of \$35,000. The Units are comprised of one common share and one common share purchase warrant, with each warrant entitling its holder to acquire one additional common share of Braveheart at a price of \$0.10 for 18 months (November 16, 2017). The Flow-Through Units are comprised of one common share and one-half warrant where each warrant entitles the holder to acquire one additional common share at \$0.10 for 18 months (November 16, 2017).
