We make reference to the Synthetic Diesel Purchase and Sale Agreement (the "**Agreement**") dated effective as of the 19th day of July, 2016 between Elbow River Marketing Ltd. ("**ERML**") and Cielo Waste Solutions Corp. ("**Cielo**").
