Tartisan is a company incorporated under the laws of Ontario. Tartisan is a Canadian exploration and development company focused on mineral exploration and development of precious and base metals properties in Canada and Peru.

2.2 State the date of the transaction or other occurrence that triggered the requirement to file this report and briefly describe the transaction or other occurrence.

On March 15, 2018, Tartisan bought 10,000 Common Shares, 5,000 at \$0.846 per Common Share and 5,000 at \$0.90 per Common Share and on March 16, 2018 Tartisan bought 15,000 Common Shares 5,000 at \$0.885 per Common Share and 10,000 at \$0.90 per Common Share representing approximately 0.000733% of the issued and outstanding Common Shares, for an aggregate purchase price of C\$22,155. (the “**Transaction**”).

Tartisan owned by direct ownership 6,000,000 common shares ("Common Shares") of the Eloro and 3,000,000 warrants ("Warrants") to purchase one additional Common Share per Warrant exercisable at a price of \$0.40 prior to expiry on October 17, 2019. The acquisition of Common Shares represents an increase in Tartisan's holdings from 17.59% to 17.66% of the issued and outstanding Common Shares.

Tartisan acquiring ownership of an aggregate of 25,000 Common Shares increased its holdings which had previously required the filing of this report.

Prior to the Transaction, Tartisan held 6,000,000 Common Shares, representing approximately 17.59% of the Common Shares. As a result of the Transaction, Tartisan now owns 6,025,000 Common Shares, representing approximately 17.66% of the issued and outstanding Common Shares.
