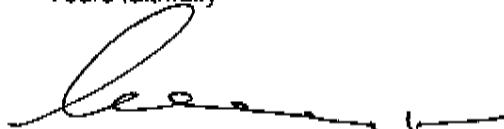

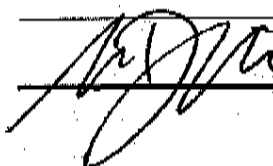

DIRECTIONS

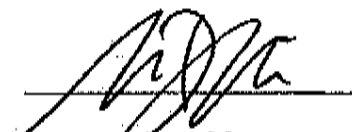
