- 2. The Court has appointed Mark Williamson, or failing him, any other director of Spectris (each with a business address of 6th Floor, The Block, Space House, 12 Keeley Street, London WC2B 4BA) to act as Chair of the Court Meeting and has directed the Chair to report the result thereof to the Court.
- 3. Every Scheme Shareholder has the right to appoint some other person(s) of their choice, who need not be a shareholder, as his or her proxy to exercise all or any of his or her rights to attend, submit questions and to vote on their behalf at the Court Meeting.
