On February 28, 2025, the Issuer announced the completion of a financing comprised of:

- (a) a bought deal public offering of 5,335,300 “flow-through” Common Shares at a price of \$3.75 per share; and
 - (b) a non-brokered private placement of 2,500,000 Common Shares to NexGen, at a price of \$2.50 per share,
- (collectively, the “**Financing**”).

NexGen acquired 2,500,000 Common Shares in connection with the Financing. Immediately following the Financing, NexGen beneficially owned, and exercised control and direction over, 61,114,985 Common Shares, representing approximately 31.8% of the outstanding Common Shares (calculated on an undiluted basis). There has been a decrease of approximately 18.39% relative to the number of Common Shares that NexGen reported as holding in its previous early warning report dated December 6, 2022, as a result of issuances of Common Shares by the Issuer.
