Change of Auditors

You will be aware that at the Annual General Meeting ("AGM") of Pennon Group Plc held on 31 July 2014 Ernst & Young LLP were appointed as statutory auditors of the Company until the next AGM. This was a new appointment following a competitive tender process carried out by Pennon Group in accordance with good corporate governance.

PricewaterhouseCoopers LLP ("PwC"), the Company's previous statutory auditors, ceased to hold office on 31 July 2014 and, as required by Section 519(3) of the Companies Act 2006, PwC have now deposited a statement with the Company of the circumstances connected with them ceasing to hold office as auditors of the Company.

In accordance with the requirements of Section 520(2) of the Act, a copy of the statement received from PwC is set out overleaf for your information. It confirms that Pennon Group Plc in accordance with good governance has undertaken a formal audit tender process for the position of statutory auditor and that PwC were not invited to tender. In addition, PwC confirm that there are no further circumstances which they consider should be brought to the notice of the Company's shareholders or creditors.

The Board wishes to thank PricewaterhouseCoopers LLP for the services they have provided as statutory auditor to the Pennon Group of companies during their period of appointment.
