Notice under Section 708A(5)(e) of the Corporations Act 2001 (Cth)

RTG Mining Inc. (TSX: RTG, ASX: RTG) ("**RTG**" or the "**Company**") advises that it has issued 81,037,020 new CHESS Depositary Interests ("**CDIs**") (representing 81,037,020 fully paid ordinary shares in the share capital of the Company) at an issue price of A\$0.048 per CDI ("**Placement CDIs**") pursuant to the private placement to institutional and sophisticated investors announced on 4 July 2023. The Placement CDIs rank equally with other CDIs on issue.

RTG gives notice under section 708A(5)(e) of the *Corporations Act 2001* (Cth) ("**Corporations Act**") as modified by ASIC Class Order 14/827 that:

- the Placement CDIs were issued without disclosure to investors under Part 6D.2 of the Corporations Act;
- as at the date of this notice, RTG has complied with section 601CK and sections 674 and 674A of the Corporations Act; and
- as at the date of this notice, there is no "excluded information" within the meaning of sections 708A(7) and 708A(8) of the Corporations Act that is required to be set out in this notice under section 708A(6)(e) of the Corporations Act.
