



DIRTT to Release 2017 Year-End Results March 21, 2018 & Provides Update on Strategic Growth Initiative

CALGARY, Alberta, March 05, 2018 -- DIRTT Environmental Solutions Ltd. ("DIRTT" or the "Company") (TSX:DRT), an interior construction company using technology for client-driven design and manufacturing, will release its fiscal 2017 fourth quarter and year-end financial results on Wednesday, March 21, 2018 after markets close. The Company also provides an update on its strategic growth initiative, as announced January 17, 2018.

Strategic Growth Initiative
