- To appoint as a proxy a person other than the Chairman of the meeting, cross out the words 'the Chairman of the meeting' and write the full name in the space provided. If you wish your proxy to make comments on your behalf you will need to appoint someone other than the Chairman and give them relevant instructions directly. A proxy need not be a member of the Company.
- You may appoint one or more proxies of your choice to attend, vote and speak at the meeting and any adjournment thereof, provided each proxy is appointed to exercise rights in respect of different-shares. To appoint more than one proxy (an) additional proxy form(s) may be obtained by contacting the Registrars or you may photocopy this page indicating on each copy the name of the proxy you wish to appoint and the number of shares in respect of which the proxy is appointed. All forms must be signed and should be returned to Equiniti in the same envelope.
- Unless otherwise instructed the proxy will vote as they think fit or, at their discretion, abstain from voting.
- The form of proxy must arrive no later than 11.00am on 16 July 2012 at Equiniti, Aspect House, Spencer Road, Lancing, West Sussex BN99 6DA. You may also deliver by hand to the same address during usual business hours.
- A corporation must execute the form of proxy under either its common seal or by a duly authorised officer or attorney.
- To be valid your proxy must be lodged no later than 11.00am on 16 July 2012. Do not show these details to anyone unless you wish them to give proxy instructions on your behalf. CREST users should note that they can lodge their proxy votes for the meeting through the CREST electronic appointment service, using CREST ID RA19. For further instructions users should refer to the CREST User Manual (available at [www.euroclear.com/CREST](http://www.euroclear.com/CREST)). Any CREST sponsored members should contact their CREST sponsor.
- Completion and return of the Form of Proxy will not preclude a member from attending and voting in person at the Annual General Meeting should he or she so wish.
- A 'vote withheld' option is provided to enable a shareholder to withhold their vote on any particular resolution. It should be noted that a vote withheld is not a vote in law and will not be counted in the calculation of the proportion of votes 'for' or 'against' a resolution.
- The form of proxy is only for use in respect of the shareholder account specified and should not be amended or submitted in respect of a different account.
- Corporate Representatives must make themselves known to the Registrar prior to the meeting.
- The right to appoint a proxy does not apply to persons whose shares are held on their behalf by another person and who have been nominated to receive communication from the Company in accordance with section 146 of the Companies Act 2006 ('Nominated Persons'). Nominated Persons may have a right under an agreement with the registered shareholder who holds shares on their behalf to be appointed (or to have someone else appointed) as a proxy. Alternatively, if Nominated Persons do not have such a right, or do not wish to exercise it, they may have a right under such an agreement to give instructions to the person holding the shares as to the exercise of voting rights.
- Entitlement to attend and vote at the meeting and the number of votes which may be cast thereat will be determined by reference to the Register of Members of the Company at 6.00pm on 16 July 2012.
