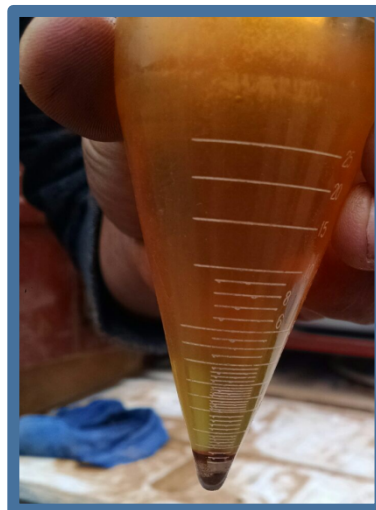
### **Lightning Industries Commences Tank Cleaning at Blue Marble Resources**

VANCOUVER, CANADA, November 14, 2017 – Lightning Ventures Inc. (CSE: LVI) (Frankfurt: 1HM) (the “Company”) is pleased to announce that its wholly-owned subsidiary, Lightning Industries, has commenced tank cleaning for Blue Marble Resources. The initial tank contained condensate from gas wells and had BS&W (“Bottom Solids and Water”) rated at 8 percent, which was well above the allowable for sales and transport.

After treatment, using the Lightning Hot Oil Trailer and Lightning’s de-mulsification chemical the tank rated at less than .5% BS&W.

Don Rainwater, CEO, commented: “Paraffin accumulation in storage tanks occurs as the liquid temperature lowers and the paraffin congeals into a solid while solids and water gravitate to the tank bottom. Lightning’s Hot Oil Trailer 3 phase process of circulation, heating, and chemical treatment effectively (1) emulsifies the bottom, (2) return the paraffin into solution, and (3) eliminate the oil-water mixture or “rag-layer” that tends to form between the bottom water and the hydrocarbons. Results such as obtained with Blue Marble provides evidence that Lightning’s combination treatment of heated liquids and specialized chemicals can convert a heavily sedimented tank into a saleable asset.”
