## **Introduction**

The following Management Discussion and Analysis ("MD&A") of Forge Resources Corp. (the "Company") has been prepared by management, in accordance with the requirements of National Instrument 51-102 ("NI 51-102") as of December 23, 2025 and should be read in conjunction with the audited consolidated financial statements for the year ended August 31, 2025, and the related notes contained therein which have been prepared under International Financial Reporting Standards ("IFRS Accounting Standards") as issued by the International Accounting Standards Board ("IASB"). The information contained herein is not a substitute for detailed investigation or analysis on any particular issue. The information provided in this document is not intended to be a comprehensive review of all matters and developments concerning the Company. The Company is presently a "Venture Issuer" as defined in NI 51-102. Additional information relevant to the Company's activities can be found on SEDAR+ at [www.sedarplus.ca](http://www.sedarplus.ca).

All financial information in this MD&A has been prepared in accordance with IFRS Accounting Standards and all dollar amounts are quoted in Canadian dollars, the reporting and functional currency of the Company, unless specifically noted.

## **Overview**

Forge Resources Corp. (the "Company") was incorporated on August 21, 2014 under the Business Corporations Act of British Columbia. The head office of the Company is 1050 - 12471 Horseshoe Way, Richmond, BC, V7A 4X6. The registered and records office is Suite 700, 401 W Georgia St, Vancouver, BC V6B 5A1. The common shares of the Company are listed on the Canadian Securities Exchange ("CSE") under the symbol "FRG", on the OTCQB under the symbol "FRGGF" and on the Frankfurt Stock Exchange ("FSE") under the symbol "5YZ".

The Company is in the business of the exploration and development of natural resource properties in Canada and Colombia.

During the year ended August 31, 2025, the Company earned a 80% interest in Aion Mining Corp. ("Aion"), a company that is developing the La Estrella coal project in Santander, Colombia.

#### **Exploration Activities**

##### **Aion Mining Corp.**

In December 2023, the Company signed a definitive agreement with Aion Mining Corp. ("Aion") to complete the Company's acquisition of a 20% interest in Aion. Pursuant to the agreement, the Company acquired common shares of Aion representing a 20% interest, calculated on a fully diluted basis. In consideration, the Company provided Aion aggregate amount of \$1,133,013: \$500,000 in cash on closing (paid); and 1,602,565 common shares (issued) of the Company at a deemed price of \$0.39 per share, subject to CSE policies. The Company was also issued a special warrant of Aion, exercisable into additional common shares of Aion, at no additional consideration to the Company, to allow the Company to maintain its 20% interest in Aion for a period of 6 months. Aion is a non-arm's length party to the Company by reason of sharing a common director, Cole McClay.

In April 2024, the Company acquired a further interest in Aion to bring the Company's total interest to 40%. Pursuant to the formal agreement, the Company acquired common shares of Aion in order to bring the total ownership of the Company to 40% of the post-issuance common shares of Aion, calculated on a fully-diluted basis. In consideration, the Company provided Aion aggregate amount of \$1,829,742: \$1,000,000 in cash on closing (paid); and 1,508,621 common shares (issued) of the Company at a deemed price of \$0.58 per share, subject to CSE policies. The Company was also granted a right of first refusal for two-years, allowing it to purchase common shares in Aion to offset any further issuances by Aion of securities, to allow the Company the opportunity to maintain its 40% interest.

In February 2025, the Company acquired a further interest in Aion to bring the Company's total interest to 60%. Pursuant to the formal agreement, the Company acquired common shares of Aion to bring the total ownership of the company to 60% of the post-issuance common shares of Aion, calculated on a fully diluted basis. In consideration, the company paid an aggregate amount of \$6,166,999 to Aion consisting of \$3,006,079 in cash on closing (paid); and 2,873,564 common shares of the Company at a deemed price of \$0.87 per share (issued). The Company was also granted a right of first refusal for four years, allowing it to purchase common shares in Aion to offset any further issuances by Aion of securities to allow the company to maintain its 60% interest.

In May 2025, the Company acquired a further interest in Aion to bring the Company's total interest to 80%. Pursuant to the formal agreement, the Company acquired common shares of Aion to bring the total ownership of the company to 80% of the post-issuance common shares of Aion, calculated on a fully diluted basis. In consideration, the Company paid an aggregate amount of \$2,276,684 to Aion consisting of \$713,966 in cash on closing (paid via the issuance of an unsecured interest-bearing promissory note to each shareholder bearing interest at a rate of 6.5% calculated annually, and will mature on the earlier of the following: the two-year anniversary of the promissory note; or the completion date of one or more hard-dollar financings by the Company for aggregate gross proceeds of at least \$3,000,000); and 2,232,453 common shares of the Company at a deemed price of \$0.71 per share (issued).

##### *Anti-dilution agreement*

The agreement protects the company's ownership in Aion from dilution due to any issuance of shares by Aion. Additionally, it grants the Company an option to acquire some or all of the remaining shares from Aion's other shareholders. To exercise this option, the Company must formally notify Aion and the shareholders, specifying the number of shares it intends to purchase.

In October 2024, the Company completed its portal design, and additional environmental advancements at the fully permitted La Estrella Coal Project in Santander, Colombia.

In November 2024, the Company commenced the construction on the mine portal at Aion Mining Corp's La Estrella project located in Santander, Colombia.

In November 2024, the Company announced a significant milestone in the development of its mining operations, highlighted by the successful groundbreaking of the decline portal at Aion Mining Corp's La Estrella coal project in Colombia.

In November 2024, the Company announced the overview of the design plans for the construction of a mine portal at the La Estrella Coal Project, located in Santander, Colombia. The new mine portal will be a critical development milestone for the project, providing essential infrastructure to support the future decline ramp and soil stability necessary for advancing underground bulk sampling exploration.

In April 2025, the Company proposed a diamond drill program comprising up to 4,000 metres across approximately 12 drill holes ranging from 300 metres to 350 metres in its Alotta Project, Yukon, Canada. This initiative aims to test stepouts on previously identified mineralization in the Payoff zone and explore untested coincident geophysical and geochemical anomalies across targeted areas.

In July 2025, the Company announced it encountered coal seam during decline development at La Estrella.

In September 2025, the Company advanced its La Estrella coal project with new camps, a mechanical station, and the hiring of a third-shift mining engineer, flow-through financing and marketing of shares.

In September 2025, the Company announced the arrival of key heavy equipment to support automated, mechanized operations and major advancements in camp construction for its expanding underground mining work force.

#### About Aion Mining Corp.

Aion Mining controls the FLG-111 concession that covers 548 Ha in a region of historic and current coal mining. Historical exploration within this concession area has determined the property to host several coking and thermal coal seams. Aion holds a recent NI 43-101 dated March 17, 2024 and Annual CRIRSCO technical reports. The project is road accessible, water, electricity, and phone signal on site. Current coal stockyards approximately 40 kilometres away on main highway to Atlantic ports for export.

Qualified Person and Quality Control/Quality Assurance Lorne Warner P.Geo, President, a qualified person as defined by National Instrument 43-101 – Standards of Disclosure for Mineral Projects ("NI 43-101"), has supervised the preparation of the scientific and technical information that forms the basis in this MD&A and has reviewed and approved the disclosure herein.

#### **Alotta Project, Yukon, Canada**

In January 2023, the Company announced that Strategic Metals Ltd. (TSXV: SMD) (the "Optionor") has signed an agreement (the "Agreement") granting the Company an optional right (the "Option") to earn an undivided 60% joint venture interest in the Alotta Project located in the Whitehorse Mining District, Yukon Territory.

The Alotta Project hosts an un-drilled porphyry prospect that is situated in a similar geological setting and in close proximity to Western Copper and Gold's Casino Deposit. Alotta is marked by a pronounced magnetic low that coincides with a strong, multi-element soil geochemical anomaly. The core of the geochemical anomaly is enriched in copper, gold and molybdenum and measures 4 kilometres by 1 kilometre. It is surrounded by a distal halo with high lead, zinc and silver values. The Alotta soil

geochemical signature exhibits classic features common associated by large porphyry deposits.

In September 2024, the Company announced the commissioning of a detailed structural analysis study based on the diamond drilling completed to date. The purpose of the study is to identify structural relationships and preferred structural orientations to higher grade gold mineralization. The completion of this study will help determine the proper drill orientations for testing both disseminated and fracture controlled gold mineralization at Alotta. The study was completed in November and has indicated several areas that require additional diamond drilling. The highest priority target occurs in the area of our 2023 drilling with an induced polarization, chargeability anomaly over 2.0 kilometres in length.

In June 2025, the Company announced the completion of phase 1 of its 2025 drill campaign at the Alotta Project.

In September 2025, the Company announced final assay results from the remaining two drill holes of the Phase 1 diamond drilling program at the Alotta property and filing of the NI 43-101.

In September 2025, the Company announced the phase 2 diamond drill program at the Alotta Project.

In October 2025, the Company announced updated assay results from initial metallic gold screen analysis for holes ALT-25-008 and ALT-25-009 from the Payoff Zone, and the successful completion of phase 2 diamond drilling at its Alotta Project.

In November 2025, the Company released the first gold assay results from the phase 2 diamond drill program at Alotta, intercepting 105 grams per tonne (g/t) gold (Au) over a core length of 1.25 metres (m).

In November 2025, the Company announced additional gold assay results from the Phase 2 diamond drill program at its Alotta Project, intercepting 45.01 g/tonne gold over a core length of 3.15 metres.

In December 2025, the Company announced full gold assay results from drill hole ALT-25-012 at the Payoff Zone intersecting 3.4 g/t gold over 44.75 metres from 256.23 metres and discovery results from hole ALT-25-013 at the Alimony Zone grading at 1.04 g/t gold over 55.52 metres from 91.99 metres, at its Alotta Project.

During the year ended August 31, 2024, the Company recorded marketing of \$929,855, stock-based compensation of \$1,338,995 and share of loss from associate of \$135,002.

During the year ended August 31, 2023, the Company wrote-down exploration and evaluation assets of \$3,834,558 and a loss from discontinued operations of \$3,762,584 on the termination of the Sonora Gold Property option agreements.

### **Results of Operations**

#### **Revenues**

Due to the Company's status as an exploration and development stage mineral resource company and a lack of commercial production from its properties, the Company currently does not have any revenues from its operations.

#### **General and administrative expenses**

##### ***For the year ended August 31, 2025 and August 31, 2024***

The Company had a net loss of \$6,303,874 for the year ended August 31, 2025, compared to \$3,125,241 for the year ended August 31, 2024.

Expense details are as follows:

- a) Consulting of \$749,493 (2024 - \$348,824) – the variance is due to an increase of consultants in the current year.
- b) Marketing expenses of \$594,060 (2024 - \$929,855) – the decrease is due to fewer marketing consultants and campaigns in the current year.
- c) Stock-based compensation of \$4,327,032 (2024 - \$1,338,995). During the year ended August 31, 2025, the Company issued 7,075,000 stock options in the current year (2024 – 4,790,000) valued using the Black Scholes Pricing Model.

##### ***For the three months ended August 31, 2025 and August 31, 2024***

The Company had a net loss of \$1,268,400 for the three months ended August 31, 2025, compared to a net loss of \$331,813 for the three months ended August 31, 2024.

Expense details are as follows:

- a) Consulting of \$202,375 (2024 - \$148,274) – the variance is due to an increase of consulting fees in the current period.
- b) Marketing expenses of \$106,419 (2024 - \$127,900) – the decrease is due to fewer marketing consultants and campaigns in the current period.
- c) Stock-based compensation of \$787,217 (2024 - \$268,719). During the period ended August 31, 2025, the Company issued 1,400,000 stock options (2024 – 390,000) valued using the Black Scholes Pricing Model.

#### **Liquidity and Capital Resources**

The Company will continue to require funds for exploration work on its properties, as well as to meet its ongoing day-to-day operating expenses and will continue to rely on equity financing during such year. There can be no assurance that financing will be available to the on terms satisfactory to the Company.

The Company does not have any other commitments for material capital expenditures over the near and long term other than as disclosed above plus normal operating expenses.

Since incorporation, the Company's capital resources have been limited. The Company relied upon the issue of equity securities to acquire interest in mineral properties acquisition payments and to pay operating expenses.

During the year ended August 31, 2025, the Company:

- Issued 1,595,000 common shares from the exercise of warrants for proceeds of \$659,800.
- Issued 725,000 common shares from the exercise of stock options for proceeds of \$219,250.
- Closed a non-brokered private placement comprising of 6,591,995 at \$0.55 per unit for proceeds of \$3,625,597.
- Closed a non-brokered private placement comprising of 1,940,152 flow-through units at \$0.66 per FT Unit for proceeds of \$1,280,500.

Subsequent to August 31, 2025, the Company:

- Closed the first tranche of a non-brokered private placement comprising of 1,409,093 flow-through units at a price of \$0.55 per FT Unit for aggregate gross proceeds of \$775,001.
- Closed the second tranche of a non-brokered private placement comprising of 909,092 flow-through units at a price of \$0.55 per FT Unit for aggregate gross proceeds of \$500,001.
- Issued 800,000 common shares from the exercise of stock options for proceeds of \$208,000.

Subsequent to August 31, 2025, Aion sold 1,955,000 of its shares of the Company for total proceeds of \$884,238.

The Company has a working capital deficiency of \$2,132,233 as at August 31, 2025.

During the year ended August 31, 2025, the Company incurred professional fees of \$60,000 (2024 - \$60,000) to a firm where an officer of the Company is a partner. As at August 31, 2025, \$31,500 (2024 - \$5,250) was owing to this firm.

During the year ended August 31, 2025, the Company incurred exploration and evaluation expenses of \$72,000 (2024 - \$72,000) from a company controlled by the president of the Company. As at August 31, 2025, \$67,700 (2024 - \$28,400) was owing to this company.

During the year ended August 31, 2025, the Company incurred consulting fees of \$79,243 (2024 - \$nil) to the VP Finance of the Company. As at August 31, 2025, \$143,242 (2024 - \$nil) was owing to the VP Finance of the Company.

During the year ended August 31, 2025, the Company incurred consulting fees of \$135,000 (2024 - \$nil) to the CEO and Director of the Company. As at August 31, 2025, \$63,711 (August 31, 2024 - \$nil) was owing to the CEO and Director of the Company.

During the year ended August 31, 2025, the Company incurred consulting fees of \$84,094 (2024 - \$nil) to the CEO and Director of Aion. As at August 31, 2025, \$238,950 (August 31, 2024 - \$nil) was owing to the CEO and Director of Aion.

As at August 31, 2025, \$226,517 (August 31, 2024 - \$nil) was owing to the County Manager of Aion.

During the year ended August 31, 2025, the Company granted stock options to key management members valued at \$2,394,071 (2024 - \$589,229).

part of the value of the common shares held by them.

An investment in securities of the Company should only be made by persons who can afford a significant or total loss of their investment. There is currently no market through which these securities may be sold and purchasers may not be able to resell securities purchased.

#### *No Ongoing Operations and No Production History*

The Company is a mineral exploration company and has no operations or revenue.

#### *Limited Operating History*

The Company has no history of earnings. There are no known commercial quantities of mineral reserves on the Company's Property. There is no assurance that the Company will ever discover any economic quantities of mineral reserves.

#### *Negative Operating Cash Flow*

Since inception, the Company has had negative operating cash flow. The Company has incurred losses since its founding. The losses and negative operating cash flow are expected to continue for the foreseeable future as funds are expended on the exploration program on the Property and administrative costs. The Company cannot predict when it will reach positive operating cash flow.

#### *Requirement for Further Financing*

The Company has limited financial resources and may need to raise additional funds to carry out exploration of its Property. There is no assurance the Company will be able to raise additional funds or will be able to raise additional funds on terms acceptable to the Company. If the Company's exploration programs are successful and favourable exploration results are obtained, the Property may be developed into commercial production. The Company may require additional funds to place the Property into production. The only sources of future funds presently available to the Company are the sale of equity capital, debt, or offering of interests in its Property to be earned by another party or parties by carrying out development work. There is no assurance that any such funds will be available to the Company or be available on terms acceptable to the Company. If funds are available, there is no assurance that such funds will be sufficient to bring the Company's Property to commercial production. Failure to obtain additional financing on a timely basis could have a material adverse effect on the Company, and could cause the Company to forfeit its interest in its Property and reduce or terminate its operations. There is no assurance the Company will be able to raise additional funds.

#### *Exploration*

At present, there are no bodies of ore, known or inferred, on the Property and there are no known bodies of commercially recoverable ore on the Property. There is no assurance that the Company's mineral exploration activities will result in any discoveries of commercial bodies of ore on the Property.

#### *Development*

The business of exploration for precious metals involves a high degree of risk. Few exploration properties are ultimately developed into producing properties. The Company's Property is at the exploration stage.

#### *Title to Properties*

Acquisition of title to mineral properties is a very detailed and time-consuming process. Title to, and the area of, mineral properties may be disputed. Although the Company has investigated its title to the Property for which it holds an option to acquire concessions or other mineral leases or licenses and the Company is

satisfied with its review of the title to the Property, the Company cannot give an assurance that title to the Property will not be challenged or impugned. Mineral properties sometimes contain claims or transfer histories that examiners cannot verify, and transfers under foreign law often are complex. The Company does not carry title insurance on the Property. A successful claim that the Company does not have title could cause the Company to lose its rights to the Property, perhaps without compensation for its prior expenditures relating to the Property.

The Company's interest in the Property is by way of an option agreement only: (i) the Company does not own the Property, rather the Company has the right to acquire an interest in the Property by issuing common shares, incurring the expenditures and meeting the certain obligations; (ii) the exploration expenditures under the Option Agreement are optional to the Company, such that if the Company determines the Property to be without sufficient merit at any time prior to exercising its option it is not obligated to incur any further expenditures; (iii) if the Company fails to incur expenditures in accordance with the Option Agreement, it will lose all of its interest in the Property; (iv) the Company is dependent on the optionor to perform its obligations under the Option Agreement and if the optionor fails to perform its obligations thereunder the Company's interest in the Property may be lost. There is no guarantee the Company will be able to raise sufficient funding in the future to incur all expenditures under the Option Agreement.

#### *Surface Rights*

The Company does not own the surface rights to the Property. The Company understands that it is necessary, as a practical matter, to negotiate surface access, and the Company is continuing to do so. However, there is a risk that local communities or affected groups may take actions to delay, impede or otherwise terminate the contemplated activities of the Company. There can be no guarantee that the Company will be able to negotiate a satisfactory agreement with any such existing landowners/occupiers for such access, and therefore it may be unable to carry out significant exploration and development activities. In addition, in circumstances where such access is denied, or no agreement can be reached, the Company may need to rely on the assistance of local officials or the courts in such jurisdiction, which assistance may not be provided or, if provided, may not be effective. If the development of a mine on the Property becomes justifiable it will be necessary to acquire surface rights for mining, plant, tailings and mine waste disposal. There can be no assurance that the Company will be successful in acquiring any such rights.

#### *Management*

The success of the Company is largely dependent upon the performance of its management. The loss of the services of these persons may have a material adverse effect on the Company's business and prospects. There is no assurance that the Company can maintain the service of its management or other qualified personnel required to operate its business.

#### *Requirement for Permits and Licenses*

The Company will be applying for all necessary licenses and permits under applicable laws and regulations to carry on the exploration activities which it is currently planning in respect of the Property, and the Company believes it will comply in all material respects with the terms of such licenses and permits. However, such licenses and permits are subject to changes in regulations and in various operational circumstances. A substantial number of additional permits and licenses will be required should the Company proceed beyond exploration. There can be no guarantee that the Company will be able to obtain such licenses and permits.

#### *Environmental Risks and other Regulatory Requirements*

The current or future operations of the Company, including the exploration activities and commencement

of production on the Property, will require permits from various federal and local governmental authorities, and such operations are and will be governed by laws and regulations governing exploration, development, production, taxes, labour standards, occupational health, waste disposal, toxic substances, land use, environmental protection, site safety and other matters. There can be no assurance that all permits which the Company may require for its facilities and conduct of exploration and development operations will be obtainable on reasonable terms or that such laws and regulations would not have a material adverse effect on any exploration and development project which the Company might undertake. Failure to comply with applicable laws, regulations and permitting requirements may result in enforcement actions including orders issued by regulatory or judicial authorities causing operations to cease or be curtailed and may include corrective measures requiring capital expenditures, installation of additional equipment or remedial actions. Parties engaged in exploration and development operations may be required to compensate those suffering loss or damage by reason of the exploration and development activities and may have civil or criminal fines or penalties imposed upon them for violation of applicable laws or regulations.

Amendments to current laws, regulations and permits governing the operations and activities of mineral companies, or more stringent enforcement thereof, could have a material adverse impact on the Company and cause increases in capital expenditure or exploration and development costs or reduction in levels of production at producing properties or require abandonment or delays in development of new properties.

#### *Uninsurable Risks*

Exploration of mineral properties involves numerous risks, including unexpected or unusual geological conditions, rock bursts, cave-ins, fires, floods, earthquakes and other environmental occurrences, and political and social instability. It is not always possible to obtain insurance against all such risks and the Company may decide not to insure against certain risks as a result of high premiums or other reasons. Should such liabilities arise, they could reduce or eliminate any further profitability and result in increasing costs and a decline in the value of the securities of the Company. The Company does not maintain insurance against environmental risks.

#### *Competition*

Significant and increasing competition exists for mineral opportunities. There are a number of large established mineral exploration companies with substantial capabilities and greater financial and technical resources than the Company. The Company may be unable to acquire additional mineral properties or acquire such properties on terms it considers acceptable. Accordingly, there can be no assurance that the Company's exploration programs will yield any reserves or result in any commercial mineral operations.

#### *Economic Conditions*

Unfavorable economic conditions may negatively impact the Company's financial viability as a result of increased financing costs and limited access to capital markets.

#### *Conflicts of Interest*

Directors of the Company may, from time to time, serve as directors of, or participate in ventures with other companies involved in natural resource development. As a result, there may be situations that involve a conflict of interest for such directors. Each director will attempt not only to avoid dealing with such other companies in situations where conflicts might arise but will also disclose all such conflicts in accordance with the *Business Corporations Act* (British Columbia) and will govern themselves in respect thereof to the best of their ability in accordance with the obligations imposed upon them by law.

No assurance can be given that any discovered mineral reserves and resources will be recovered or that they will be recovered at the rates estimated. Mineral reserve and resource estimates are based on limited sampling and, consequently, are uncertain because the samples may not be representative. Mineral reserve and resource estimates may require revision (either up or down) based on actual production experience.
