The Acquiror is a corporation existing under the laws of the Province of Ontario. Its principal business is mining and exploration.

On April 8, 2021, the Acquiror agreed to purchase 15,900,000 shares of the Reporting Issuer at a price of \$0.08 per common share (the "Purchase Shares") by way of a share purchase agreement entered into with Oberon Capital Corporation for a purchase price of \$1,272,000 (the "Transaction").

Prior to the closing of the Transaction, the Acquiror had beneficial ownership of, or control and direction over 42,311,077 common shares and 4,520,000 warrants of the Reporting Issuer, or 17.44% of its issued and outstanding common shares on a partially diluted basis (assuming exercise of the warrants).

Assuming exercise of the warrants, the Acquiror will have the beneficial ownership of, or control and direction over 62,731,077 common shares or 19.96% of the issued and outstanding shares of the Reporting Issuer on a partially diluted basis, calculated as of the date of the Transaction. The Acquiror does not own any other securities of the Reporting Issuer.
