The last reported net asset value as at 30 September 2020 was 50.6 pence per ordinary share.

The Company’s issued share capital now consists of 128,956,091 ordinary shares of 10 pence each with voting rights. In addition, the Company holds 12,376,437 ordinary shares of 10 pence each in treasury.

The above figure of 128,956,091 ordinary shares may be used by shareholders as the denominator for the calculations by which they will determine if they are required to notify their interest in, or a change to their interest in, the Company under the FCA’s Disclosure and Transparency Rules.
