



NOTICE OF ANNUAL GENERAL MEETING OF SHAREHOLDERS

NOTICE IS HEREBY GIVEN that the annual general meeting (the “**Meeting**”) of shareholders of Silver Dollar Resources Inc. If a shareholder does not deliver a Proxy or Voting Instruction Form to TSX Trust Company, 301 – 100 Adelaide Street West, Toronto, Ontario, M5H 4H1, by 11:00 a.m. Pacific time on Friday, August 14, 2026 (or before 48 hours, excluding Saturdays, Sundays and holidays before any adjournment or postponement of the meeting at which the proxy is to be used) then the shareholder will not be entitled to vote at the Meeting by proxy. Only shareholders of record at the close of business on July 9, 2026 will be entitled to vote at the Meeting.
