The notes offered by this pricing supplement are unsecured debt securities issued by Bank of Montreal. The objective of the notes is to offer investors an income stream via potential periodic coupon payments with contingent downside protection against the loss of their principal investment from any negative performance above the barrier level of Solactive Canada Energy Select 75 AR Index over the term of the notes.

The notes provide contingent protection only and, as such, investors should be comfortable with the risk of losing some or substantially all of their principal investment in the notes, subject to a minimum payment amount of CAD \$1.00 per note at maturity.

The maximum return that an investor may receive on the notes is CAD \$177.28 assuming the payment of a coupon on each coupon payment date as well as the principal amount of CAD \$100.00 per note at maturity.

All payments on the notes are subject to the credit risk of Bank of Montreal.

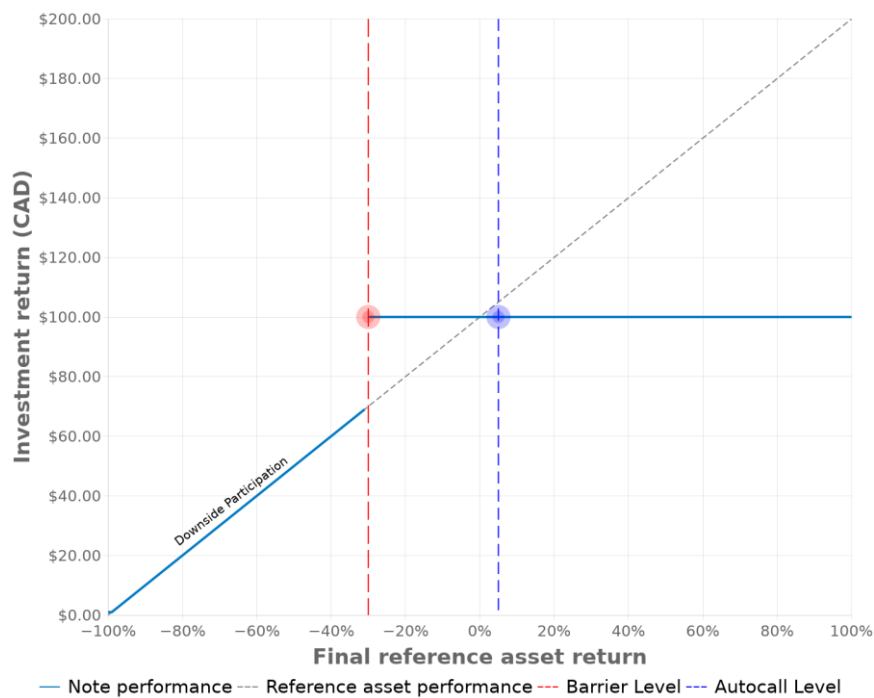

Maturity Payment Profile

The return profile below is provided for illustration purposes only. This graph demonstrates the maturity payment on the notes based on varying values of the final reference asset return. There can be no assurance that any specific return will be achieved on the notes (subject to the minimum payment amount). All examples assume that you have purchased notes with a stated principal amount of CAD \$100.00, that you hold the notes until maturity and that no early redemption or extraordinary event has occurred during the term of the notes.



The diagonal grey dashed line represents a range of possible returns that could be generated by a direct investment in the reference asset over the term of the notes. If the final level is at or above the barrier level, your principal investment will be protected and you will receive a maturity payment equal to the principal amount. If the final level is less than the barrier level, the maturity payment will be reduced by an amount equal to the final reference asset return (which will be a negative amount). The notes provide contingent principal protection only, so you could lose some or substantially all of your principal investment in the notes (subject to the minimum payment amount).

The table below shows the maturity payment and corresponding return (excluding any coupon payments received over the term of the note) that you would receive on the notes based on various values for the final reference asset return.

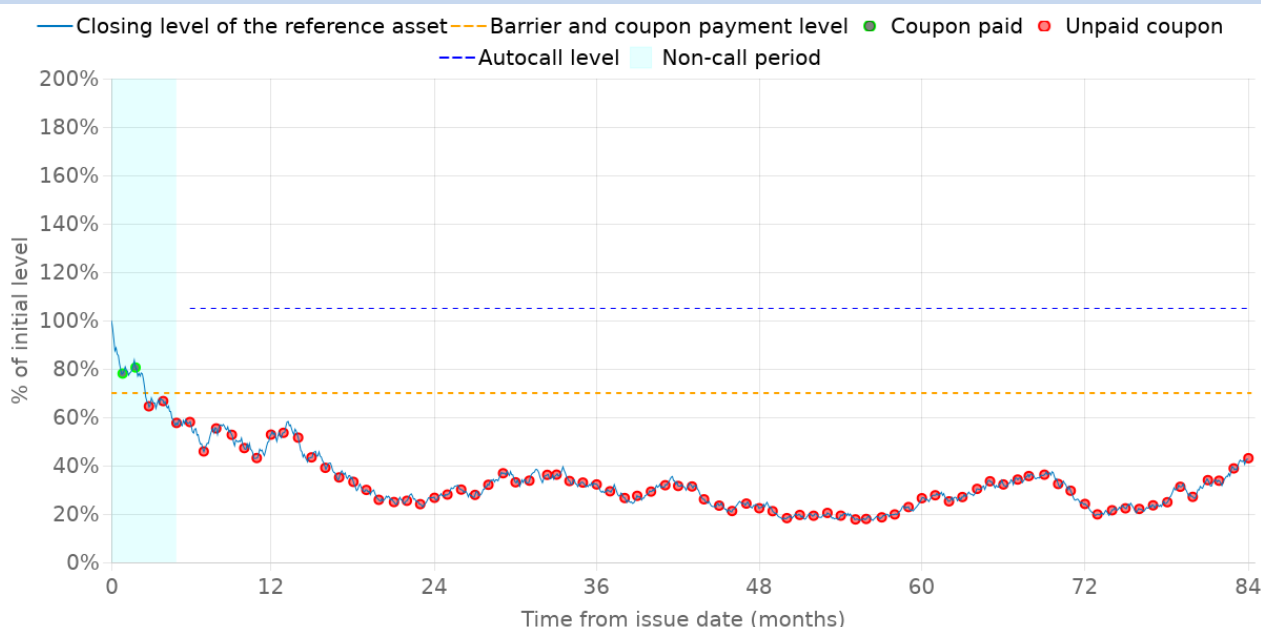
Hypothetical Examples

The following hypothetical examples demonstrate how the payment you may receive will be calculated and determined under four different scenarios.

The hypothetical closing levels used in these examples are for illustrative purposes only and should not be construed in any way as estimates or forecasts of the future performance of the reference asset or the return that you might realize on the notes. All hypothetical examples assume that no events described under “Certain Additional Terms for Notes Linked to a Reference Index” in the income product supplement have occurred during the term. For ease of analysis, figures below have been rounded.

Barrier level/Coupon payment level	Autocall level
70.00% of the initial level	105.00% of the initial level

Example 1 – Payment at Maturity (Negative Scenario)



In this hypothetical example, the closing level is below the autocall level on all autocall observation dates, so the notes are not redeemed early. Furthermore, it is above the coupon payment level on the first and second coupon observation dates and below the coupon payment level on all the others, so you would receive two of the coupon payments.

Lastly, the final level is at 45.00% of the initial level, which is below the barrier level, so the final reference asset return is –55.00%. Accordingly, you would receive a maturity payment of CAD \$45.00 per note with coupons totalling CAD \$1.84 per note over the term of the notes (which is equivalent to a compounded annual loss of 10.25% on the notes).

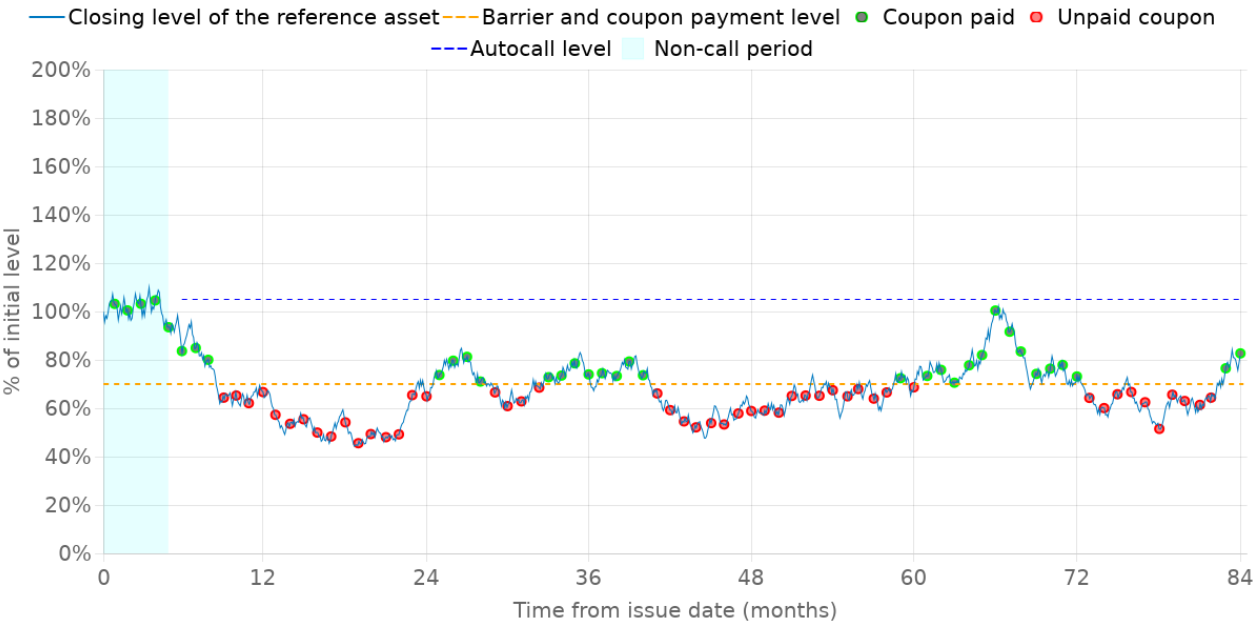
In this example, the maturity payment is calculated as follows:

$$\begin{aligned}
 \text{Maturity payment} &= \text{CAD } \$100.00 + (\text{CAD } \$100.00 \times \text{final reference asset return}) \\
 &= \text{CAD } \$100.00 + (\text{CAD } \$100.00 \times -55.00\%) \\
 &= \text{CAD } \$45.00
 \end{aligned}$$

Example 2 – Payment at Maturity (Neutral Scenario)



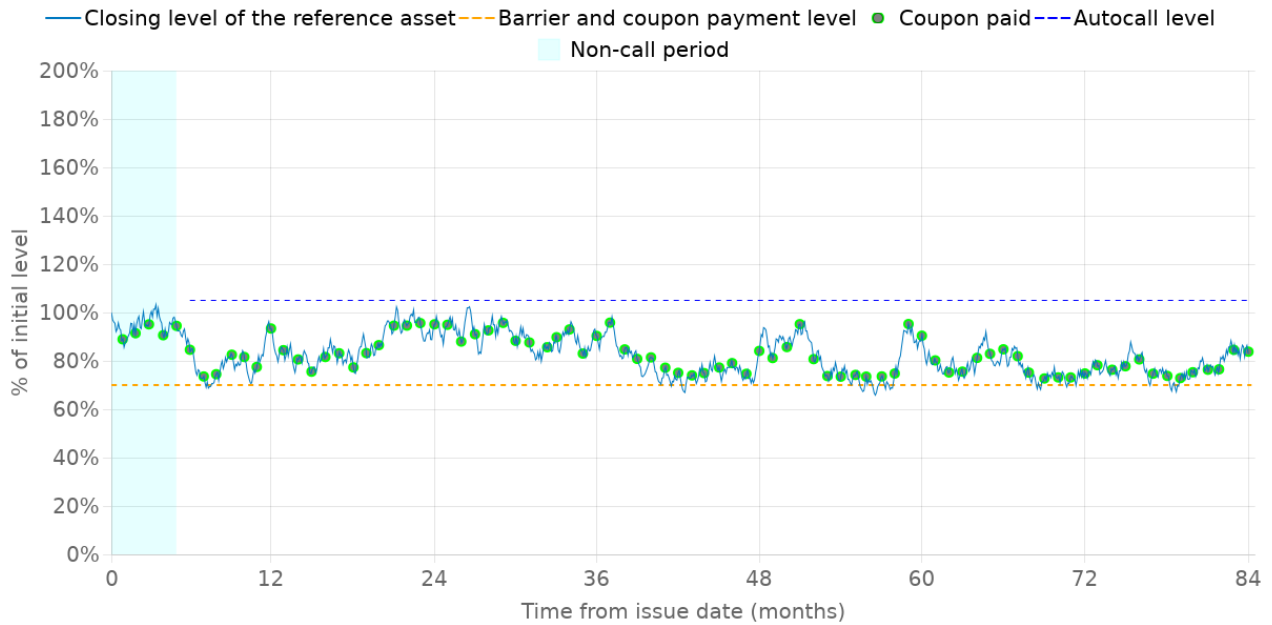
In this hypothetical example, the closing level is below the autocall level on all autocall observation dates, so the notes are not redeemed early. Furthermore, it is above the coupon payment level on thirty-five of the coupon observation dates and below the coupon payment level on all the others, so you would receive thirty-five of the coupon payments.

Lastly, the final level is at 87.00% of the initial level, which is above the barrier level, so the final reference asset return is -13.00%. Accordingly, you would receive a maturity payment equal to the principal amount with coupons totalling CAD \$32.20 per note over the term of the notes (which is equivalent to a compounded annual return of 4.06% on the notes).

The following table summarizes the payments that you would receive for each CAD \$100.00 note.

Example 3 – Payment at Maturity (Positive Scenario)



In this hypothetical example, the closing level is below the autocall level on all autocall observation dates, so the notes are not redeemed early. Furthermore, it is above the coupon payment level on all of the coupon observation dates, so you would receive all of the coupon payments.

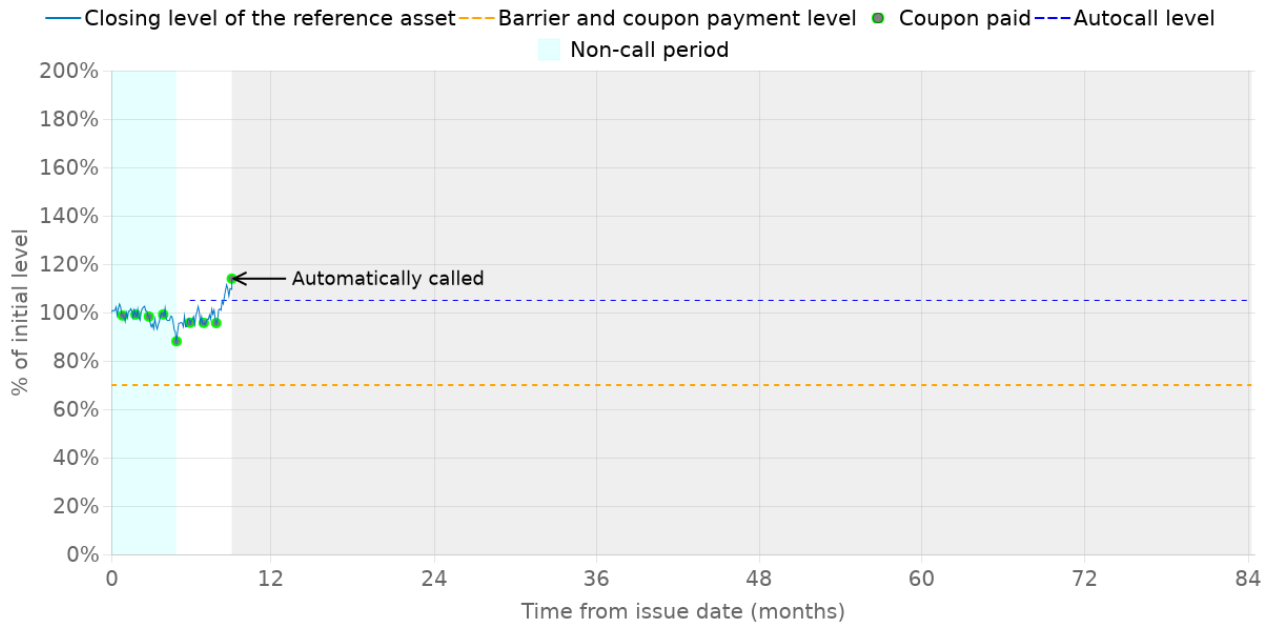
Lastly, the final level is at 83.00% of the initial level, which is above the barrier level, so the final reference asset return is -17.00%. Accordingly, you would receive a maturity payment equal to the principal amount with coupons totalling CAD \$77.28 per note over the term of the notes (which is equivalent to a compounded annual return of 8.51% on the notes).

The following table summarizes the payments that you would receive for each CAD \$100.00 note.

Example 4 – Automatic Early Redemption



In this hypothetical example, the closing level is below the autocall level on all autocall observation dates until the ninth observation date. This results in the notes being redeemed early on the autocall payment date corresponding with the ninth observation date. Furthermore, it is above the coupon payment level on nine of the coupon observation dates, so you would receive nine of the coupon payments before the notes are redeemed.

Lastly, the closing level is at 114.00% of the initial level, which is above the autocall level, so the reference asset return is 14.00% and the notes are redeemed early for a value of CAD \$100.00. Accordingly, you would receive a maturity payment equal to the principal amount with coupons totalling CAD \$8.28 per note over the term of the notes (which is equivalent to a compounded annual return of 11.05% on the notes).

The following table summarizes the payments that you would receive for each CAD \$100.00 note.

Solactive Canada Energy Select 75 AR Index (ticker: SOCAEN75)

General Description

The Solactive Canada Energy Select 75 AR Index is an adjusted return index. It aims to track the gross total return performance of the Solactive Canada Energy Select Index TR (the “underlying index”), calculated in Canadian dollars, less an adjusted return factor of 75 index points per annum that will be calculated daily in arrears (the “adjusted return factor”). The underlying index is a free-float market capitalization weighted equity index. The methodology of the underlying index provides that the constituent securities fulfill the following criteria: must be part of the GBS INDEX UNIVERSE of the Solactive GBS Canada Large & Mid Cap Index PR (ISIN: DE000SLA4D48); be listed on the Toronto Stock Exchange; be classified under the Oil & Gas Production (code: 2105) or Integrated Oil (code: 2110) industries according to FactSet Standard Classification; and have an average daily value traded of at least USD \$20,000,000 over the preceding 1-month and 6-month period. The closing level on March 31, 2026 was 2,341.38. The adjusted return factor divided by the closing level was therefore equal to 3.20% on March 31, 2026. Over the term of the notes, the sum of the adjusted return factor will be approximately 526 index points, representing 22.46% of the closing level on March 31, 2026.

The underlying index is a gross total return index that reflects the price changes of its constituent securities and the reinvestment in the underlying index of any dividends and distributions paid in respect of such securities. For the calculation of the level of the underlying index, any dividends or other distributions paid on the constituent securities of the underlying index are assumed to be reinvested across all the constituent securities of the underlying index. The composition of the underlying index is adjusted quarterly, ordinarily in February, May, August, and November, and is also subject to extraordinary adjustments in compliance with the rules of the index sponsor.

Investments in the notes are uncertain in nature in that they could produce no return and you could lose some or substantially all of your principal investment in the notes. An investment in the notes is only suitable for investors with a medium-term investment horizon and who are prepared to assume risk with an investment whose return and repayment of principal is dependent upon the closing level on the observation dates. It is possible that you may not receive any coupons during the term of the notes.
