Hot Chili Limited – Request for Voluntary Suspension

Further to the Company's current trading halt, which was granted by ASX on Wednesday, 1 May 2024, Hot Chili Limited (ASX: HCH) (TSXV: HCH) (OTCQX: HHLKF) ("Hot Chili" or "the Company") requests that a voluntary suspension of its quoted securities be granted in accordance with ASX Listing Rule 17.2 from the commencement of trading on Friday, 3 May 2024.

For the purposes of ASX Listing Rule 17.2, the Company provides the following information:

- (a) The Company requests the voluntary suspension pending an announcement concerning the results of a capital raising which was announced on Wednesday, 1 May 2024 (**Capital Raise**).
- (b) The voluntary suspension is necessary to prevent trading in the Company's securities on an uninformed basis, pending the results of the Capital Raise being released.
- (c) The suspension is requested to remain in place until the earlier of the commencement of normal trading on Monday, 6 May 2024 or when the announcement is released to the market regarding the above.
- (d) The Company is not aware of any reason why the voluntary suspension should not be granted nor any other information to inform the market about the voluntary suspension.
