

MANAGEMENT'S DISCUSSION AND ANALYSIS
OF FINANCIAL CONDITION AND RESULTS OF OPERATIONS
MARCH 31, 2024

Management's discussion and analysis (MD&A) is current to May 15, 2024 and is management's assessment of the operations and the financial results together with future prospects of 1329310 B.C. Ltd. ("1329310" or the "Company"). This MD&A should be read in conjunction with our unaudited condensed interim financial statements for the period ended March 31, 2024 and 2023 and notes thereto, prepared in accordance with International Financial Reporting Standards. All figures are in Canadian dollars unless stated otherwise. This discussion contains forward-looking statements that are not historical in nature and involves risks and uncertainties. Forward-looking statements are not guarantees as to 1329310's future results as there are inherent difficulties in predicting future results. Accordingly, actual results could differ materially from those expressed or implied in the forward-looking statements. The Company has adopted National Instrument 51-102F1 as the guideline in presenting the MD&A. Additional information relevant to 1329310's activities, including 1329310's Press Releases can be found on SEDAR at www.sedarplus.ca.

OVERVIEW OF THE BUSINESS

1329310 B.C. Ltd. (the "Company"), was incorporated on October 20, 2021 under the *Business Corporations Act* (British Columbia). Its principal business is to effect mergers, arrangements, reverse takeover transactions and other corporate transactions with other entities with a view to providing liquidity in connection with "go public" transactions. The Company's head office is located at 890 Pender Street, Suite 600, Vancouver, British Columbia V6C 1J9.

The Company was a wholly-owned subsidiary of Veta Resources Inc. ("Veta") until a plan of arrangement was completed on February 18, 2022 under which the Company's common shares were distributed to shareholders of Veta on a pro-rata basis. The Company issued 22,590,750 common shares. On the same day, the Company became a reporting issuer.

PROPOSED TRANSACTION

On May 7, 2024, the Company entered into a non-binding letter of intent (the "LOI") with Wisr AI Solutions Inc., a private British Columbia corporation ("WisrAI"), pursuant to which the Company and WisrAI have agreed to complete a transaction that will result in a reverse takeover of the Company by WisrAI (the "Proposed Transaction"). The LOI outlines the terms and conditions of the Proposed Transaction, upon the completion of which, the resulting issuer (the "Resulting Issuer") will carry on the businesses of WisrAI and seek a listing on the Canadian Securities Exchange or such other recognized Canadian stock exchange as the parties may agree upon (in any case, the "Exchange").

The Proposed Transaction is expected to proceed by way of a statutory three-cornered amalgamation, but is subject to the receipt of tax, corporate and securities law advice by both the Company and WisrAI. As part of the Proposed Transaction, the current shareholders of WisrAI are expected to receive approximately 35,000,000 common shares in the capital of the Company in exchange for their shares of WisrAI. The parties currently anticipate entering into a definitive agreement in respect of the Proposed Transaction on or before July 31, 2024.

In connection with the Proposed Transaction, the Company is required to complete a private placement financing (the "Private Placement") for gross proceeds of not less than \$1,000,000 on terms to be determined in the context of the market, but which is anticipated to consist of units (each, a "Unit") comprised of one common share of WisrAI and one-half of one warrant, with each whole warrant exercisable into one common share of WisrAI for a period of two years. The shares and warrants underlying the Units will be exchanged for shares and warrants of the Resulting Issuer on the same terms as the issued and outstanding securities of WisrAI.

Immediately prior to the completion of the Proposed Transaction, it is anticipated that the Company will consolidate its issued and outstanding common shares on the basis of up to 10 pre-consolidation shares for each one post-consolidation share (the "Consolidation"), with the result that the post-consolidation shares (including any shares issued upon the conversion of existing debt of the Company) will have a deemed value of not less than \$550,000.

The directors and officers of the Resulting Issuer will be determined at a later date; however, upon the completion of the Proposed Transaction, it is anticipated that the board of directors will consist of five nominees, four of whom will be identified by WisrAI and one of whom will be identified and agreed upon by the parties.

The Proposed Transaction is subject to a number of conditions, including but not limited to: the parties successfully entering into a definitive agreement in respect of the Proposed Transaction; the completion of the Private Placement; the completion of the Consolidation; receipt of all necessary approvals, including the approval of the Exchange (if necessary); and certain other closing conditions, including the completion of satisfactory due diligence by the parties.

OPERATIONAL DISCUSSION

The following is management's discussion and analysis of the results of operations and liquidity and financial condition of the Company for the period ended March 31, 2024 and 2023. RELATED PARTY DISCLOSURES

i) Key management personnel compensation

The company did not pay employment-based remuneration to directors, officers or other members of key management for the period ended March 31, 2024. However, the Company did pay contract-based remuneration to directors, officers and other members of key management as disclosed below.

Related party balances

Included in trade and other payables at March 31, 2024 is \$104,223 (December 31, 2023 – \$100,507) due to related parties. Such amounts are due on demand, non-interest bearing and are unsecured.

LIQUIDITY AND CAPITAL RESOURCES

The Company had a working capital deficit of \$132,897 as at March 31, 2024 (December 31, 2023 - \$120,776). The Company does not have revenues from operations and relies on outside funding for its continuing financial liquidity. The Company will need additional financing in order to continue operations. A related party undertakes to finance the Company until self-sustainability is achieved.

Management cautions that the Company's ability to raise additional funding is not certain. Additional funds will be required in order to pursue the Company's current business plans. An inability to raise additional funds would adversely impact the future assessment of the Company as a going concern.

Share Capital Transactions

On October 20, 2021, the company issued 1 common share upon incorporation for proceeds of \$1.

On February 18, 2022, under a statutory plan of arrangement, the Company canceled the 1 outstanding common share issued upon incorporation and issued 22,590,750 new common shares from treasury for no additional consideration.

OFF-STATEMENT OF FINANCIAL POSITION ARRANGEMENTS

The Company has no off-statement of financial position arrangements.

DIVIDEND INFORMATION

The Company has neither declared nor paid any dividends on its Common Shares. The Company intends to retain its earnings, if any, to finance growth and expand its operation and does not anticipate paying any dividends on its Common Shares in the foreseeable future.

OUTSTANDING SHARE DATA

As at the date of this MD&A, there were 22,590,750 common shares outstanding.

CRITICAL ACCOUNTING ESTIMATES

Use of management estimates, judgments and measurement uncertainty

The preparation of these financial statements using accounting policies in accordance with IFRS requires management to make judgements and estimates and form assumptions that affect the reported amounts of assets and liabilities and the disclosure of contingent assets and liabilities at the date of the financial statements and reported amounts of revenues and expenses during the reporting period. Such estimates primarily relate to unsettled transactions and events as at the date of the financial statements. On an ongoing basis, management evaluates its judgements and estimates in relation to assets, liabilities, revenue and expenses. Management uses historical experience and various other factors it believes to be reasonable under the given circumstances as the basis for its judgements and estimates. Actual outcomes may differ from these estimates under different assumptions and conditions. Significant estimates and judgments made by management in the preparation of these financial statements are outlined below:

Income, value added, withholding and other taxes

The Company is subject to income, value added, withholding and other taxes. Significant judgment is required in determining the Company's provisions for taxes. There are many transactions and calculations for which the ultimate tax determination is uncertain during the ordinary course of business. The Company recognizes liabilities for anticipated tax audit issues based on estimates of whether additional taxes will be due. The determination of the Company's income, value added, withholding and other tax liabilities requires interpretation of complex laws and regulations. The Company's interpretation of taxation law as applied to transactions and activities may not coincide with the interpretation of the tax authorities. All tax related filings are subject to government audit and potential reassessment subsequent to the financial statement reporting period. Where the final tax outcome of these matters is different from the amounts that were initially recorded, such differences will impact the tax related accruals and deferred income tax provisions in the period in which such determination is made.

Functional currency

The Company's management is required to make judgments as to the currency of the primary economic environment in which an entity operates to determine the functional currency of the entity. The Company has determined the functional currency of the parent company to be the Canadian dollar.

FINANCIAL RISK FACTORS

Fair value hierarchy and fair value

Financial instruments recorded at fair value on the statement of financial position are classified using a fair value hierarchy that reflects the significance of the inputs used in making the measurements. The fair value hierarchy has the following levels:

Level 1 - valuation based on quoted prices (unadjusted) in active markets for identical assets or liabilities;

Level 2 - valuation techniques based on inputs other than quoted prices included in Level 1 that are observable for the asset or liability, either directly (i.e. as prices) or indirectly (i.e. derived from prices);

Level 3 - valuation techniques using inputs for the asset or liability that are not based on observable market data.

As at March 31, 2024, the Company did not have any financial instruments measured at fair value and that classification within the fair value hierarchy. As at March 31, 2024, the carrying and fair value amounts of the Company's other financial instruments are approximately equivalent due to the relatively short periods to maturity of these investments.

Fair value estimates are made at a specific point in time, based on relevant market information and information about financial instruments. These estimates are subject to and involve uncertainties and

matters of significant judgment, and therefore cannot be determined with precision. Changes in assumptions could significantly affect the estimates.

A summary of the Company's risk exposures as it relates to financial instruments are reflected below:

i) Credit risk

Credit risk is the risk of loss associated with a counter-party's inability to fulfill its payment obligations. The credit risk is attributable to various financial instruments, as noted below. The credit risk is limited to the carrying value amount carried on the statement of financial position.

- a. **Cash and cash equivalents** – Cash is held in trust with the lawyer and the risk of loss is minimal.

The Company's maximum exposure to credit risk as at March 31, 2024 is the carrying value of cash.

ii) Liquidity risk

The Company's approach to managing liquidity risk is to ensure that it will have sufficient liquidity to meet liabilities as they become due. At March 31, 2024, the Company had a working capital deficiency of \$132,897 (December 31, 2023 - \$120,776). Working capital deficiency as at March 31, 2024 consisted of: cash of \$1,929 (December 31, 2023 - \$1,285), accounts receivables of \$732 (December 31, 2023 - \$1,929), and trade and other payables of \$135,558 (December 31, 2023 - \$123,990). The Company had not yet achieved profitable operations, has accumulated losses of \$132,898 (December 31, 2023 - \$120,777) and expects to incur further losses in the development of its business.

iii) Interest rate risk

The Company is not exposed to significant interest rate risk due to the short-term nature of its monetary assets and liabilities. Cash not required in the short term, is invested in short-term guaranteed investment certificates, as appropriate.

OTHER RISK FACTORS

There are a number of risks and uncertainties that may have a material and adverse impact on the future operating and financial performance of 1329310 and could cause 1329310's proposed plans, prospects, strategies, events, operating and financial performance and results to differ materially from the estimates described in forward-looking statements and forward-looking information in this MD&A related to 1329310. These include widespread risks associated with any form of business and specific risks associated with 1329310's business. An investment in 1329310 Shares, as well as 1329310's prospects, is highly speculative due to the high-risk nature of its business, as well as due to the limited assets and cash resources of 1329310. Shareholders of 1329310 may lose their entire investment. The risks described below are not the only ones facing 1329310. Additional risks not currently known to 1329310, or that 1329310 currently deems immaterial, may also impair 1329310's proposed plans, prospects, strategies, events, business, operations, financial performance and results. If any of the following risks actually occur, 1329310's plans, strategies, events, business, financial performance and condition, results and prospects could be adversely affected.

Absence of Public Trading Market

Currently there is no public market for the Common Shares, and there can be no assurance that an active market for the Common Shares will develop or be sustained. If an active public market for the Common Shares does not develop, the liquidity of an investor's investment may be limited and the share price may decline below an investor's initial purchase price.

Internal Controls

Internal controls over financial reporting are procedures designed to provide reasonable assurance that transactions are properly authorized, assets are safeguarded against unauthorized or improper use,

and transactions are properly recorded and reported. A control system, no matter how well designed and operated, can provide only reasonable, and not absolute, assurance with respect to the reliability of financial reporting and financial statement preparation.

DISCLOSURE AND INTERNAL CONTROLS

Management has established processes, which are in place to provide them sufficient knowledge to support management representations that they have exercised reasonable diligence that (i) the financial statements do not contain any untrue statement of material fact or omit to state a material fact required to be stated or that is necessary to make a statement not misleading in light of the circumstances under which it is made, as of the date of and for the periods presented by the financial statements and (ii) the financial statements fairly present in all material respects the financial condition, results of operations and cash flows of the Company, as of the date of and for the periods presented by the financial statements.

In contrast to the certificate required under National Instrument 52-109 Certification of Disclosure in Issuers' Annual and Interim Filings (Form 52-109FV2), the Company utilizes the Venture Issuer Basic Certificate which does not include representations relating to the establishment and maintenance of disclosure controls and procedures (DC&P) and internal control over financial reporting (ICFR), as defined in NI 52-109. In particular, the certifying officers filing the Certificate are not making any representations relating to the establishment and maintenance of:

- (i) controls and other procedures designed to provide reasonable assurance that information required to be disclosed by the issuer in its annual filings, interim filings or other reports filed or submitted under securities legislation is recorded, processed, summarized and reported within the time periods specified in securities legislation; and
- (ii) a process to provide reasonable assurance regarding the reliability of financial reporting and the preparation of financial statements for external purposes in accordance with the issuer's IFRS.

The Company's certifying officers are responsible for ensuring that processes are in place to provide them with sufficient knowledge to support the representations they are making in this certificate.

Investors should be aware that inherent limitations on the ability of certifying officers of a venture issuer to design and implement on a cost-effective basis DC&P and ICFR as defined in NI 52-109 may result in additional risks to the quality, reliability, transparency and timeliness of interim and annual filings and other reports provided under securities legislation.

The Company's Chief Executive Officer ("CEO") and Chief Financial Officer ("CFO") are responsible for the design and effectiveness of disclosure controls and procedures ("DC&P") and the design of internal control over financial reporting ("ICFR") to provide reasonable assurance that material information related to the Company is made known to the Company's certifying officers. The Company's controls are based on the Committee of Sponsoring Organizations ("COSO") 2013 framework. The Company's CEO and the CFO have evaluated the design and effectiveness of the Company's DC&P as of March 31, 2024 and have concluded that these controls and procedures are effective in providing reasonable assurance that material information relating to the Company is made known to them by others within the Company. The CEO and CFO have also evaluated the design and effectiveness of the Company's ICFR as of March 31, 2024 and concluded that these controls and procedures are effective in providing reasonable assurance that financial information is recorded, processed, summarized and reported in a timely manner.

During the current period, there have been no changes in the Company's DC&P or ICFR that materially affected, or are reasonably likely to materially affect, the Company's internal control over financial reporting.
