**RONIN VENTURES CORP. COMPLETES IPO AND
ANNOUNCES LISTING ON THE TSX VENTURE EXCHANGE**

News Release - Vancouver, British Columbia – August 11, 2022: Ronin Ventures Corp. (TSX-V: RVC.P) (the “**Company**”) is pleased to announce that the Company completed its initial public offering (“**IPO**”) in which it distributed 2,000,000 common shares of the Company at a price of \$0.10 per common share for aggregate gross proceeds of \$200,000 pursuant to a final prospectus dated May 13, 2022. The Company’s common shares were listed on August 11, 2022 and are expected to commence trading on the TSX Venture Exchange (the “**Exchange**”) on or about August 15, 2022 under the trading symbol “RVC.P”.

Leede Jones Gable Inc. (the “**Agent**”) acted as exclusive agent in respect of the IPO on a commercially reasonable efforts basis. The IPO consisted of the distribution of 2,000,000 common shares at a price of \$0.10 per common share. Pursuant to the IPO, the Agent received a cash commission of 10% of the gross proceeds raised and an aggregate of 200,000 non-transferable common share purchase warrants entitling the Agent and members of its selling group to purchase 200,000 common shares at \$0.10 per common share at any time until August 11, 2024. The Agent also received a cash corporate finance fee.

At the closing of the IPO, the Company also granted stock options (the “**Options**”) to the directors of the Company to acquire up to an aggregate of 450,000 common shares. Each Option is exercisable to acquire one common share at a price of \$0.10 at any time until August 11, 2027.

Following completion of the IPO, the Company has 4,500,000 common shares issued and outstanding, 2,500,000 of which are subject to escrow restrictions pursuant to the policies of the Exchange.

The Company is a capital pool company within the meaning of the policies of the Exchange. The Company has not commenced operations and has no assets other than cash. The Company will use the net proceeds of the IPO to identify and evaluate potential ‘Qualifying Transactions’ pursuant to the policies of the Exchange.
