AMENDMENT TO AGREEMENT FOR GOOGLE ADVERTISING AND ANALYTICS SERVICES

This Amendment to Agreement for Google Advertising and Analytics services ("Amendment") is entered into on this 20 day of September, 2023 (the "Effective Date"), by and between Aleen Inc. ("Company") and Leading Internet Venture LLC ("Agency").

WHEREAS, the Company and the Agency have an existing agreement in place for the provision of Google Advertising and Analytics services (the "Agreement");

WHEREAS, the Company has identified several technical issues and bugs within the Google Advertising and Analytics services that require resolution;

WHEREAS, the Company requests the temporary suspension of Google Advertising and Analytics services for the month of October 2023 to address and resolve these issues;

WHEREAS, the Company requests a payment schedule adjustment to move the payment of \$1,000.00 for the month of October 2023 to November 2023 to align with the temporary suspension of services;

NOW, THEREFORE, in consideration of the mutual covenants contained herein, the Company and the Agency hereby agree as follows:

1. Temporary Suspension of Services

1.1 During the period of October 2023, the Agency shall temporarily suspend the provision of Google Advertising and Analytics services to the Company. This suspension is to allow the Company and the Agency to identify and rectify technical issues and bugs impacting the services.

2. Payment Schedule Adjustment

2.1 The Company and the Agency agree to adjust the payment schedule as follows:

2.2 The payment of \$1,000.00 (one thousand U.S. dollars) for Google Advertising and Analytics services for the month of October 2023 shall be moved to November 2023, aligning with the resumption of services and the expected resolution of technical issues.

3. Continuation of Agreement

3.1 Except as expressly modified by this Amendment, all other terms and conditions of the original Agreement shall remain in full force and effect.

4. Governing Law

4.1 This Amendment shall be governed by and construed in accordance with the laws of Ontario, Canada.

5. Entire Agreement

5.1 This Amendment constitutes the entire agreement between the Company and the Agency with respect to the subject matter hereof and supersedes all prior discussions, negotiations, and agreements.
