AGREEMENT EXTENSION FOR GOOGLE ADVERTISING AND ANALYTICS SERVICES

This Agreement Extension ("Extension") is entered into between Aleen Inc. ("Company") and Leading Internet Venture LLC ("Agency") on November 30, 2023, collectively referred to as the "Parties".

Background:

The Parties entered into an Agreement for Google Advertising and Analytics Services, dated May 1, 2023 (referred to as the "Original Agreement"), that was initially set to conclude on October 31, 2023. However, on September 20, 2023, the Company with the Agency, signed an Amendment to the Agreement for Google Advertising and Analytics Services (referred to as the "Amendment"). The extension, initially scheduled for October 31, 2023, was rescheduled to November 30, 2023. The Company now expresses the intention to further extend the term of the agreement.

Agreement Extension:

Term:

The term of this Extension shall commence on **December 1, 2023**, and terminate on **May 31, 2024** (the "Extended Term").

Scope of Services:

The scope of services provided by the Agency during the Extended Term shall remain consistent with the services outlined in the Original Agreement.

Compensation:

The Company and the Agency have agreed on the following budget for the specified months:

- December 2023: \$1000
- January 2024: \$1000
- February 2024: \$1000
- March 2024: \$1000
- April 2024: \$1000
- May 2024: \$1000

The Company pledges to remit **\$6,000 (six thousand U.S. dollars)** to the Agency for Google advertising and analytics services within the next six months. The payment can be distributed by the Company, but the **initial payment** must be a **minimum of \$1,000** and settled within **fifteen business days**, with a deadline of **December 21, 2023**. The remaining balance of \$5,000

can be paid collectively or on a monthly basis, but each installment should not be less than \$1,000 and must be paid within fifteen business days of each month.

Performance Metrics:

The Parties shall continue to work towards achieving mutually agreed-upon performance metrics and goals as outlined in the Original Agreement.

Confidentiality:

All terms related to the confidentiality of information shared during the term of the Original Agreement shall remain in effect during the Extended Term.

Governing Law:

This Extension shall be governed by and construed in accordance with the courts of Ontario, Canada.

Amendments:

Any amendments or modifications to this Extension must be made in writing and signed by both Parties.

Entire Agreement:

This Extension constitutes the entire agreement between the Parties and supersedes all prior agreements, understandings, and negotiations, whether oral or written.
