

CONSULTING SERVICES AGREEMENT

The Parties

This Consulting Services Agreement (this "Agreement") dated as of **November 23, 2022**, is by and between **GUANGZHOU JAAN MEDICAL CO.,LTD** with its principal place of business located at 4NO-813, 6TH FLOOR, EAST BUILDING, XICHA ROAD, GUANGZHOU, CHINA ("Consultant") and **Aleen Inc.**, with its principal place of business located at 2507 - 4978 Yonge St. North York, ON M2N 7G9, Toronto, Canada ("Client").

Background

- a) The Company desires to retain the Consultant for the term set forth in this Agreement to assure itself of the services of the Consultant, and the Consultant is willing to be retained by the Company for the term on the terms and conditions set forth below.
- b) The Consultant desires to provide the services under this Agreement and represents that it is qualified to perform such services.

Agreement

Services provided

1. The services to be performed by the Consultant under this Agreement (the "Services") shall consist of all tasks assigned by the Chief Executive Officer of the Company, including, but not limited to, the following: **Consulting services in the area of clinical medicine "dentistry"**.

Consulting services include the following list of work:

- Analyzing databases (60 hours) - \$3000;
- Adjustment of database structure with involvement of developers and medical experts (80 hours) - \$4000;
- Evaluation and determination of preliminary diagnosis criteria (25 hours) - \$1250;
- Validation and recommendations for diagnostic algorithms (35 hours) - \$1750;
- Cost of 1 hour: \$50
- **Total amount: \$10 000.00**

Payment

2. In consideration for the Services to be performed by Consultant, Client agrees to pay Consultant in the following manner the total amount of **\$10 000.00** (ten thousand U.S. dollars).
3. Consultant shall be paid within a reasonable time after Consultant submits an invoice to Client. The invoice should include the following: an invoice number, the dates covered by the invoice, a summary of the work performed, and any other information or details in accordance with this Agreement.

Taxes

4. The Consultant, and not the Company, shall be solely responsible for all taxes incurred by the Consultant in connection with this Agreement, including, but not limited to, all withholding, social security and other taxes with respect to the Consultant's compensation.

Conflict of Interest

5. The Consultant and the Company agree that there is no conflict of interest in connection with the retention by the Company of the Consultant pursuant to this Agreement.

Liability Limitation

6. In no event shall either party be liable to the other party whether in contract, tort or otherwise, for payment of any special, indirect, incidental, consequential or similar damages.

Notice

7. All notices required under this Agreement shall be deemed given when sent by overnight courier or registered or certified mail, or when sent by telecopy, telegraph or other graphic, electronic means and confirmed by overnight courier or registered or certified mail addressed to the address set forth in the preamble to this Agreement. Either party shall have the right to change the address or name of the person to whom such notices are to be delivered by notice to the other party.

Assignment

8. This Agreement and all of the Consultant's rights, duties and obligations under this Agreement shall not be subcontracted, assigned, delegated or otherwise disposed of by the Consultant without the prior written consent of the Company.

Law

9. This Agreement shall be governed in all respects by and construed in accordance with the laws of Canada without regard to conflicts of law provisions. Any litigation between the parties shall be conducted in the province of Ontario, Canada.

Complete Agreement

10. This Agreement constitutes the entire and final agreement and supersedes all prior and contemporaneous agreements, representations, warranties and understandings of the parties, whether oral, written or implied. The inclusion of this provision has been a material inducement for each of the parties to enter into this Agreement.

The parties have executed this Agreement effective as of the day and year first above written.
