

**MDK ACQUISITION INC. CLOSSES INITIAL PUBLIC OFFERING
LED BY HAYWOOD SECURITIES INC. AND LISTS ON THE TSX VENTURE EXCHANGE**

Vancouver, British Columbia, June 28, 2023 – MDK Acquisition Inc. (the “**Company**”) (TSXV:MDK), a capital pool company, is pleased to announce that it has completed its initial public offering (the “**Offering**”). The Company issued an aggregate of 2,000,000 common shares in its authorized share structure (each, a “**Common Share**”) to purchasers in British Columbia, Ontario and Alberta at a purchase price of \$0.10 per Common Share for gross proceeds to the Company of \$200,000. Following the closing of the Offering, a total of 6,210,001 Common Shares are issued and outstanding, of which 4,210,001 are currently held in escrow pursuant to the policies of the TSX Venture Exchange (the “**Exchange**”).

The Company is a capital pool company within the meaning of the policies of the Exchange. The Company has not commenced operations and has no assets other than cash. The net proceeds of the Offering, together with the proceeds from prior sales of Common Shares, will be used by the Company to identify and evaluate assets or businesses for acquisition with a view to completing a “Qualifying Transaction” under the Exchange’s capital pool company program. Except as otherwise allowed under the policies of the Exchange, the Company will not carry on any other business.

Haywood Securities Inc. (“**Haywood**”) acted as agent for the Offering. In connection with the Offering and pursuant to the Agency Agreement dated April 14, 2023 the Company granted to Haywood, and its selling group, non-transferable warrants to acquire up to an aggregate of 200,000 Common Shares (the “**Agent’s Warrants**”). Each Agent’s Warrant is exercisable to acquire one Common Share at a price of \$0.10 per Common Share for a period of five years following the date that the Common Shares are listed on the Exchange. In connection with the Offering, Haywood also received a cash commission of \$20,000, representing 10% of the aggregate gross proceeds of the Offering, a corporate finance fee in cash of \$10,000 plus GST, and was reimbursed for its legal fees and reasonable expenses.

The current directors and officers of the Company are: David L. King – Chief Executive Officer, Corporate Secretary and Director; Hani Zabaneh - Chief Financial Officer and Director; John Burdiga – Director; Justin Isaacs – Director; and Robert Barlow – Director.

The Common Shares were listed on the Exchange on June 28, 2023 and immediately halted pending closing of the Offering. The Common Shares are expected to commence trading on the Exchange on June 30, 2023 under the trading symbol “MDK”.
