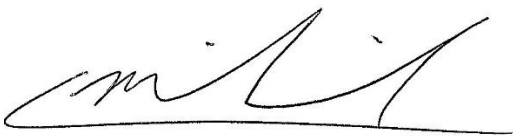
REQUEST FOR TRADING HALT - MATADOR MINING LIMITED (ASX: MZZ)

Pursuant to ASX Listing Rule 17.1, Matador Mining Limited (ASX: MZZ) (“**Matador**” or the “**Company**”) requests an immediate trading halt on its securities out of an abundance of caution related to the remediation of a government clerical error relating to the status of a few of Matador’s tenements in Newfoundland. The government was notified of their error and are in the process of correcting it.

The Company requests that the trading halt be lifted on the earlier of commencement of normal trading on Monday, 29 January 2024 or when the anticipated announcement is released to the market.

The Company is not aware of any reason why the trading halt should not be granted or of any other information necessary to inform the market about the trading halt.
