SHARE PURCHASE PLAN

The Directors advise that the Company's offer to shareholders under the Share Purchase Plan (SPP) announced on 7 February 2003 closed on 19 March 2003 with the receipt of \$465,000.

The issue price of the shares under the terms of the SPP is 95% of the average market price of the Company's shares on ASX in the five trading days up to the close of applications. This has been calculated to be 32.7 cents per share. Consequently 1,421,970 shares have been allotted at an issue price of 32.7 cents per share to acceptors of the issue.
