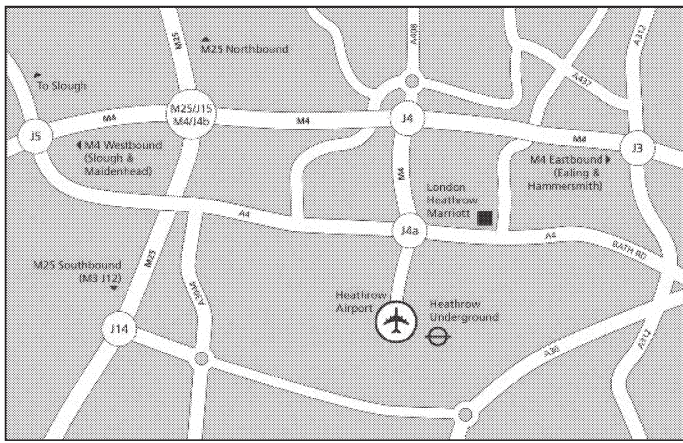

### Explanatory Notes:

- Every holder has the right to appoint some other person(s) of their choice, who need not be a shareholder, as his proxy to exercise all or any of his rights, to attend, speak and vote on their behalf at the meeting. If you wish to appoint a person other than the Chairman, please insert the name of your chosen proxy holder in the space provided (see reverse). If the proxy is being appointed in relation to less than your full voting entitlement, please enter in the box next to the proxy holder's name (see reverse) the number of shares in relation to which they are authorised to act as your proxy. Changes to entries on the Register of Members after that time shall be disregarded in determining the rights of any person to attend and vote at the meeting.
- To appoint one or more proxies or to give an instruction to a proxy (whether previously appointed or otherwise) via the CREST system, CREST messages must be received by the issuer's agent (ID number 3RA50) not later than 48 hours before the time appointed for holding the meeting. For this purpose, the time of receipt will be taken to be the time (as determined by the timestamp generated by the CREST system) from which the issuer's agent is able to retrieve the message. The Company may treat as invalid a proxy appointment sent by CREST in the circumstances set out in Regulation 35(5)(a) of the Uncertificated Securities Regulations 2001.

**How to find us**

**Directions from M25 (East)**

1. Exit the M25 at Junction 15 onto the M4 following signs to Heathrow Terminals 1 and 3.
2. Exit M4 at Junction 4 and follow signs to Terminals 1 and 3 onto the M4 spur road. Keep in the left hand lane and exit M4 spur road onto A4 following signs to central London.
3. The hotel is located approximately 1/2 a mile on the left hand side.

**Directions from London (East)**

Follow instructions as above from Point 2.

**From Heathrow Airport**

A Heathrow Hotel "Hoppa Bus" operates between Heathrow Airport and the Hotel for a nominal charge. Bus H3 runs every 20 minutes between Terminals 2 and 3 and Bus H53 runs every 30 minutes between Terminals 4 and 5.

**By London Underground or by train**

Take the Piccadilly Line on the Underground or the Heathrow Express Train from London Paddington Station to Terminals 2 and 3 and take the "Hoppa Bus" H3 as above. Alternatively, the Underground runs to Hatton Cross Station where you can take one of three complimentary buses (285, 555 and 557) to Bath Road.
