I am pleased to announce to the Company's Annual General Meeting, which will be held at the offices of Deutsche Numis, 45 Gresham Street, London EC2V 7BF on 13 June 2024 at 9:30am.

The notice of the 2024 Annual General Meeting (the '**AGM**') is set out on pages 3 and 4 of this document (the '**Notice**'). A copy of the Annual Report and Accounts for the year ended 31 December 2023 (the '**2023 Annual Report**') is available at www.mearsgroup.co.uk and a form of proxy is enclosed to enable you to exercise your voting rights.

The purpose of the AGM is to seek shareholders' approval for the resolutions set out in the Notice (the '**Resolutions**'). It is also an opportunity for shareholders to express their views and to ask questions of the Directors of the Company (the '**Board**'). We, as your Board, are committed to open dialogue with our shareholders and our AGM is an excellent means to engage with you directly.

Welcoming you to the meeting

We are delighted to welcome shareholders to join our AGM and we hope that shareholders will take up the opportunity to join the meeting and look forward to seeing you.

If you are not attending the meeting, the Board strongly encourages you to exercise your right to vote by appointing the Chairman of the AGM as your proxy to exercise your right to vote at the AGM in accordance with your instructions. To appoint a proxy, please complete the enclosed form of proxy and send it to our registrars, Computershare Investor Services PLC. CREST members who wish to appoint a proxy or proxies for the AGM (and any adjournment(s) thereof) through the CREST electronic proxy appointment service may do so by using the procedures described in the CREST Manual.

Proxy appointments must be received by Computershare Investor Services PLC no later than 9:30am on 11 June 2024.

We, as your Board, are committed to open dialogue with our shareholders. Your Board remains very mindful of ensuring that shareholders have an opportunity to engage with them and so shareholders who are unable to attend the meeting are encouraged to submit questions in advance of the AGM or raise matters of concern as a shareholder by emailing Company.Secretary@mearsgroup.co.uk with the subject line 'AGM 2024' before 9:30am on 11 June 2024. Answers to questions that are of common interest will be published on the Group's website.

In line with best corporate governance, voting on the Resolutions will be conducted by way of a poll. The Company considers a poll is more representative of shareholders' voting intentions because votes are counted according to the number of shares held and all votes tendered are taken into account.

Directors

Biographical details of the Directors seeking election and re-election are details in full in Appendix 1 to this Notice of Meeting. Membership of the principal Board committees is set out on pages 56 and 57 of the 2023 Annual Report and Accounts. Information on remuneration is set out in the Directors' Remuneration Report for the financial year ended 31 December 2023 (which is contained in pages 87 to 96 of the 2023 Annual Report).

The end of 2023 saw the completion of the transition of the CEO role from David Miles to Lucas Critchley. David stepped down from the Board on 31 December 2023. The Board is pleased with this smooth transition. David has remained a key member of the senior management team and has committed to continue to provide support to the business over the medium term with particular focus on key client engagement, operational support and driving commercial performance.

The Group's Employee Director, Hema Nar, elected for her position to become a non-statutory appointment and resigned from the Board on 14 December 2023. This has enabled Hema to solely focus on being an effective link between the Board and the Workforce. Hema will continue to attend and present at every Board meeting, and the change to a non-statutory position will not dilute the importance or significance of the role.

Nick Wharton was appointed as a Non-Executive Director and Chair of Audit and Risk Committee on 14 December 2023 and will seek election at the AGM.

Electronic communications

The Company actively encourages all shareholders to register for the electronic communications service.

Recommendation

In the opinion of the Directors, each of the Resolutions is in the best interests of the Company and shareholders as a whole. Accordingly, the Directors recommend that shareholders vote in favour of the Resolutions at the AGM, as the Directors intend to do in respect of their own beneficial holdings of ordinary shares, which amount to approximately 0.3% of the issued ordinary shares of the Company.

Resolution 13. such authority to expire on the date of the next annual general meeting of the Company, or, if earlier, 6:00pm on 12 September 2025 (unless previously renewed, varied or revoked by the Company at a general meeting) save that the Company may before such expiry make an offer or agreement which would or might require equity securities to be allotted after such expiry and the Board may allot equity securities in pursuance of such an offer or agreement as if the authority conferred hereby had not expired.

Resolution 14. THAT the Company be generally and unconditionally authorised for the purposes of Section 701 of the Act to make market purchases (as defined in Section 693(4) of the Act) of ordinary shares with nominal value of 1p each in the Company on such terms and in such manner as the Directors may determine, provided that:

- (a) the Company does not purchase under this authority more than 9,684,776 ordinary shares;
- (b) the Company does not pay less than 1p (exclusive of expenses) for each ordinary share;

- (e) the Company may make a contract to purchase its own ordinary shares under the authority conferred by this Resolution prior to the expiry of such authority, and such contract will or may be executed wholly or partly after the expiry of such authority, and the Company may make a purchase of its own ordinary shares in pursuance of any such contract.

Explanatory notes to the Resolutions

Resolution 1

The Directors are required by law to present to the meeting the audited accounts and the Directors' and the Auditor's Reports for the year ended 31 December 2023.

Resolution 2

In accordance with Section 439 of the Act, the Company is required to seek the approval of shareholders for its annual report on remuneration. This report gives details of the Directors' remuneration for the financial year ended 31 December 2023 and is set out in full on pages 87 to 96 of the 2023 Annual Report. The vote on the annual report on remuneration is advisory in nature.

Resolutions 3 and 4

The current appointment of Ernst & Young LLP as auditor will end at the conclusion of the AGM. An extensive tender process was overseen by the Audit Committee during the year which recommended the selection of PwC. This was approved by the Board and the Directors are recommending the appointment of PwC as auditor.

As required by Section 519 of the Act, the retiring auditors, Ernst & Young LLP, have provided a statement of circumstances which the Company is required to distribute to members under Section 520 of the Act and which is set out at Appendix 2 to this Notice.

It is normal practice for a company's directors to be authorised to agree how much the auditors should be paid, and Resolution 4 grants this authority to the Directors.

Resolution 5

Final dividends must be approved by shareholders but must not exceed the amount recommended by Directors. If the meeting approves Resolution 5, the final dividend in respect of the financial year ended 31 December 2023 of 9.30p per share will be paid on 16 July 2024 to ordinary shareholders who are on the Register of Members on 28 June 2024 in respect of each ordinary share.

Resolutions 6 to 11

In accordance with the UK Corporate Governance Code and the Company's Articles of Association, all of the Directors will seek election or re-election at the AGM. Each Director will be proposed for election or re-election by a separate resolution.

Nick Wharton will each seek election as Director following his appointment to the Board on 14 December 2023.

The Executive Directors bring a wide range of experience to contribute to the long-term sustainable success of the Company. Lucas Critchley brings experience of the industry gained during his tenure at Mears; Andrew Smith brings a wealth of financial experience.

The Non-Executive Directors possess a good mix of sector experience, business acumen and financial experience and they provide active contributions to Board discussions contributing to the long-term success of the Company. Jim Clarke brings experience from an extensive career in senior finance roles in consumer-facing industries. Julia Unwin brings significant experience in both the housing and care sectors to the Board. Angela Lockwood brings experience from a career in housing spanning nearly 30 years. Nick Wharton has extensive finance and corporate governance experience gained, both in the UK and internationally, through executive and non-executive positions in consumer companies under both public and private equity ownership. Julia Unwin's tenure as a Non-Executive Director will reach nine years in December 2024, and it is her intention to step down at that point.

The Board is satisfied that all of the Non-Executive Directors are independent in character and there are no relationships or circumstances that are likely to affect their independence. The performance of the Board as a whole, as well as the contribution made by individual Directors, has been reviewed during the course of the year. After considering this evaluation, and the combined expertise and experience of the Directors, the Chairman has confirmed that the performance of every Director continues to be effective, that they continue to demonstrate commitment to their respective roles, that their respective skills complement one another to enhance the overall operation of the Board and that their contribution is, and continues to be, important to the Company's long-term sustainable success. Biographical details of the Directors seeking election are included in Appendix 1 to this Notice.

Resolution 12

The authority sought by this Resolution is for the Directors to be authorised to allot ordinary shares comprising up to a total aggregate nominal amount of £645,650. This represents approximately two thirds of the issued share capital as at 17 April 2024 (being the latest practicable date prior to the posting of this Notice). This is within the guidelines issued by the Investment Association in that it is considered routine and standard practice for a listed company to seek authorisation to allot up to two thirds of its existing issued share capital. However, the additional one third may only be applied to fully pre-emptive offer and the authorisation must only be valid until the next annual general meeting. The Directors will therefore be seeking annual renewal of this authority in accordance with best practice and to ensure the Company has maximum flexibility in managing its capital resources. This authority will expire at the next annual general meeting, or, if earlier, at 6:00pm on 12 September 2025.

The Directors have no present intention of exercising this authority. However, the Directors consider it appropriate to maintain the flexibility that this authority provides. It is intended to renew this authority at successive annual general meetings.

As at 17 April 2024 (being the latest practicable date prior to the posting of this Notice), no shares are held by the Company in treasury.

Explanatory notes to the Resolutions continued

Resolution 13

When shares are to be allotted for cash, Section 561 of the Act provides that existing shareholders have pre-emption rights and that any new shares are offered first to such shareholders in proportion to their existing shareholdings. There may be occasions, however, when the Board needs the flexibility to finance business opportunities by the issue of ordinary shares without a pre-emptive offer. Resolution 13 would give the Directors that authority.

The authority under Resolution 13 would be limited to:

- (a) allotments or sales in connection with pre-emptive offers and offers to holders of other equity securities if required by the rights of those shares or as the Board considers necessary; and
- (b) allotments or sales (otherwise than pursuant to (a)) up to an aggregate nominal amount of £48,423, which represents approximately 5% of the Company's issued ordinary share capital as at 17 April 2024 (being the latest practicable date prior to the publication of this Notice).

The disapplication authority under Resolution 13 is in line with the authority sought at the Annual General Meeting last year.

The Pre-Emption Group's Statement of Principles was revised in November 2022 (the '**Pre-Emption Principles**') to allow companies to seek authority for an issue of shares for cash otherwise than in connection with a pre-emptive offer to include: (i) an authority up to 10% of a company's issued share capital for use on an unrestricted basis; and (ii) an additional authority up to a further 10% of a company's issued share capital for use in connection with an acquisition of specified capital investment announced contemporaneously with the issue, or that has taken place in the 12-month period preceding the announcement of the issue. In both cases, an additional authority of up to 2% may be sought for the purposes of making a follow-on offer.

Having considered the revised Pre-Emption Principles, the Board considers that, for the time being, it is in the best interests of shareholders to adopt them but to retain the threshold for the general disapplication of pre-emption rights at 5%, the amount previously recommended under the 2015 Pre-emption Group Statement of Principles. The Board continues not to seek additional authority to disapply pre-emption rights specifically for the purposes of financing a transaction or other capital investment.

The Directors have no present intention of exercising this authority. However, the Directors consider it appropriate to maintain the flexibility that this authority provides. It is intended to renew this authority at successive annual general meetings.

The Directors confirm that, in considering the exercise of the authority under Resolution 13, they intend to follow the shareholder protections set out in Part 2B of the Pre-Emption Principles to the extent relevant and reasonably practicable.

The authority contained in Resolution 13 will expire at the next annual general meeting, or, if earlier, at 6.00pm on 12 September 2025.

Resolution 14

Share buybacks are a way of returning cash to shareholders. The Directors will exercise this authority only when to do so would be in the best interests of the Company and of its shareholders generally and could be expected to result in an increase in earnings per share of the Company.

Shares that are purchased by the Company must either be cancelled or held in treasury. Once shares are held in treasury, the Directors may only dispose of them in accordance with the relevant legislation by:

- (a) selling the shares (or any of them) for cash;
- (b) transferring the shares (or any of them) for the purposes of, or pursuant to, an employee share scheme; or
- (c) cancelling the shares (or any of them).

The Directors' intention is to cancel any shares purchased pursuant to this authority.

As shareholders will be aware, the Company has undertaken a series of buyback programmes since the last Annual General Meeting. The current buyback programme is being undertaken pursuant to the authority given at the general meeting held on 24 February 2024 and such authority will expire at the conclusion of the Annual General Meeting.

The directors will exercise the authority conferred pursuant to this resolution only when to do so would be in the best interests of shareholders generally.

Authority is sought in Resolution 14 to purchase up to 10% of the issued ordinary share capital of the Company (excluding treasury shares). Resolution 14 specifies the maximum number of shares that may be purchased and the minimum and maximum prices at which they may be bought.

For information, as at 17 April 2024, there were options outstanding over 5,645,394 ordinary shares, representing 5.8% of the Company's issued ordinary share capital. If the authority given by Resolution 14 were to be fully used, the options would then represent 6.5% of the Company's issued ordinary share capital. The Company has no treasury shares and no warrants are in issue in relation to its shares.

The authorities contained in Resolution 14 will expire at the next annual general meeting, or, if earlier, at 6:00pm on 12 September 2025.

Resolution 15

Section 307A of the Act provides that listed companies must hold general meetings (other than annual general meetings) on 21 days' notice unless the members of that company pass a special resolution agreeing to a shorter notice period which cannot be any less than 14 clear days. It is therefore necessary for the Company to pass this Resolution allowing the Company to continue to hold general meetings (other than annual general meetings) on not less than 14 clear days' notice.

The Directors confirm that the shorter notice period would not be used as a matter of routine but only where flexibility is merited by the business of the meeting, the proposals are time-sensitive and it is thought to be to the advantage of shareholders as a whole. The approval will be effective until the Company's next annual general meeting, when it is intended that a similar resolution will be proposed.

Notes

Proxy appointments

1. As a member of the Company, you are entitled to appoint one or more proxies to exercise all or any of your rights to attend, speak and vote at the AGM and you should have received a form of proxy with this Notice of AGM. You can only appoint a proxy using the procedures set out in these notes and the notes to the form of proxy. Appointment of a proxy does not preclude you from attending the AGM and voting in person.
2. A proxy does not need to be a member of the Company. If you wish your proxy to speak on your behalf at the AGM, you will need to appoint your own choice of proxy (not the Chairman) and give your instructions directly to them.
3. To appoint a proxy using the form of proxy, the form must be: (i) completed and signed; (ii) sent or delivered to the Company's registrars, Computershare Investor Services PLC, The Pavilions, Bridgwater Road, Bristol BS13 8AE; and (iii) received by the Company's registrars no later than 9:30am on 11 June 2024.
4. You may terminate a proxy instruction but to do so you will need to inform the Company in writing by sending a signed hard copy notice clearly stating your intention to revoke your proxy appointment to the Company's registrars. The notice must be received by the Company's registrars no later than the cut-off time for the receipt of proxy appointments.
5. Shareholders may change proxy instructions by submitting a new proxy appointment using the methods set out above. Please note that the cut-off time for receipt of proxy appointments (see above) also applies in relation to amended instructions. Any amended proxy appointment received after the relevant cut-off time will be disregarded. Where you have appointed a proxy using the form of proxy enclosed with this Notice and would like to change the instructions using another hard copy form of proxy, please contact Computershare Investor Services PLC. If you submit more than one valid proxy appointment, the appointment received last before the latest time for the receipt of proxies will take precedence.
6. Any power of attorney or any other authority under which the form of proxy is signed (or a duly certified copy of such power or authority) must be included with the form of proxy.
7. CREST members who wish to appoint a proxy or proxies through the CREST electronic proxy appointment service may do so for the AGM and any adjournment(s) thereof by using the procedures described in the CREST Manual. CREST personal members or other CREST sponsored members, and those CREST members who have appointed a voting service provider(s), should refer to their CREST sponsor or voting service provider(s), who will be able to take the appropriate action on their behalf.
8. In order for a proxy appointment or instruction made using the CREST service to be valid, the appropriate CREST message (a '**CREST Proxy Instruction**') must be properly authenticated in accordance with Euroclear UK & International Limited's specifications, must contain the information required for such instructions, as described in the CREST Manual, and must be transmitted so as to be received by the Company's agent, Computershare Investor Services PLC (ID: 3RA50) by 9:30am on 11 June 2024 (or at such later time as the Chairman shall determine in his absolute discretion). CREST members and, where applicable, their CREST sponsors or voting service providers should note that Euroclear UK & International Limited does not make available special procedures in CREST for any particular messages. Normal system timings and limitations will therefore apply in relation to the input of CREST Proxy Instructions. CREST members who wish to appoint a proxy or proxies by utilising the CREST electronic proxy appointment service may do so for the meeting and any adjournments of it by using the procedures described in the CREST Manual (available from www.euroclear.com). The Company may treat as invalid a CREST Proxy Instruction in the circumstances set out in Regulation 35(5) (a) of the Uncertificated Securities Regulations 2001 (as amended).
9. In the case of joint holders, where more than one of the joint holders purports to appoint a proxy, only the appointment submitted by the most senior holder will be accepted. Seniority is determined by the order in which the names of the joint holders appear in the Company's Register of Members in respect of the joint holding (the first-named being the most senior).

Entitlement to attend and vote

10. Pursuant to Regulation 41(1) of the Uncertificated Securities Regulations 2001 (2001 No. 3755), the Company has specified that only those members registered on the Register of Members of the Company at 6:00pm on 11 June 2024 shall be entitled to attend and vote at the AGM in respect of the number of ordinary shares registered in their name at that time. Changes to the Register of Members after that time shall be disregarded in determining the rights of any person to attend and vote at the AGM.

Documents on display

11. Copies of the Non-Executive Directors' letters of appointment will be available for inspection at the Company's registered office during normal business hours from the date of this Notice to the date of the AGM and at the location of the AGM for 15 minutes prior to and during the AGM.

Other information

12. Information regarding the meeting, including a copy of this Notice and the information required by Section 311A of the Companies Act 2006 (the 'Act'), is available from www.mearsgroup.co.uk.

Communication

13. Any electronic address provided either in this Notice or any related documents (including the form of proxy) may only be used for the limited purposes specified herein and not to communicate with the Company by electronic means or for any other more general purpose.
14. Except as provided above, shareholders who have general enquiries about the AGM should call our shareholder helpline on +44 (0)370 889 3192 (calls to this number are charged at the standard rate per minute plus network extras and lines are open from 8:30am to 5:30pm (GMT) Monday to Friday, excluding UK public holidays). No other methods of communication will be accepted.

Information rights

15. Under the Act, there are a number of rights that may be available to indirect investors of Mears Group PLC, including the right to be nominated by the registered holder to receive general shareholder communications direct from the Company.
16. The rights of indirect investors who have been nominated to receive communications from the Company in accordance with Section 146 of the Act (nominated persons) do not include the right to appoint a proxy. However, nominated persons may have a right under an agreement with the registered shareholder who holds the shares on their behalf to be appointed (or to have someone else appointed) as a proxy. Alternatively, if nominated persons do not have such a right or do not wish to exercise it, they may have a right under such an agreement to give instructions to the person holding the shares as to the exercise of voting rights.
17. If you have been so nominated to receive general shareholder communications direct from Mears Group PLC, it is important to remember that your main contact in terms of your investment remains with the registered shareholder or custodian or broker, or whoever administers the investment on your behalf. You should also deal with them in relation to any rights that you may have under agreements with them to be appointed as a proxy and to attend, participate in, and vote at the meeting, as described above.
18. Any changes or queries relating to your personal details and holding (including any administration thereof) must continue to be directed to your existing contact at your investment manager or custodian. Mears Group PLC cannot guarantee dealing with matters that are directed to us in error. The only exception to this is where Mears Group PLC is exercising one of its powers under the Act and writes to you directly for a response.

Right to ask questions

19. Under Section 319A of the Act, any member attending the AGM has the right to ask questions at the AGM relating to the business of the AGM. The Company must cause to be answered any such question relating to the business being dealt with at the AGM but no such answer need be given if (a) to do so would interfere unduly with the preparation for the AGM or involve the disclosure of confidential information, (b) the answer has already been given on a website in the form of an answer to a question, or (c) it is undesirable in the interests of the Company or the good order of the AGM that the question be answered. Shareholders may also submit questions in advance of the AGM or raise matters of concern as a shareholder by emailing Company.Secretary@mearsgroup.co.uk with the subject line 'AGM 2024' before 9:30am on 11 June 2024.

Members' power to influence AGM agenda

20. Under Section 338 of the Act, members meeting the threshold requirements set out in that Section have the right to require the Company to give notice of a resolution which may properly be moved at the AGM. Any such request, which must comply with Section 338(4) of the Act, must be received by the Company no later than 6 weeks before the date fixed for the AGM.
21. Under section 338A of the Act, members meeting the threshold requirements set out in that Section have the right to require the Company to include a matter (other than a proposed resolution) in the business to be dealt with at the AGM. Any such request, which must comply with Section 338A(4) of the Act, must be received by the Company no later than six weeks before the date fixed for the AGM.

Statements related to the audit

22. Members satisfying the thresholds in Section 527 of the Act can require the Company to publish a statement on its website setting out any matter relating to: (i) the audit of the Company's accounts (including the Auditor's Report and the conduct of the audit) that are to be laid before the meeting; or (ii) any circumstances connected with an auditor of the Company ceasing to hold office since the last AGM that the members propose to raise at the meeting. The Company cannot require the members requesting the publication to pay its expenses in connection with the publication. The Company must forward a copy of the statement to the auditor when it publishes the statement on the website. The business which may be dealt with at the meeting includes any such statement that the Company has been required to publish on its website.

Automatic poll voting

23. Each of the Resolutions to be put to the meeting will be voted on by poll and not by show of hands. A poll reflects the number of voting rights exercisable by each member and so the Board considers it a more democratic method of voting, which is also in line with best corporate governance practice. Proxies and members will be asked to complete a poll card to indicate how they wish to cast their votes. These cards will be collected at the end of the meeting. The results of the poll will be published on the Company's website and notified to the market once the votes have been counted and verified.

Conduct at the AGM

24. Unacceptable behaviour will not be tolerated at the AGM and it will be dealt with appropriately by the Chairman.

Total voting rights and share capital

25. As at 6:00pm on 17 April 2024 (being the latest practicable date prior to the printing of this Notice) the Company's issued share capital consists of 96,847,757 ordinary shares of 1p, carrying one vote each. Therefore, the total voting rights in the Company as at 17 April 2024 are 96,847,757.
