CORPORATE STRUCTURE

Orion Gold NL is a no liability company that is incorporated and domiciled in Australia. The Company has prepared a consolidated financial report incorporating the entity that it controlled during the financial year, being the wholly-owned subsidiary Goldstar Resources (WA) Pty Ltd (together the "Group").

NATURE OF OPERATIONS AND PRINCIPAL ACTIVITIES

The principal activity of the Group during the year was the exploration and evaluation of the Walhalla Gold Project in Victoria. The Group also has exploration tenements in Queensland.

REVIEW OF OPERATIONS**Corporate**

The appointment of administrators in January 2009 was a major setback for the Company, however, following the successful outcome of the Deed of Company Arrangement process which included a capital raising of approximately \$10.6 million and the reinstatement of the Company's shares to the Australian Securities Exchange in July 2009, the Company was well placed to progress exploration on its highly prospective Walhalla Gold Project tenement package.

The Group recorded a loss of \$14.1 million after tax for the full-year ended 30 June 2010. This compares to a loss of \$32.6 million after tax for the previous year. Net cash used in operating activities totalled \$4.5 million for the year. Cash on hand at the end of the year was \$5.1 million.

The Group continues to focus strongly on exploration within its Walhalla Gold Project and to a lesser extent on the surrounding exploration licences. A total of \$3.1 million in exploration expenditure was incurred in the year ended 30 June 2010.

During the year ended 30 June 2010, Orion Gold NL under the terms of the converting loan agreement with Silja Investment Limited, incurred an interest expense of \$0.6 million and interest unwinding expense of \$1.1 million.

Walhalla Gold Project

During the December 2009 half, the Company continued with a review of geological data and historical mining records relating to the Walhalla Gold Project tenement area. Based upon this review, the Board of Directors adopted a two part strategic plan:

1. Complete a more detailed technical review of all data relating to the highly prospective Walhalla Gold Project and determine priority targets to be drill tested.
2. Progress a pre-feasibility study on the current gold resources within the Walhalla Gold Project.

Based on the Company's strategic plan, a diamond drill program commenced in November 2009 with the following objectives:

1. test potential extensions of Cohen's Reef;
2. confirm the continuity of mineralisation along the West 1 trend; and
3. test targets along the West 2 trend.

The program, which is continuing, aims to illustrate the continuity of mineralisation along the Cohen's Line and parallel structures leading to the development of high grade near surface mineral resources based upon continuous, planar, laminated reef mineralisation.

To date, the drilling program has achieved its objectives through:

1. establishing that the quartz reefs in West 1 continue northwards;
2. the intersection of the Cohen's Reef system north of the existing workings; and
3. the intersection at Happy Go Lucky of a pyrite-gold system associated with a major structure, in a near-surface position that has largely been unexploited by previous mining.

Drilling is continuing at Happy Go Lucky, with the aim of further delineating the extent of the mineralised system and to provide further information of the geological and structural setting.

Subject to further interpretation and geological assessment, the Company intends to complete two additional holes at Cohen's designed to locate high grade zones within the inferred up-plunge shoot further to the north. The holes are planned to commence in November 2010 after the cessation of the Winter Closure period.

The principal aim of the initial holes of the West 1 program was to determine whether the identified structures continue along strike and at depth and are auriferous. Additional assessment will be undertaken before a decision is made on further drill testing of the West 1 line of mineralisation.

The Company also undertook an initial geological assessment of the Walhalla Gold Project regional exploration area during the June 2009 year and continued with a more detailed assessment during 2010. This assessment led to the identification of numerous regional targets with a priority area of interest being the historic Toombon and New Dawn workings.

The exploration priority of the Company continues to be to drill test targets in the Cohen's and Happy Go Lucky areas. In addition to the drill programs, the Company has continued with components of a pre-feasibility study on the Tubal Cain deposit. This work will assist in determining the economics of the deposit and what future work should be undertaken by the Company.

Other Projects

During the year, the Company focussed its exploration programs on the Walhalla Gold Project given the high prospectivity of the Walhalla gold field and the significant historical gold production from mines located within the Company's Walhalla tenements.

The Company has however previously identified a number of areas of interest within the more regional component of the Walhalla Gold Project.

A priority area of interest is the historic Toombon and New Dawn workings. The Company has designed a drilling program to test for extensions of the mineralisation below the historical workings, and continuity of the reef between the workings. The program is planned to commence in early 2011.

With the changes to the Board of Directors and senior management and the resultant review of all projects, during the year the Company reduced its interest in tenement holdings outside of the Walhalla Gold Project.

Outlook

Exploration continues to produce encouraging results as evidenced from the Company's Australian Securities Exchange announcements regarding the drilling at Cohen's, West 1 and Happy Go Lucky. The Company will continue to focus on exploration activities at the Walhalla Gold Project and intends to follow up the many prospective target areas on the more regional exploration licenses such as Toombon.

RESULTS OF OPERATIONS

The operating loss after income tax of the Group for the year ended 30 June 2010 was \$14,145,490 (2009: \$32,640,346). The result is driven primarily by the revaluation of the convertible note.

The basic and diluted loss per share for the Group for the year was 1.86 cents (2009: 18.73 cents).

No dividend has been paid during or is recommended for the financial year ended 30 June 2010.

SIGNIFICANT EVENTS AFTER THE BALANCE DATE

There has not arisen in the interval between the end of the financial year and the date of this report any item, transaction or event of a material and unusual nature likely, in the opinion of the directors of the Company, to affect the operations of the consolidated entity, the results of those operations or the state of affairs of the consolidated entity in subsequent financial years except for those matters referred to below:

- a) On 22 September 2010, 300,000,000 options held by Silja Investment Limited with an exercise price of \$0.01, expired without having being exercised;
- b) On 29 September 2010, the Company renegotiated the terms of the converting loan agreement which will now enable the Company at its election, to convert or redeem the remaining convertible notes at maturity;
- c) On 13 September 2010, the Company issued 640,000 performance rights to employees; and
- d) On 13 September 2010, the Company issued 2,000,000 options to Sean Cahoon, an employee of the Company.

FUTURE DEVELOPMENTS

Likely future developments in the operations of the Group are referred to elsewhere in the Annual Financial Report. Other than as referred to in this report, further information as to the likely developments in the operations of the Group and expected results of those operations would, in the opinion of the directors, be speculative and prejudicial to the interests of the Group and its shareholders.

Key management personnel have authority and responsibility for planning, directing and controlling the activities of the Company and the Group. Key management personnel comprise the directors of the Company and executives for the Company and the Group including the five most highly remunerated Company and Group executives.

It is the Company's objective to provide maximum stakeholder benefit from the retention of a high quality Board and management by remunerating directors and executives fairly and appropriately with reference to relevant employment and market conditions. To assist in achieving the objective the Board links the nature and amount of Executive directors' emoluments to the Company's financial and operational performance.

The expected outcome of the Company's remuneration structure is:

- Retention and motivation of directors and executives; and
- Performance rewards to allow directors and executives to participate in the future success of the Group.

Remuneration may include base salary & fees, short term incentives, superannuation contributions and long term incentives. Any equity based remuneration for directors will only be made with the prior approval of shareholders at a general meeting.

The Board of directors is responsible for determining and reviewing compensation arrangements for the executive and non-executive directors. The maximum remuneration of non-executive directors is the subject of shareholder resolution in accordance with the Company's Constitution, and the Corporations Law as applicable.

The total level of remuneration for all non-executive directors of \$100,000 is maintained within the maximum limit of \$350,000 approved by shareholders. When setting fees and other compensation for non-executive directors, the Board may seek independent advice and apply Australian benchmarks. The Board may recommend additional remuneration to non-executive directors called upon to perform extra services or make special exertions on behalf of the Company.

There is no scheme to provide retirement benefits, other than statutory superannuation, to non-executive directors.

The Chairman will undertake an annual assessment of the performance of the individual directors and meet privately with each director to discuss this assessment. Position descriptions are in place for directors and executives and will be used as a basis for assessing performance.

Long Term Incentive Based Remuneration

The Company has an option and performance rights based remuneration scheme for executives. In accordance with the provisions of the Orion Gold Option and Performance Rights Plan, as approved by shareholders at a general meeting, executives may be granted options or performance rights to purchase ordinary shares. The number and terms of options or performance rights granted is at the absolute discretion of the Board, provided that the total number of options on issue under the scheme at the time of the grant does not exceed 5% of the number of ordinary shares on issue.

Shareholder consent must be obtained at a general meeting for the issue of options to directors.

The issue of options to directors and employees encourages the alignment of personal and shareholder interests.

Service contracts

Existing service contracts for key management personnel, including the chief executive officer (or equivalent) and company secretary, are unlimited in term but capable of termination on 1 months' notice (company secretary 3 months') and that the Group retains the right to terminate the contract immediately, by making that payment in lieu of notice.

Key management personnel are also entitled to receive on termination of employment, redundancy benefits, their statutory entitlements of accrued annual and long service leave, together with any superannuation benefits.

The service contract outlines the components of compensation paid to the key management personnel but does not prescribe how compensation levels are modified year to year. Compensation levels are reviewed each year to take into account cost-of-living changes, any change in the scope of the role performed by the senior executive and any changes required to meet the principles of the compensation policy.

Directors

Total compensation for all non-exec directors fees, last voted upon by shareholders at the 2007 Annual General Meeting, is not to exceed \$350,000 per annum and is set based on advice from external advisors with reference to fees paid to other directors of comparable companies. Non exec directors' base fees are presently \$100,000 per annum.

The Executive Chairman receives \$75,000 per annum. Non-executive directors do not receive performance related compensation. Directors' fees cover all main board activities and membership of one committee.

Directors may be paid additional amounts for consulting services provided in addition to normal director duties. Such additional amounts are paid on commercial terms.

Corporate Governance Statement

The Board of Directors of Orion Gold NL ("Orion" or "Company") is responsible for the corporate governance of the Company. The Company's corporate governance practices are set out below. These practices are generally in line with the ASX Corporate Governance Council's Recommendations, with exceptions noted in italics and cross-referenced in the table below. Further information is available in the Corporate Governance section of the Company's website [.oriongold.com](http://oriongold.com).

1. THE BOARD

The Board guides and monitors the business and affairs of the Company on behalf of the shareholders by whom they are elected and to whom they are accountable. The Board Charter is available on the website.

To ensure that the Board is well equipped to discharge its responsibilities, it has established guidelines for the nomination and selection of directors and for the operation of the Board.

The composition of the Board is determined in accordance with the following principles and guidelines:

- the Board should comprise at least three directors, a majority of whom should be non-executive directors;
- the Board should comprise directors with an appropriate range of qualifications and expertise; and
- the Board shall meet at regular intervals and follow meeting guidelines set down to ensure all directors are made aware and have available all necessary information to participate in an informed discussion of all agenda items.

The membership of the Board, its activities and composition is subject to periodic review.

The Board considers that its current structure is appropriate given its size and that the current directors provide the necessary diversity of skills and experience which is appropriate for the Company's current projects and business.

The Company does not comply with Recommendation 2.1, as a majority of Directors are not independent; Graeme Sloan, as a non-executive director, is not considered to be independent as he has within the last three years has been employed in an executive capacity by Orion. Alexander Haller, as a non-executive director, is not considered to be independent because he is associated with Z Nominees Limited, a substantial shareholder of the Company holding more than five percent of the Company's voting shares.

The Company does not comply with Recommendations 2.2 or 2.3, as the Chairman, Denis Waddell, as Executive Chairman, is not independent and exercises the function of both Chairman and CEO. The Board considers that this is not inappropriate given his experience in the resources sector in Australia and the Company's current stage of development. It is intended to review the position of CEO as the Company develops.

The criteria for determining the identification and appointment of a suitable candidate for the Board shall include qualifications, experience and achievement, credibility within the Company's scope of activities, intellectual ability to contribute to the Board's duties and ability to undertake Board duties and responsibilities.

The Company does not comply with Recommendation 2.4, as there is no separate nomination committee. The Board considers that the current size and level of activities of the Company are not of a sufficient level to justify having a nomination committee. The whole Board conducts the functions of the nomination committee, and is guided by the charter posted on the website.

2. REMUNERATION

It is the Company's objective to provide maximum stakeholder benefit from the retention of a high quality Board and executive team by remunerating directors and key executives fairly and appropriately with reference to relevant employment market conditions. The expected outcomes of the remuneration structure are:

- Retention and motivation of key executives;
- Attraction of quality management to the Company; and
- Performance incentives which allow executives to share the rewards of the success of Orion.

For details on the amount of remuneration and all monetary and non-monetary components for all directors, refer to the Directors' Report.

In relation to the payment of bonuses, options and other incentive payments, discretion is exercised by the Board, having regard to the overall performance of Orion and the performance of the individual during the

period. A performance review for Directors and executives was conducted by the Board during the year in review.

There is no scheme to provide retirement benefits, other than statutory superannuation, to directors.

The Company does not comply with Recommendation 8.1, as there is currently no separate remuneration committee. The Board considers that the current size and level of activities of the Company are not of a sufficient level to justify having a remuneration committee. The whole Board conducts the functions of the remuneration committee and is guided by the charter posted on the website.

3. AUDIT COMMITTEE

The Audit Committee has been established by the Board. Its primary function is to assist the Board in fulfilling its responsibilities by reviewing the:

- Quality and integrity of financial reporting.
- Systems of internal control which management and the Board has established in order to safeguard the Company's financial and physical assets and facilitate compliance with relevant statutory and regulatory requirements.
- Processes for business risk identification, quantification and mitigation.
- Effectiveness and independence of the external audit process.
- Quality and relevance of financial and non-financial information provided to management and the Board on which decisions will be based.

The Audit Committee comprises Denis Waddell (Chairman), Graeme Sloan and Alexander Haller. Each member has the relevant financial and industry experience required to perform Audit Committee functions. Details their qualifications and experience is set out in the Directors' Report. The Audit Committee Charter is available on the website.

The Company does not comply with Recommendation 4.2, as Denis Waddell is the Chairman of both the Board and the Audit Committee, and is also an executive of the Company, and both non-executive directors, Graeme Sloan and Alexander Haller, are not independent. The Board considers that the current structure is appropriate given the size of the Company and the necessary skills and experience that the current Audit Committee members bring to these meetings.

4. BOARD RESPONSIBILITIES

The Board is responsible for:

- (a) driving the success of Orion in a way that ensures that the interests of shareholders and key stakeholders are properly recognised and protected;
- (b) setting the strategic direction of Orion and monitoring the performance of the Chief Executive Officer/Managing Director ("CEO/MD") and those senior executives who report to the CEO/MD;
- (c) ensuring that there are adequate resources available to meet Orion's (and the Orion Group's) business plans and strategic objectives;
- (d) appointing and where appropriate removing the CEO/MD and overseeing succession plans for the senior executives who report to the CEO/MD;
- (e) ratifying the appointment and where appropriate, the removal of the Chief Financial Officer (CFO) or equivalent and the Company Secretary;
- (f) approving conditions of service and performance monitoring procedures to apply to all executive directors and those senior executives who report to the CEO/MD;
- (g) approving policies of a company-wide nature;
- (h) approving and monitoring Orion's financial reporting, major capital expenditure and capital management;
- (i) approving and monitoring the progress of Orion's business plans and strategic objectives;
- (j) ensuring that adequate audit, risk management and compliance systems and procedures exist, and are being effectively utilised;
- (k) ensuring that Orion has appropriate corporate governance structures in place, including an ethical code of conduct;

- (l) ensuring that the Board has the appropriate blend of experience, skills and attributes to meet the changing needs of Orion.

The Board has delegated responsibility for the day-to-day operations and administration of Orion to the CEO/MD.

5. MONITORING OF THE BOARD'S PERFORMANCE

The Board will from time to time, evaluate its performance (including individual Board members) and the Board committees to determine whether they are functioning effectively by reference to their charters and current best practice.

6. ADDITIONAL INFORMATION

- The charter of the **Technical Committee** of the Board is available on the website.
- The Company has established a **Risk Management and Internal Control Policy**, which is available on the Company's website. Management reports regularly to the Board on its management of material business risks. The Board has received assurance from the CEO and CFO that the declaration for the financial report, provided in accordance with section 295A of the *Corporations Act*, is founded on a sound system of risk management and internal control and that the system is operating effectively in all material respects in relation to financial reporting risks.
- The Company has written policies and procedures on information disclosure that focus on continuous disclosure of any information concerning the Company and its controlled entities that a reasonable person would expect to have a material effect on the price of the Company's securities. The Company's **Continuous Disclosure Policy** is posted on the website. All information disclosed to ASX is immediately posted on the website and emailed to those parties who have supplied their email addresses. When analysts are briefed on aspects of the Company's operations, the material to be used in the presentation is released to ASX and posted on the website.
- The Company's **Shareholder Communication Policy** is posted on the website.
- The Company's **Securities Dealing Policy** is available on the website. It binds Directors, officers and employees of the Company and prohibits trading in the Company's securities by anyone in possession of price-sensitive information. Notes to the Financial Statements

FOR THE YEAR ENDED 30 JUNE 2010

1 CORPORATE INFORMATION

Orion Gold NL ("Company") is a company domiciled in Australia. The address of the Company's registered office is Level 11, 330 Collins Street, Melbourne, Victoria, 3000. The consolidated financial statements as at and for the year ended 30 June 2010 comprise the Company and its subsidiary (together referred to as the "Group"). The Group primarily is involved in gold exploration.

2 SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

(a) Basis of preparation

Statement of compliance

The financial report is a general purpose financial report which has been prepared in accordance with Australian Accounting Standards (AASBs) (including Australian Interpretations) adopted by the Australian Accounting Standards Board (AASB) and the Corporations Act 2001. The consolidated financial report of the Group and the financial report of the Company comply with International Financial Reporting Standards (IFRSs) and interpretations adopted by the International Accounting Standards Board (IASB). The financial statements were approved by the Board of directors on 30 September 2010.

Basis of measurement

The consolidated financial statements have been prepared on the historical cost basis except where stated.

Going concern

The Group incurred a loss of \$14,145,490 for the year ended 30 June 2010 and, as of that date, has a deficiency in shareholders' funds of \$5,743,073. The major reason for the loss and the deficiency in shareholder funds is due to the accounting treatment of the convertible note. In particular:

- The net movement in the fair value of convertible notes for the twelve month period was a loss of \$9,333,039. This unrealised loss is not a cash loss and did not affect the Group's cash reserves.
- The convertible note liability, classified as a non-current liability in the Balance Sheet, totalled \$17,928,833 at 30 June 2010. Under the terms of the agreement which existed at the balance date the maximum amount payable in cash by the Group in relation to the convertible notes is \$8,846,872 on, and not before, 31 August 2013.

At 30 June 2010, the Company has \$5,065,765 in cash on hand which will enable it to continue its exploration activities at the Walhalla Gold Project in the next twelve months from the date of this report sufficient to meet its minimum exploration commitments for the Project. Subsequent to the year end, on 22 September 2010, 300 million options held by Silja Investment Limited ("Silja") with an exercise price of \$0.01, expired. If exercised, the Group would have received \$3.0 million cash, which would have funded further exploration activities at the Walhalla Gold Project beyond the twelve-month period from the date of this report.

The financial statements for the year ended 30 June 2010 have been prepared on a going concern basis as, in the opinion of the directors, the Group will be in a position to continue to meet its operating costs and exploration expenditure for at least twelve months from the date of this report having regard to the following:

- On 29 September 2010 the Company renegotiated the terms of the convertible notes which were issued to Silja pursuant to the terms of the converting loan agreement between Silja and the Company dated 9 September 2008. The amendment will enable the Company at its election, to convert the remaining convertible notes at maturity on 31 August 2013 to ordinary shares in the Company or redeem the convertible notes for cash. This is a significant amendment to the terms of the convertible notes as it enables the Company to satisfy its obligations with respect to the notes at the maturity date without relying upon its cash reserves. The renegotiation of the convertible notes also places the Company in a stronger position to consider alternative funding. All other rights of Silja in respect of the notes remain unchanged.

Going concern (continued)

- The Board is considering alternative funding to enable the Company to continue exploration and drilling programs at the Walhalla Gold Project beyond the twelve-month period. The directors are of the opinion that they will be able to raise further capital.

However, the Directors recognise that if additional capital is not raised, the going concern basis may not be appropriate with the result that the entity may have to realise its assets and extinguish its liabilities other than in the ordinary course of business and at amounts different from those stated in the financial report. No allowance for such circumstances has been made in the financial report.

(b) New accounting standards and interpretations

Adopted

The following amendment to a standard was early adopted at 30 June 2009:

- AASB 2009-5 *Amendments to Australian Accounting Standards arising from the Annual Improvements Process*. The group early adopted the amendment to AASB 101 that is included in AASB 2009-5 in the year ended 30 June 2009. No other amendments from this standard were early adopted.

AASB 101 *Presentation of Financial Statements* has been amended to state that the classification of the liability component of a convertible instrument as current or non-current is not affected by terms that could, at the option of the holder of the instrument, result in settlement of the liability by the issue of equity instruments. This change confirmed the classification of the Group's convertible notes as a non-current liability for the year ended 30 June 2009 and 30 June 2010.

Not yet adopted

The following standards, amendments to standards and interpretations have been identified as those which may impact the entity in the period of initial application. They are available for early adoption at 30 June 2010, but have not been applied in preparing this financial report:

(c) Basis of consolidation

The consolidated financial statements incorporate the assets and liabilities of all entities controlled by Orion Gold NL ("parent company") from time to time during the year and at 30 June 2010 and the results of its controlled entity, Goldstar Resources (WA) Pty Ltd for the year then ended. The effects of all transactions between entities in the economic entity are eliminated in full.

Where control of an entity is obtained during a financial year, its results are included in the consolidated statement of financial performance from the date on which control commences. Where control of an entity ceases during a financial year its results are included for that part of the year during which control exists.

The financial statements of the subsidiary are prepared for the same reporting period as the parent entity, using consistent accounting policies. Adjustments are made to bring into line any dissimilar accounting policies that may exist.

(d) Foreign currency translation

The functional and presentation currency of the Company and its Australian subsidiary is Australian Dollars.

(e) Property, plant and equipment

Plant and equipment is stated at cost less accumulated depreciation and accumulated impairment losses. Depreciation is calculated on a reducing balance basis using estimated remaining useful life of the asset. The estimated useful lives for the current and comparative period are as follows:

(f) Impairment

At each reporting date, the Group assesses whether there is any indication that an asset may be impaired. Where an indicator of impairment exists, the Group makes a formal estimate of recoverable amount. Where the carrying amount of an asset exceeds its recoverable amount the asset is considered impaired and is written down to its recoverable amount.

Recoverable amount is the greater of fair value less costs to sell and value in use. It is determined for an individual asset, unless the asset's value in use cannot be estimated to be close to its fair value less costs

An impairment loss is recognised if the carrying amount of an asset or its cash-generating unit exceeds its recoverable amount. Impairment losses are recognised in profit or loss. Impairment losses recognised in respect of cash-generating units are allocated first to reduce the carrying amount of any goodwill allocated to the units and then to reduce the carrying amount of the other assets in the unit (group of units) on a pro rata basis.

Impairment losses recognised in prior periods are assessed at each reporting date for any indications that the loss has decreased or no longer exists. An impairment loss is reversed if there has been a change in the estimates used to determine the recoverable amount. An impairment loss is reversed only to the extent that the asset's carrying amount does not exceed the carrying amount that would have been determined, net of depreciation or amortisation, if no impairment loss had been recognised.

(g) Trade and other receivables

Trade receivables, which generally have 30-60 day terms, are recognised and carried at original invoice amount less an allowance for any uncollectible amounts.

An estimate for doubtful debts is made when collection of the full amount is no longer probable. Bad debts are written off when identified.

(h) Cash and cash equivalents

Cash and short-term deposits in the balance sheet comprise cash at bank and in hand and short-term deposits with an original maturity of twelve months or less.

For the purposes of the Cash Flow Statement, cash and cash equivalents consist of cash and cash equivalents as defined above, net of outstanding bank overdrafts.

Funds placed on deposit with financial institutions to secure performance bonds are classified as non-current receivables and not included in cash and cash equivalents.

(i) Provisions

Provisions are recognised when the Group has a present obligation (legal or constructive) as a result of a past event, it is probable that an outflow of resources embodying economic benefits will be required to settle the obligation and a reliable estimate can be made of the amount of the obligation.

Where the Group expects some or all of a provision to be reimbursed, for example under an insurance contract, the reimbursement is recognised as a separate asset but only when the reimbursement is virtually certain. The expense relating to any provision is presented in the income statement net of any reimbursement.

If the effect of the time value of money is material, provisions are determined by discounting the expected future cash flows at a pre-tax rate that reflects current market assessments of the time value of money and, where appropriate, the risks specific to the liability.

Where discounting is used, the increase in the provision due to the passage of time is recognised as a finance cost.

(j) Employee benefits

Wages, salaries and annual leave

Liabilities for employee benefits for wages, salaries and annual leave that are expected to be settled within twelve months of the reporting date represent obligations resulting from employees services provided to reporting date, are calculated at undiscounted amounts based on remuneration wage and

Share based payments

The cost of equity-settled transactions with employees is measured by reference to the fair value at the date at which they are granted. The fair value is determined by an external valuer using the Black Scholes model. Further details are given in Note 11.

The cost of equity-settled transactions is recognised, together with a corresponding increase in equity, over the period in which the performance conditions are fulfilled, ending on the date on which the relevant employees become fully entitled to the award ('vesting date').

The cumulative expense recognised for equity-settled transactions at each reporting date until vesting date reflects (i) the extent to which the vesting period has expired and (ii) the number of awards that, in the opinion of the directors of the Group, will ultimately vest. This opinion is formed based on the best available information at balance date. No adjustment is made for the likelihood of market performance conditions being met as the effect of these conditions is included in the determination of fair value at grant date. No expense is recognised for awards that do not ultimately vest, except for awards where vesting is conditional upon a market condition.

Where the terms of an equity-settled award are modified, as a minimum an expense is recognised as if the terms had not been modified. In addition, an expense is recognised for any increase in the value of the transaction as a result of the modification, as measured at the date of modification.

Where an equity-settled award is cancelled, it is treated as if it had vested on the date of cancellation, and any expense not yet recognised for the award is recognised immediately. However, if a new award is substituted for the cancelled award, and designated as a replacement award on the date that it is granted, the cancelled and new award are treated as if they were a modification of the original award, as described in the previous paragraph.

(k) Leases

Operating lease payments are recognised as an expense in the income statement on a straight-line basis over the lease term.

Minimum lease payments made under finance leases are apportioned between the finance expense and the reduction of the outstanding liability. The finance expense is allocated to each period during the lease term so as to produce a constant periodic rate of interest on the remaining balance of the liability.

(l) Revenue

Revenue is recognised to the extent that it is probable that the economic benefits will flow to the Group and the revenue can be reliably measured.

Interest

Revenue is recognised as the interest accrues (using the effective interest method, which is the rate that exactly discounts estimated future cash receipts through the expected life of the financial instrument) to the net carrying amount of the financial asset.

Rental income

Rental income is accounted for on a straight-line basis over the lease term.

(m) Income tax

Income tax expense comprises current and deferred tax. Income tax expense is recognised in profit or loss except to the extent that it relates to items recognised directly in equity, in which case it is recognised in equity.

Deferred tax is recognised using the balance sheet method, providing for temporary differences between the carrying amounts of assets and liabilities for financial reporting purposes and the amounts used for taxation purposes. Deferred tax is not recognised for the following temporary differences: the initial recognition of assets or liabilities in a transaction that is not a business combination and that affects neither accounting nor taxable profit or loss, and differences relating to investments in subsidiaries and jointly controlled entities to the extent that it is probable that they will not reverse in the foreseeable future. In addition, deferred tax is not recognised for taxable temporary differences arising on the initial recognition of goodwill. Deferred tax is measured at the tax rates that are expected to be applied to the temporary differences when they reverse, based on the laws that have been enacted or substantively enacted by the reporting date. Deferred tax assets and liabilities are offset if there is a legally enforceable right to offset current tax liabilities and assets, and they relate to income taxes levied by the same tax authority on the same taxable entity, or on different tax entities, but they intend to settle current tax liabilities and assets on a net basis or their tax assets and liabilities will be realised simultaneously.

A deferred tax asset is recognised to the extent that it is probable that future taxable profits will be available against which the temporary difference can be utilised. Deferred tax assets are reviewed at each reporting date and are reduced to the extent that it is no longer probable that the related tax benefit will be realised. Additional income taxes that arise from the distribution of dividends are recognised at the same time as the liability to pay the related dividend is recognised.

During the year the Company reviewed the 2006 Tax return and adjusted the Research and Development claim to elect to receive the cash rebate. The Australian Taxation Office cash rebate received was \$253,184.

Tax consolidation

The Company and its wholly-owned Australian resident entity are part of a tax-consolidated group. As a consequence, all members of the tax-consolidated group are taxed as a single entity from that date. The head entity within the tax-consolidated group is Orion Gold NL.

Current tax expense / income, deferred tax liabilities and deferred tax assets arising from temporary differences of the members of the tax-consolidated group are recognised in the separate financial statements of the members of the tax-consolidated group using the 'separate taxpayer within group' approach by reference to the carrying amounts of assets and liabilities in the separate financial statements of each entity and the tax values applying under tax consolidation.

Any current tax liabilities (or assets) and deferred tax assets arising from unused tax losses of the subsidiaries are assumed by the head entity in the tax-consolidated group and are recognised by the Company as amounts payable (receivable) to / (from) other entities in the tax-consolidated group in conjunction with any tax funding arrangement amounts (refer below). Any difference between these amounts is recognised by the Company as an equity contribution or distribution.

The Company recognises deferred tax assets arising from unused tax losses of the tax-consolidated group to the extent that it is probable that future taxable profits of the tax-consolidated group will be available against which the assets can be utilised.

Any subsequent period adjustments to deferred tax assets arising from unused tax losses as a result of revised assessments of the probability of recoverability are recognised by the head entity only.

(n) Other taxes

Revenues, expenses and assets are recognised net of the amount of GST except where the GST incurred on a purchase of goods and services is not recoverable from the taxation authority, in which case the GST is recognised as part of the cost of acquisition of the asset or as part of the expense item as applicable;

Cash flows are included in the Cash Flow statement on a gross basis and the GST component of cash flows arising from investing and financing activities, which is recoverable from, or payable to, the taxation authority are classified as operating cash flows.

(o) Exploration and evaluation expenditure

Exploration and evaluation expenditure incurred by or on behalf of the Group is accumulated separately for each area of interest. Such expenditure comprises net direct costs and an appropriate portion of related overhead expenditure which can be directly attributed to operational activities in the area of interest, but does not include general overheads or administrative expenditure not having a specific nexus with a particular area of interest.

Each area of interest is limited to a size related to a known or probable mineral resource capable of supporting a mining operation.

Exploration expenditure for each area of interest is written off as incurred, except that it may be carried forward provided that one of the following conditions is met:

- such costs are expected to be recouped through successful development and exploitation of the area of interest or, alternatively, by its sale; or
- exploration activities in the area of interest have not, at balance date reached a stage which permits a reasonable assessment of the existence or otherwise of economically recoverable reserves.

Exploration expenditure which no longer satisfies the above policy is written off. In addition, a provision is raised against exploration expenditure where the directors are of the opinion that the carried forward net cost may not be recoverable under the above policy. The increase in the provision is charged against the financial performance for the year.

When an area of interest is abandoned, any expenditure carried forward in respect of that area is written off in the year in which the decision to abandon is made, firstly against any existing provision for that expenditure, with any remaining balance being charged to earnings.

Expenditure is not carried forward in respect of any area of interest/mineral resource unless the economic entity's rights of tenure to that area of interest are current. Amortisation is not charged on areas under development, pending commencement of production.

(p) Critical accounting judgements and key sources of estimation uncertainty

In the application of AASB'S management is required to make judgments, estimates and assumptions about carrying values of assets and liabilities that are not readily apparent from other sources. The estimates and associated assumptions are based on historical experience and various other factors that are believed to be reasonable under the circumstance, the results of which form the basis of making the judgments. Actual results may differ from these estimates. The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the year in which the estimate is revised if the revision affects only that year, or in the year of the revision and future years if the revision affects both current and future years.

Judgments made by management that have significant effects on the financial statements and estimates with a significant risk of material adjustments in the next year are disclosed, where applicable, in the relevant notes to the financial statements and include:

- Measurement of share based payments,
- calculation of financial instruments (convertible notes) and
- lease classification, and
- deferred exploration, evaluation and development.

Convertible notes issued by the Group can be converted to share capital at the option of the holder, and the number of shares to be issued may vary depending upon the price at which the Company issues shares during the term of the convertible notes.

The liability component of the convertible note is recognised initially at the fair value of a similar liability that does not have a conversion option. Subsequent to initial recognition, the liability component of the convertible notes is measured at amortised cost using the effective interest method. Interest, dividends,

losses and gains relating to the financial liability are recognised in the income statement as a non cash item.

The conversion option is recognised initially at fair value. Subsequent to initial recognition all changes in its fair value are recognised immediately in the income statement.

(r) Earnings per share

The Group presents basic and diluted earnings per share (EPS) data for its ordinary shares. Basic EPS is calculated by dividing the profit or loss attributable to ordinary shareholders of the Company by the weighted average number of ordinary shares outstanding during the period. Diluted EPS is determined by adjusting the profit or loss attributable to ordinary shareholders and the weighted average number of ordinary shares outstanding for the effects of all dilutive potential ordinary shares, which comprise convertible notes and share options granted to employees.

(s) Segment reporting

Determination and presentation of operating segments

As of 1 July 2009 the Group determines and presents operating segments based on the information that internally is provided to the Executive Chairman, who is the Group's chief operating decision maker. This change in accounting policy is due to the adoption of AASB 8 Operating Segments. Previously operating segments were determined and presented in accordance with AASB 114 Segment Reporting. The new accounting policy in respect of segment operating disclosures has not changed the way in which disclosures are presented as the Group only operates in one segment.

An operating segment is a component of the Group that engages in business activities from which it may earn revenues and incur expenses, including revenues and expenses that relate to transactions with any of the Group's other components. All operating segments' operating results are regularly reviewed by the Group's Executive Chairman to make decisions about resources to be allocated to the segment and assess its performance, and for which discrete financial information is available.

Segment results that are reported to the Executive Chairman include items directly attributable to a segment as well as those that can be allocated on a reasonable basis. Unallocated items comprise mainly corporate assets (primarily the Company's headquarters), head office expenses, and income tax assets and liabilities.

Segment capital expenditure is the total cost incurred during the period to acquire property, plant and equipment, and intangible assets other than goodwill.

(t) Share capital

Ordinary shares are classified as equity. Incremental costs directly attributable to the issue of ordinary shares and share options are recognised as a deduction from equity, net of any tax effects. Dividends on ordinary shares are recognised as a liability in the period in which they are declared.

(v) Determination of fair values

A number of the Group's accounting policies and disclosures require the determination of fair value, for both financial and non-financial assets and liabilities. Fair values have been determined for measurement and / or disclosure purposes based on the following methods. When applicable, further information about the assumptions made in determining fair values is disclosed in the notes specific to that asset or liability.

Convertible notes

The fair value of the convertible notes is determined at each reporting date by an external, independent company that has appropriate, recognized professional qualifications and experience to value financial instruments of this nature. In relation to the converting option feature of the convertible notes, the fair value is determined by this company using a binomial option pricing model.

Share-based payment transactions

The fair value of the employee share options and the share appreciation rights is measured using the Black-Scholes formula. Measurement inputs include share price on measurement date, exercise price of the instrument, expected volatility (based on weighted average historic volatility adjusted for changes expected due to publicly available information), weighted average expected life of the instruments (based on historical experience and general option holder behaviour), expected dividends, and the risk-free interest rate (based on government bonds). Service and non-market performance conditions attached to the transactions are not taken into account in determining fair value.

The converting loan agreement between Silja Investment Limited and the Company dated 9 September 2008, provided for Silja Investment Limited to provide a total of up to \$6 million in funding to the Company by way of the following convertible notes:

- First tranche note - \$1,400,000;
- Second tranche note - \$1,600,000; and
- Third tranche note - \$3,000,000.

The issue of the convertible notes was subject to the satisfaction of a number of conditions precedent, including shareholder approval, which was given at a general meeting of the Company held on 25 November 2008. The first tranche note was issued on that date, and the second and third tranche notes were issued on 24 June 2009. Prior to maturity on 31 August 2013, the holder is only able to convert the outstanding amount to shares in the Company. On the third anniversary of the convertible note drawdown, the Company is able to offer to settle the outstanding amount in cash. However, the holder is able to demand settlement in shares at that point in time. The holder may redeem the convertible notes for cash at the maturity date.

Financial Risk Management

Overview

The Group has exposure to the following risks from its use of financial instruments:

- Market risk.
- Credit risk.
- Liquidity risk.

This note presents information about the Group's exposure to each of the above risks, its objectives, policies and processes for measuring and managing risk, and the management of capital.

The Board of directors has overall responsibility for the establishment and oversight of the risk management framework.

Risk management policies are established to identify and analyse the risks faced by the Group, to set appropriate risk limits and controls, and to monitor risks and adherence to limits. Risk management policies and systems are reviewed regularly to reflect changes in market conditions and the Group's activities.

The Group Audit Committee oversees how management monitors compliance with the Group's risk management policies and procedures and reviews the adequacy of the risk management framework in relation to the risks faced by the Group.

The Group's principal financial instruments are cash, short-term deposits, receivables and payables.

Market risk

Market risk is the risk that changes in market prices, such as foreign exchange rates, interest rates and equity prices will affect the Group's income or the value of its holdings of financial instruments. The objective of market risk management is to manage and control market risk exposures within acceptable parameters, while optimising the return.

Equity price risk

The conversion option included in the convertible note is exposed to fluctuations in the Company's share price and the volatility of that share price. Movements in the volatility of the share price will increase the fair value of the conversion option. Movements in the fair value of the option are recognised in the Income Statement.

Interest rate risk

Interest rate risk is the risk that the value of a financial instrument or cash flows associated with the instrument will fluctuate due to changes in market interest rates. Interest rate risk arises from fluctuations in interest bearing financial assets and liabilities that the group uses. Interest bearing assets comprise cash and cash equivalents which are considered to be short-term liquid assets. It is the Group's policy to settle trade payables within the credit terms allowed and therefore not incur interest on overdue balances.

Credit risk

Report on the financial report

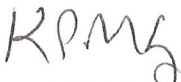
