**POLL RESULTS OF EXTRAORDINARY GENERAL MEETING
HELD ON 28 NOVEMBER 2016**

The Board is pleased to announce that the Resolution as set out in the EGM Notice was duly passed by the Independent Shareholders by way of poll at the EGM held on 28 November 2016.

Reference is made to the circular of Far East Hotels and Entertainment Limited (the “**Company**”) dated 10 November 2016 (the “**Circular**”) and the notice of the extraordinary general meeting of the Company (the “**EGM**”) dated 10 November 2016 (the “**EGM Notice**”). Terms used in this announcement shall have the same meanings as those defined in the Circular unless the context requires otherwise.

POLL RESULTS OF THE EGM

The Board is pleased to announce that the ordinary resolution set out in the EGM Notice (the “**Resolution**”) was duly passed by the Independent Shareholders by way of poll at the EGM held on 28 November 2016.

As at the date of the EGM, there were a total of 602,110,675 Shares in issue. The Vendor and his associates (being Mr. Derek Chiu and his associates who together were interested in or were entitled to exercise control over the voting right in respect of 253,364,848 Shares in aggregate, representing approximately 42.08% of the total issued shares of the Company as at the date of the EGM) are regarded as having material interests in the Acquisition Agreement and the transactions contemplated therein, and have abstained from voting on the Resolution at the EGM to approve the Acquisition Agreement and the transactions contemplated thereunder. Accordingly, as at the date of the EGM, there was a total of 348,745,827 Shares, representing approximately 57.92% of the total issued share capital of the Company, entitling the Independent Shareholders to attend and vote for or against the Resolution at the EGM. There were no Shares entitling the holders to attend and vote only against the Resolution at the EGM and no parties have stated their intention in the

Circular to vote against the Resolution.

The poll results of the Resolution set out in the EGM Notice are as follows:

As more than 50% of the votes were cast in favour of the Resolution, the Resolution was duly passed as an ordinary resolution of the Company at the EGM.
