CHAIRMAN'S STATEMENT AND MANAGEMENT DISCUSSION AND ANALYSIS

On behalf of the board of directors (the “Board”) of Get Nice Holdings Limited (the “Company”), I hereby present the annual report of the Company and its subsidiaries (collectively the “Group”) for the year ended 31 March 2026.

OVERVIEW

For the year ended 31 March 2026, the Group's revenue amounted to approximately HK\$357.5 million, representing a decrease of 17.3% as compared with approximately HK\$432.1 million reported in the last corresponding financial year. The decrease in revenue was mainly attributable to the decrease in interest income from margin financing business, interest from bank balance and time deposits, and property rental income during the year.

Profit for the year attributable to owners of the Company was approximately HK\$53.4 million (2025: HK\$41.2 million). The increase in profit was mainly attributable to the decrease in impairment loss on accounts receivable from margin clients and the acquisition of non-controlling interests in a subsidiary during the year. The Group recorded provision of net impairment loss on accounts receivable from margin clients of approximately HK\$39.4 million (2025: HK\$138.4 million) in current financial year.

Basic earnings per share for the year were HK8.64 cents (2025: HK8.48 cents) as a result of increase in profit during the year.

本人謹代表結好控股有限公司（「本公司」）董事會（「董事會」）提呈本公司及其附屬公司（統稱「本集團」）截至二零二六年三月三十一日止年度之年報。

概覽

截至二零二六年三月三十一日止年度，本集團之收益約為357,500,000港元，較上一財政年度約432,100,000港元減少17.3%。收益減少主要由於年內來自保證金融資業務之利息收入、銀行結餘及定期存款之利息收入及物業租金收入減少所致。

本公司擁有人應佔年內溢利約為53,400,000港元（二零二五年：41,200,000港元）。溢利增加主要由於年內應收保證金客戶賬項之減值虧損減少及收購一間附屬公司之非控股權益。本集團於本財政年度錄得應收保證金客戶賬項之減值虧損淨額撥備約為39,400,000港元（二零二五年：138,400,000港元）。

因年內溢利增加，年內之每股基本盈利為8.64港仙（二零二五年：8.48港仙）。

REVIEW AND OUTLOOK

Market review

In 2025, Hong Kong's economy remained stable, though structural adjustments in key industries led to uneven growth. Real GDP grew moderately, driven by resilient export demand and the gradual stabilization of domestic consumption, despite localized headwinds for private consumption. The seasonally adjusted unemployment rate remained low, indicating the labor market's underlying resilience despite ongoing corporate restructuring and workforce adjustments in traditional industries.

The Hong Kong stock market rebounded significantly, with trading activity rising sharply, a stark contrast to previous investor caution. This recovery in market confidence was primarily attributed to substantial capital inflows from mainland investors through the Shanghai-Hong Kong Stock Connect and Shenzhen-Hong Kong Stock Connect mechanisms, as well as strong demand for heavyweight tech and financial stocks.

The Hong Kong stock market delivered a robust performance in the year 2026. The Hang Seng Index closed at 24,788 points at the end of March 2026 compared to 23,119 points at the end of March 2025. The average daily turnover on the Main Board and GEM during the year ended 31 March 2026 was approximately HK\$257.4 billion, an increase of 53.9% as compared with approximately HK\$167.2 billion for the prior financial period.

In the money lending market, operating conditions achieved greater stability as private consumption demonstrated resilience, successfully rebounding from the minor year-on-year contractions seen in late 2024. Lenders maintained disciplined credit policies, prioritizing stringent risk management and proactive debt recovery strategies. These efforts were well-supported by steady household earnings and ongoing government initiatives, such as high-profile mega-events designed to drive inbound tourism. Furthermore, the realization of successive US Federal Reserve interest rate cuts throughout the year successfully lowered localized borrowing costs, which stimulated credit demand and encouraged loan uptake.

回顧及展望

市場回顧

於二零二五年，香港經濟保持穩定，惟主要行業的結構性調整導致增長不均。儘管私人消費面臨局部阻滯，但受具韌性的出口需求及國內消費逐漸趨穩的推動，實質本地生產總值錄得溫和增長。經季節性調整後的失業率維持在低水平，顯示儘管傳統行業持續進行企業重組及勞動力調整，勞工市場仍具備潛在韌性。

香港股市大幅反彈，成交趨向活躍，與此前投資者的謹慎態度形成強烈對比。市場信心的回升，主要由於內地投資者透過滬港通及深港通機制流入的大量資金，以及對重磅科技股及金融股的強勁需求。

於二零二六年，香港股市表現強勁。恆生指數於二零二六年三月底收報24,788點，相比二零二五年三月底收報23,119點。截至二零二六年三月三十一日止年度，主板及GEM的平均每日成交額約為2,574億港元，較上一財政期間約1,672億港元增加53.9%。

於放債市場，經營狀況更趨穩定，此乃由於私人消費展現韌性並成功從二零二四年年底的按年輕微收縮中反彈。放款人維持嚴謹的信貸政策，優先採取嚴格的風險管理及主動的收回債務策略。這些策略受穩定的住戶收入及持續的政府措施（如旨在帶動入境旅遊的備受矚目盛事）的堅實支持。此外，美國聯儲局於整年相繼落實減息，成功降低本地借貸成本，從而刺激信貸需求並鼓勵貸款需求。

The Hong Kong property market transitioned into a phase of stabilization and selective recovery, shaped by the cumulative impact of past policy adjustments and easing monetary conditions. The full-year impact of the complete removal of demand-side management measures, paired with progressive interest rate cuts and a supportive mortgage environment, fueled a noticeable rebound in residential transaction volumes compared to the preceding year. Private residential prices bottomed out mid-year and registered a modest annual gain by December 2025, supported by solid demand from primary market launches and various government talent attraction schemes. In contrast, the commercial sector presented a more complex narrative. Ample new supply completions pushed the overall Grade A office vacancy rate to a historical high. Retail and industrial segments continued to navigate structural headwinds, but the broader market found a solid floor due to robust domestic leasing demand and aggressive government-backed promotional events.

Regarding the UK property market, growth across prime regional markets remained muted as the elevated demand from the pandemic era continued to recede and market participants carefully evaluated the implications of the Autumn Budget. However, the cumulative effect of progressive interest rate cuts initiated since the second half of 2024 helped lower borrowing costs, which gradually stimulated demand among mortgaged buyers. While a sense of price sensitivity persisted throughout the year due to localized tax and regulatory adjustments, this improving monetary environment laid a more predictable foundation that is expected to support a gradual and steady recovery.

Business review

Broking and securities margin financing

During the year ended 31 March 2026, the broking business posted a profit of approximately HK\$60.3 million (2025: HK\$86.9 million). The operating profit of the broking business decreased by 30.6% as a result of the decrease in interest revenue from time-deposits, outweighing the increase in broking turnover and the number of sizeable corporate finance transactions during the current year. The increase in broking turnover was caused by the volatile local stock market and positive global investment atmosphere. Revenue from broking for the year decreased by 19.6% to approximately HK\$103.1 million (2025: HK\$128.2 million) as compared with the last financial year, mainly comprising of broking commissions amounting to approximately HK\$26.2 million (2025: HK\$18.9 million), and interest from bank balances and time deposits amounting to approximately HK\$47.0 million (2025: HK\$96.1 million).

因過往政策調整及貨幣環境寬鬆的累積影響，香港物業市場過渡至穩定及選擇性復甦階段。全面撤銷需求管理措施的整年影響，加上逐步減息及支持性的按揭環境，推動住宅成交量較上一年度顯著回升。受一手市場推售的穩健需求及各項政府吸引人才計劃支持，私人住宅價格於年中見底回升，並於二零二五年十二月錄得輕微年度升幅。相比之下，商用物業的情況則較為複雜。大量新物業落成將整體甲級寫字樓空置率推至歷史新高。零售及工業物業繼續應對種種結構性不利因素，但整體市場因本地租賃需求強勁及政府大力支持的推廣活動而企穩。

英國物業市道方面，隨著疫情過後的強勁需求持續消退及市場參與者審慎評估秋季預算案的影響，各主要區域市場的增長仍然低迷。然而，利率自二零二四年下半年的漸進式減息之累積效應，有助降低借貸成本，從而逐漸刺激按揭買家的需求。儘管價格敏感度因本地稅務及監管調整而整年間維持不變，但此改善中的貨幣環境奠定了更可預測的基礎，預期將支持逐漸且穩步的復甦。

業務回顧

經紀及證券保證金融資

截至二零二六年三月三十一日止年度，經紀業務錄得溢利約60,300,000港元（二零二五年：86,900,000港元）。由於本年度之定期存款的利息收入減幅超越經紀業務營業額及較大型之企業融資交易數目的增幅，故經紀業務之經營溢利減少30.6%。經紀業務之營業額亦因為本地股市波動及正面環球投資市場氣氛而增加。經紀分部於年內之收益較上財政年度減少19.6%至約103,100,000港元（二零二五年：128,200,000港元），主要包括經紀佣金約26,200,000港元（二零二五年：18,900,000港元）以及銀行結餘及定期存款之利息約47,000,000港元（二零二五年：96,100,000港元）。

Securities margin financing remained to be the Group's major revenue contributor for the year. During the year, total interest income from securities margin financing dropped by 20.4% to approximately HK\$158.8 million (2025: HK\$199.6 million), with a decrease in the average level of securities margin lending during the year. Total gross accounts receivable from margin clients as at 31 March 2026 amounted to approximately HK\$2,337.6 million (2025: HK\$2,269.5 million). Net impairment loss on margin clients receivable of approximately HK\$39.4 million was charged during the current year (2025: HK\$138.4 million).

The provision of net impairment loss was provided for the whole margin loan portfolio of the Group irrespective of a client's margin shortfall status, in order to recognise the expected credit loss of accounts receivable from margin clients. Depending on the degree of margin shortfall of each client, which is calculated by the outstanding loan balance minus the market value of pledged securities, margin clients are categorised into different credit ratings and the expected credit loss is recognised based on the corresponding default rate and recovery rate from Moody's. For clients with significant margin shortfall, additional impairment loss of up to 100% of the margin shortfall amount will be recognised. To recover overdue account receivables, the Group has taken various actions, including issuing margin calls, forced selling of pledged securities, issuing demand letters and taking legal action accordingly.

The total provision of net impairment loss on accounts receivable from margin clients amounted to approximately HK\$39.4 million during the year ended 31 March 2026. Net provision of approximately HK\$21.5 million was reversed for the Group's ten largest margin clients, including the director of the Company and their close family members.

The Group will continue to maintain a balance on yield relative to risk, as well as a cautious approach to the credit control of its margin financing business.

證券保證金融資繼續是本集團於年內之主要收益來源。於年內，證券保證金融資之利息收入總額減少20.4%至約158,800,000港元（二零二五年：199,600,000港元），而年內證券保證金借貸之平均水平下降。本集團於二零二六年三月三十一日之應收保證金客戶賬項總額合計約為2,337,600,000港元（二零二五年：2,269,500,000港元）。本年度支銷之應收保證金客戶賬項減值虧損淨額約39,400,000港元（二零二五年：138,400,000港元）。

減值虧損淨額撥備乃就本集團整個保證金貸款組合而計提，而不論客戶是否有保證金短欠情況，藉此確認應收保證金客戶賬項的預期信貸虧損。按每位客戶的保證金短欠程度（按未償還貸款餘額減去抵押證券的市值計算）將保證金客戶分類為不同信貸等級，並根據來自穆迪的相應違約率及收回率以確認預期信貸虧損。對於保證金短欠金額龐大的客戶，則確認最高相當於保證金短欠金額100%的額外減值虧損。本集團為收回逾期應收賬項而採取各種行動，包括發出保證金催繳通知、強制出售抵押證券、發出催繳函及依法採取法律行動。

截至二零二六年三月三十一日止年度，應收保證金客戶賬項的減值虧損淨額之總撥備約為39,400,000港元。撥備淨額約21,500,000港元乃就本集團的十大保證金客戶（包括本公司董事及彼等的緊密家族成員）而撥回。

本集團將繼續維持收益與風險之間的平衡，並以謹慎的態度對旗下保證金融資業務實行信貸控制措施。

Money lending

The money lending vehicle is engaged in provision of mortgage and consumer loans. The money lending business performance showed a stable performance during the year. The aggregated loan amount increased to approximately HK\$641.8 million as at 31 March 2026 from approximately HK\$497.4 million as at 31 March 2025, with interest income for the year decreasing to approximately HK\$44.0 million (2025: HK\$45.8 million). The money lending business recorded a profit before tax of approximately HK\$12.1 million for the year ended 31 March 2026 (2025: HK\$24.1 million). Net impairment loss on loans and advances of approximately HK\$30.9 million was provided during the year (2025: HK\$20.7 million).

Potential customers are required to disclose and provide a list of information required for a loan application. The Group has the following credit assessment policy to assess the creditworthiness of potential customers and their repayment abilities.

- (i) For secured loans, the Group will conduct a credit assessment test against a potential customer. It will take into account the term of the loan and the results from the credit assessment in totality to assess the repayment ability of the potential customer. A valuation report on the underlying property will be prepared by an independent valuer to determine its current fair value. The Group has set a clear guideline on the loan-to-value ratios for granting and renewing mortgage loans and the term of the loan shall normally be within a reasonable tenor accepted by the Group.

The Group will then conduct a credit assessment exercise according to the credit policy by considering factors, including but not limited to, the relevant risks of the Group (e.g. the default risk of the potential customer), the cost of funds, cashflows, etc. of the Group as well as the market offer, customer's repayment ability, etc. Afterwards, the Group will determine the terms of the offer and notify the customer regarding the loan approval.

放債

放債公司之主要業務為提供按揭及消費者貸款。本年度的放債業務表現穩定。貸款總額由二零二五年三月三十一日之約497,400,000港元上升至二零二六年三月三十一日之約641,800,000港元，利息收入於年內減少至約44,000,000港元（二零二五年：45,800,000港元）。放債業務於截至二零二六年三月三十一日止年度錄得除稅前溢利約12,100,000港元（二零二五年：24,100,000港元）。年內貸款及墊款之減值虧損淨額約30,900,000港元（二零二五年：20,700,000港元）。

潛在客戶須披露並提供申請貸款所需的資料清單。本集團有以下信貸評估政策，以評估潛在客戶的信貸評級及其償還能力。

- (i) 對於有擔保貸款，本集團會對潛在客戶進行信貸評估測試。本集團綜合考慮貸款期限及信貸評估結果，以評估潛在客戶之還款能力。獨立估值師會就相關物業編製估值報告，釐定其當時之公允值。本集團已就授出及重續按揭貸款之貸款價值比率制定明確指引，而貸款期限通常訂為本集團所接納之合理年期。

其後，本集團將根據信貸政策進行信貸評估，考慮因素包括但不限於本集團之相關風險（如潛在客戶之違約風險）、本集團之資金成本、現金流等，以及市場報價、客戶之還款能力等。然後，本集團將釐定貸款條款，並通知客戶有關貸款之批核狀況。

(ii) For unsecured loans, the Group will carry out the credit assessment on every unsecured loan applicant based on the following factors:

- (a) Total amount of the principal and interest payable to be granted;
- (b) Duration of the term for repayment of the loan to be granted;
- (c) Frequency and amount of the repayments to be made;
- (d) The interest rate of the loan to be granted;
- (e) Purpose of obtaining the loan to be granted;
- (f) The employment or business of the unsecured loan applicant;
- (g) Current credit and financial information of the unsecured loan applicant;
- (h) Any other factors which may affect the unsecured loan applicant's affordability;
- (i) Current income and expenditure of the unsecured loan applicant;
- (j) Foreseeable reduction in income or increase in expenditure of the unsecured loan applicant; and
- (k) Savings and assets of the unsecured loan applicant.

Building on the Group's expertise and relationships with high net worth customers, the Group remains positive about the money lending business and will continue to target high net worth customers with short-term financial needs.

(ii) 就無擔保貸款而言，本集團會根據以下因素對每名無擔保貸款申請人進行信貸評估：

- (a) 擬授出之應付本金及利息總額；
- (b) 擬授出之貸款還款期限；
- (c) 還款分期期數及金額；
- (d) 擬授出之貸款利率；
- (e) 擬授出之貸款申請目的；
- (f) 無擔保貸款申請人之就業或業務狀況；
- (g) 無擔保貸款申請人當時之信貸及財務資料；
- (h) 任何其他可能影響無擔保貸款申請人負擔能力之因素；
- (i) 無擔保貸款申請人當時之收入及開支；
- (j) 無擔保貸款申請人可預見之收入減少或開支增加；及
- (k) 無擔保貸款申請人之儲蓄及資產。

憑藉本集團掌握的專門知識以及與高淨值客戶的業務關係，本集團仍然看好放債業務之前景，並將繼續專注於有短期融資需要之高淨值客戶。

Corporate finance

The Group's corporate finance business focused on the provision of financial advisory services to listed companies in Hong Kong. During the year ended 31 March 2026, it completed 5 financial advisory transactions (2025: 5). The operation reported a segment profit of approximately HK\$4.1 million for the year (2025: HK\$3.5 million).

Asset Management

During the year ended 31 March 2026, this division reported a profit of approximately HK\$452,000 (2025: HK\$581,000) mainly attributable to the asset management related income of approximately HK\$472,000 (2025: HK\$594,000) received during the year.

Financial instruments investments

The financial instruments investments division held financial instruments for the Group. Assets allocations are based on expected return rates and available funding capital. During the year ended 31 March 2026, this division reported a profit of approximately HK\$176,000 (2025: HK\$28.7 million), mainly attributable to interest income from unlisted debt securities of approximately HK\$3.1 million (2025: HK\$6.7 million); interest income from listed debt securities of approximately HK\$4.6 million (2025: HK\$6.7 million); interest income from financial assets measured at amortised cost of approximately HK\$4.9 million (2025: HK\$Nil); and losses on disposal of listed debt securities of approximately HK\$14.1 million (2025: gains of HK\$243,000).

企業融資

本集團之企業融資業務專注向香港上市公司提供財務顧問服務。其於截至二零二六年三月三十一日止年度已完成五項(二零二五年：五項)財務顧問交易。此業務於年內錄得分部溢利約4,100,000港元(二零二五年：3,500,000港元)。

資產管理

截至二零二六年三月三十一日止年度，此分部錄得溢利約452,000港元(二零二五年：581,000港元)，主要源自本年度收取有關資產管理的收入約472,000港元(二零二五年：594,000港元)。

金融工具投資

金融工具投資分部為本集團持有金融工具。資產配置是建基於預期回報率及可動用資金資本。截至二零二六年三月三十一日止年度，此分部錄得溢利約176,000港元(二零二五年：28,700,000港元)，主要由於非上市債務證券之利息收入約3,100,000港元(二零二五年：6,700,000港元)；上市債務證券之利息收入約4,600,000港元(二零二五年：6,700,000港元)；按攤銷成本計量之金融資產利息收入約4,900,000港元(二零二五年：零港元)；及出售上市債務證券虧損約14,100,000港元(二零二五年：收益243,000港元)。

As at 31 March 2026, the Group held an investment portfolio mainly consisting of listed equity securities, debt securities, unlisted equity securities and term note with total fair values of approximately HK\$387.7 million (2025: HK\$344 million). The increase in total fair values of the investment portfolio was mainly attributable to the purchase of term note of approximately HK\$80 million (2025: HK\$Nil). The portfolio of listed equity securities mainly comprised of listed companies in Hong Kong while the portfolio of debt securities mainly comprised of listed bonds and redeemable notes issued by certain listed and unlisted companies in Hong Kong and overseas countries.

Property investments

The property investments division held properties in Hong Kong and London. For the year under review, this division reported a loss of approximately HK\$91.3 million (2025: HK\$71.9 million), mainly attributable to fair value losses on investment properties of approximately HK\$117.3 million (2025: HK\$94.4 million) and rental income of approximately HK\$31.6 million (2025: HK\$40.0 million).

During the year ended 31 March 2026, the Group had newly acquired twenty-one investment properties in Hong Kong, of which twelve properties are uncompleted residential, at total considerations of HK\$198.5 million. As at 31 March 2026, the Group held a portfolio of investment properties with a total fair value of approximately HK\$1,282.4 million (2025: HK\$1,205.3 million), comprised of residential, commercial and industrial properties in Hong Kong, and residential properties and a commercial building in London. As at 31 March 2026, the Group had paid deposits totaling of approximately HK\$137.5 million for the acquisition of the uncompleted residential (2025: HK\$Nil).

Auction business

During the year ended 31 March 2026, this division reported a profit of approximately HK\$938,000 (2025: HK\$604,000) mainly attributable to the artwork auction commission income of approximately HK\$1.6 million (2025: HK\$1.1 million) received during the year.

物業投資

物業投資分部於香港及倫敦持有物業。於回顧年度，此分部錄得虧損約91,300,000港元（二零二五年：71,900,000港元），主要源自投資物業之公允值虧損約117,300,000港元（二零二五年：94,400,000港元）及租金收入約31,600,000港元（二零二五年：40,000,000港元）。

截至二零二六年三月三十一日止年度，本集團新收購21個位於香港的投資物業（其中12個為未落成住宅），總代價為198,500,000港元。於二零二六年三月三十一日，本集團所持投資物業組合的總公允值約為1,282,400,000港元（二零二五年：1,205,300,000港元），包括於香港的住宅、商業及工業物業以及倫敦的住宅物業及商業大廈。於二零二六年三月三十一日，本集團已就收購未落成住宅物業支付按金合計約137,500,000港元（二零二五年：零港元）。

拍賣業務

截至二零二六年三月三十一日止年度，此分部錄得溢利約938,000港元（二零二五年：604,000港元），主要源自本年度收取有關藝術品拍賣的佣金收入約1,600,000港元（二零二五年：1,100,000港元）。

Outlook

Looking ahead, the external environment in 2026 remains complex. On one hand, the outbreak of military conflict in the Middle East and the closure of the Strait of Hormuz have brought severe supply-side shocks to the global commodity market. Large-scale disruptions to energy infrastructure have pushed up crude oil prices, triggering a sharp rebound in global inflationary pressures, and uncertainty remains regarding whether interest rates will rise or fall. On the other hand, the global economic framework has demonstrated significant structural resilience. Financial conditions outside conflict zones remain at historically accommodative levels. However, international trade flows and global investment are largely dependent on the duration and scope of geopolitical crises.

Despite these challenges, our Group will continue to leverage its professionalism and extensive experience in the money lending business. We will persistently implement cautious and prudent measures, regularly review and tighten our credit policies, and increase our focus on high-net-worth clients.

Regarding the Group's investment activities, management will continue to seek high-quality investment properties in Asia and Europe, as well as securities with strong potential, to enhance the investment portfolio and ensure steady rental income and investment gains. Meanwhile, management will adopt prudent measures to manage the Group's investment portfolio.

In the auction business, the Group aims to maintain stable growth and development by upholding its principle of sourcing excellent artworks with strong provenance to attract art enthusiasts from all sectors of society.

To address future challenges, the Group's management will regularly review and adjust business strategies with a prudent and balanced risk management approach. The Group remains cautiously optimistic about its business development and overall performance moving forward.

展望

展望未來，外部環境於二零二六年仍然複雜。一方面，中東爆發軍事衝突及霍爾木茲海峽關閉，為全球商品市場帶來了嚴重的供應端衝擊。能源基礎設施遭受大規模中斷推高原油價格，引發全球通脹壓力大幅反彈，而利率升跌仍存在不確定性。另一方面，全球經濟框架顯示明顯的結構韌性。衝突地區以外的金融狀況仍處於歷史性的寬鬆水平。然而，國際貿易流量及全球投資在很大程度上取決於地緣政治危機的時長及範圍。

FINANCIAL REVIEW

Financial Resources and Gearing Ratio

Equity attributable to owners of the Company amounted to approximately HK\$6,651.8 million as at 31 March 2026 (2025: HK\$6,623.3 million), representing an increase of approximately HK\$28.5 million or 0.4% over that of the last financial year end. The non-controlling interests decreased from approximately HK\$399,000 as at 31 March 2025 to approximately HK\$90,000 as at 31 March 2026. These movements were mainly attributable to the profit for the year netting off dividend distributed during the year.

As at 31 March 2026, the Group's net current assets amounted to approximately HK\$4,770.0 million (2025: HK\$4,821.6 million), and its liquidity as represented by current ratio (current assets/current liabilities) was 11.3 times (2025: 7.9 times). The increase in net current assets and current ratio were mainly attributable to the decrease in dividend payable. The Group's bank balances and cash on hand decreased to approximately HK\$1,964.7 million (2025: HK\$2,744.3 million). The decrease in bank balances and cash on hand was mainly due to the cash outflow in respect of the acquisition of twenty-one investment properties in Hong Kong and distribution of special dividend as set out in note 33(a) to the consolidated financial statements.

The Group had no bank borrowings as at 31 March 2026 and 31 March 2025. The Group had undrawn banking facilities amounting to approximately HK\$428 million as at 31 March 2026 (2025: HK\$428 million) which were secured by corporate guarantees issued by the Company (2025: corporate guarantee issued by the Company).

As at 31 March 2026 and 31 March 2025, the Group's gearing ratio (total borrowing over equity attributable to owners of the Company) was not presented as the Group had no borrowings.

The number of issued shares of Company amounted to 618,197,262 shares as at 31 March 2026 (2025: 9,662,705,938 shares).

於二零二六年三月三十一日，本公司擁有人之應佔權益約為6,651,800,000港元（二零二五年：6,623,300,000港元），較上一財政年度之年結日增加約28,500,000港元或0.4%。非控股權益由二零二五年三月三十一日約399,000港元減少至二零二六年三月三十一日約90,000港元。有關變動主要源自年度溢利抵銷年內分派之股息所致。

於二零二六年三月三十一日，本集團之流動資產淨額約為4,770,000,000港元（二零二五年：4,821,600,000港元），而流動性（以流動比率，即流動資產／流動負債作說明）為11.3倍（二零二五年：7.9倍）。流動資產淨額及流動比率上升，主要由於應付股息減少所致。本集團之銀行結餘及手頭現金減少至約1,964,700,000港元（二零二五年：2,744,300,000港元）。銀行結餘及手頭現金減少，主要是由於收購21個位於香港的投資物業所產生的現金流出以及綜合財務報表附註33(a)所述的特別股息派發。

本集團於二零二六年三月三十一日及二零二五年三月三十一日概無銀行借貸。而於二零二六年三月三十一日之未提取銀行信貸額約為428,000,000港元（二零二五年：428,000,000港元）。有關銀行信貸額以本公司提供之公司擔保作抵押（二零二五年：以本公司提供之公司擔保作抵押）。

於二零二六年三月三十一日及二零二五年三月三十一日，由於本集團並無借貸，故並無呈列本集團之資本負債比率（即借貸總額除以本公司擁有人應佔權益）。

Except for the investment property located in the United Kingdom and its related rental income which are denominated in British Pounds, the business activities of the Group were not exposed to material fluctuations in exchange rates as the majority of the transactions were denominated in Hong Kong dollars.

The Group had no material contingent liabilities at the end of the year.

Charges on Group Assets

The Group had no charges on assets for banking facilities as at 31 March 2026 and 31 March 2025.

Material Acquisitions and Disposals of Subsidiaries, Associates and Jointly Controlled Entities

Save as disclosed in note 37 to the consolidated financial statements, there were no material acquisitions or disposals of subsidiaries, associates or jointly controlled entities during the reporting period.

Employee Information

As at 31 March 2026, the Group had 58 (2025: 61) full time employees. The Group's employees were remunerated according to their performance, working experience and market conditions. The total amount of remuneration cost of employees of the Group for the year was approximately HK\$19.4 million (2025: HK\$24.1 million). The Group provides employee benefits including mandatory provident fund, discretionary share options and performance bonuses to its staff.

The Board is pleased to present this Corporate Governance Report in the Group's annual report for the year ended 31 March 2026.

This Company is committed to the establishment of good corporate governance practices and procedures. This is with the view of being a transparent and responsible organization which is open and accountable to the Company's shareholders. The Directors believe that good corporate governance practices are increasingly important for maintaining and promoting the confidence of our investors.

An explanation of how the principles of the Corporate Governance Code were put into practice during the year under review is set out below.

CORPORATE GOVERNANCE CODE COMPLIANCE

Throughout the year ended 31 March 2026, the Company has applied the principles of, and complied with, the applicable code provisions of the Corporate Governance Code (the "CG Code") as set out in Appendix C1 to the Rules Governing the Listing of Securities (the "Listing Rules").

BOARD OF DIRECTORS

The Board's primary responsibilities are to formulate the Company's long-term corporate strategy, to oversee the management of the Group, to evaluate the performance of the Group and to assess the achievement of targets periodically set by the Board. The day-to-day management, administration and operation of the Company are delegated to the CEO and the senior management. In addition, the Board has also established three Board Committees and has delegated various responsibilities to them as set out in their terms of reference. The Board has the full support of the senior management to discharge its responsibilities. Details of the delegation by the Board will be discussed in the paragraphs below.

遵守企業管治守則

於截至二零二六年三月三十一日止年度，本公司已應用並遵守證券上市規則（「上市規則」）附錄C1企業管治守則（「企業管治守則」）所載適用之守則條文。

董事會

董事會之主要職責為制訂本公司之長遠企業策略、監督本集團之管理、評估本集團之表現及評核能否達到董事會定期設定之目標。本公司之日常管理、行政及營運乃交予行政總裁及高級管理層負責。此外，董事會亦已成立董事會轄下之三個委員會，並按有關委員會之職權範圍之條文，將不同職責交予有關委員會負責。董事會在高級管理層全力支持下履行其職責。董事會作出之授權詳情將於下文論述。

BOARD COMPOSITION

During the year ended 31 March 2026, the Board has at all times met the requirements of rules 3.10(1) and (2), and rule 3.10A of the Listing Rules relating to the appointment of at least three independent non-executive directors, representing at least one-third of the Board and at least one of them possessing appropriate professional qualifications, or accounting or related financial management expertise.

The Board currently comprises six Directors, four of these Directors are non-executive and three of them are independent to the management. The Board is collectively responsible for promoting the success of the Company by directing and supervising the Group's affair. The Board has a balance of skill and experience appropriate and diversity of perspective for the requirements of the Group's businesses.

As at the date of this annual report, two of them are executives, namely, Mr. Hung Hon Man, Chairman and Mr. Kam Eddie Shing Cheuk, CEO, one of the Director is non-executive Director, namely Ms. Wu Yan Yee (Member of Remuneration Committee and Nomination Committee) and three of the Directors are independent non-executive Directors, namely Ms. Chan Oi Chong (Chairman of Audit Committee, Remuneration Committee and Nomination Committee), Mr. Leung Yiu Man (Member of Audit Committee, Remuneration Committee and Nomination Committee) and Mr. Ho Pak Chuen Brian (Member of Audit Committee, Remuneration Committee and Nomination Committee).

Each of the Directors' respective biographical details is set out in the "Biographical details of Directors" of this annual report. As at the date of this report, the Board members have no financial, business, family or other relationships with each other.

BOARD DIVERSITY POLICY

During the year ended 31 March 2026, the Board has at all times adopted the board diversity policy. It sets out the approach to achieve and maintain diversity on the Board in order to enhance its effectiveness. The Company endeavors to ensure that the Board has the appropriate balance of skills, experience, expertise and diversity of perspectives. The appointments of board members will continue to be made on merit basis, and candidates will be considered against objective criteria, having due regard for the benefits of diversity of the Board. Pursuant to the board diversity policy, the Company seeks to achieve board diversity through the consideration of a number of factors, including but not limited to gender, age, culture and educational background, professional experience, skills, knowledge and length of service. The Board will set up and review the measurable objectives from time to time to ensure their appropriateness and ascertain the progress made towards achieving those objectives.

Targets have been set to maintain the Board with at least 50% of members being made up of non-executive directors and independent non-executive directors, together with an appropriate level of female member, which shall be at least one female member.

The Board has achieved the aforementioned targets during the year ended 31 March 2026. As at the date of this report, the Board comprises six directors, four of which are non-executive director and independent non-executive directors and two of them are female members.

The Board sets measurable objectives to implement the Board Diversity Policy and review such objectives from time to time and at least once per year to ensure their appropriateness and ascertain the progress made towards achieving those objectives. The Nomination Committee will review the Board Diversity Policy from time to time to ensure its continued effectiveness.

董事會就實施董事會成員多元化政策制定了可衡量目標，並不時及每年至少檢討一次該等目標，以確保其適當性並確定實行該等目標的進展。提名委員會將不時檢討董事會成員多元化政策，以確保其持續行之有效。

DIRECTORS' AND OFFICERS' LIABILITY INSURANCE

The Company has arranged for appropriate liability insurance to indemnify its Directors and officers against liabilities arising out of corporate activities. The insurance coverage is reviewed on an annual basis ensuring that the Directors and officers are adequately protected against potential legal liabilities.

DIRECTORS' TRAINING AND PROFESSIONAL DEVELOPMENT

Directors keep abreast of responsibilities as directors of the Company and the conduct, business activities and development of the Company.

Every newly appointed Director will receive formal, comprehensive and tailored induction on the first occasion of his/her appointment. This is to ensure the new employee possesses an appropriate understanding of the business and operations of the Company and has full awareness of Director's responsibilities and obligations under the Listing Rules and relevant statutory requirements.

Directors are expected to participate in appropriate continuous professional development to develop and refresh their knowledge and skills to ensure that their contribution to the Board remains informed and relevant.

During the year ended 31 March 2026, relevant reading materials including regulatory updates and seminar handouts, etc. were provided to the Directors for their reference and studying.

The Company Secretary of the Company is responsible for keeping minutes of all Board meetings and committee meetings. Draft minutes are normally circulated to Directors for comment within a reasonable time after each meeting and the final version is open for Directors' inspection.

According to current Board practice, any material transaction, which involves a conflict of interests for a substantial shareholder or a Director, will be considered and dealt with by the Board at a duly convened Board meeting. The Articles also contain provisions requiring Directors to abstain from voting and not to be counted in the quorum at meetings for approving transactions in which such Directors or any of their associates have a material interest.

APPOINTMENTS AND RE-ELECTION OF DIRECTORS

Executive Director, Mr. Hung Hon Man, has entered into service contracts with the Company for an initial fixed term of three years commencing from 1 April 2002 and will continue thereafter unless and until terminated by either party giving not less than three months' prior notice in writing to the other.

Other Directors did not enter into any service contract with the Company and there are no fixed or proposed length of service with the Company. All Directors are subject to retirement by the rotation at least once every three years.

According to the Articles, at each annual general meeting of the Company, one-third of the Directors for the time being (or, if their number is not three or a multiple of three, then the number nearest one-third) should retire from office by rotation. Further, any Director appointed to fill a casual vacancy or as an addition to the Board should hold office only until the next following annual general meeting of the Company and should then be eligible for re-election at the meeting.

At the forthcoming annual general meeting of the Company, Mr. Kam Eddie Shing Cheuk and Mr. Ho Pak Chuen Brian, will retire by rotation and, being eligible, will offer themselves for re-election.

董事會及董事會轄下委員會之會議－續

本公司之公司秘書負責保存所有董事會會議及委員會會議之會議記錄。草擬會議記錄一般會於每次會議後在合理時間內傳給董事閱覽以便彼等提出意見，而最終版本將公開供董事查閱。

委任及重選董事

執行董事洪漢文先生與本公司訂立由二零零二年四月一日起生效而初步固定年期為三年之服務合約，該等合約將一直有效，直至一方向對方發出不少於三個月之事先書面通知終止為止。

其他董事並未與本公司訂立任何服務合約，彼等於本公司並無固定或建議之服務年期。所有董事須至少每三年輪值告退一次。

根據細則，在本公司每年的股東週年大會上，當其時的董事中的三分之一，或如董事的人數並非三或三的倍數，則最接近三分之一人數的董事須輪值告退。此外，獲委任以填補臨時空缺或增加董事會名額的董事，只任職至本公司下屆股東週年大會，並於其時合資格在大會上膺選連任。

於本公司應屆股東週年大會上，甘承倬先生及何百全先生將輪值告退，彼等符合資格並願意膺選連任。

MODEL CODE FOR SECURITIES TRANSACTIONS

The Company has adopted the Model Code for Securities Transactions by Directors of Listed Issuers (the “Model Code”) set out in Appendix C3 to the Listing Rules as its own code of conduct regarding securities transactions by the Directors. All the Directors have confirmed, following a specific enquiry by the Company that they have complied with the required standard set out in the Model Code throughout the year ended 31 March 2026.

The Company has adopted written guidelines, “Code for securities transactions by relevant employees”, on no less exacting terms than the Model Code for securities transactions by relevant employees who are likely to be in possession of inside information of the Company.

No incident of non-compliance of the written guidelines by the employees was noted by the Company.

CHAIRMAN AND CHIEF EXECUTIVE OFFICER

The roles of the Company’s Chairman and CEO are complementary, but importantly, they are distinct and separate with a clear division of responsibilities.

Mr. Hung Hon Man, the chairman of the Company provides leadership to the Board; ensures effectiveness of the Board and helps foster better relationships between Directors.

Mr. Kam Eddie Shing Cheuk (CEO), focuses on implementing objectives, policies and strategies approved and delegated by the Board. He oversees the Company’s day-to-day management and operations. He is also responsible for developing strategic plans and formulating the company practices and procedures, business objectives, and risk assessment for the Board’s approval.

證券交易之標準守則

洪漢文先生（本公司主席）領導董事會，確保董事會有效運作，並協助董事之間建立更穩健的關係。

甘承倬先生（行政總裁）專注於執行董事會批准及授權實行的目標、政策及戰略，負責監督本公司的日常管理及營運，亦負責制定戰略計劃和制定本公司的常規及程序、業務目標及風險評估，以供董事會批准。

INDEPENDENT NON-EXECUTIVE DIRECTORS

Independent non-executive Directors have played a significant role in the Board by bringing their independent judgment at the Board meetings and scrutinising the Group's performance. Their views carry significant weight in the Board's decisions, in particular, they bring an impartial view to bear on issues of the Group's strategy, performance and control. All independent non-executive Directors possess extensive academic, professional and industry expertise and management experience and have provided their professional advices to the Board. The independent non-executive Directors provide independent advice on the Group's business strategy, results and management so that all interests of Shareholders can be taken into account and the interests of the Company and its Shareholders can be protected.

During the year ended 31 March 2026, the Board at all times met the minimum requirements of the Listing Rules relating to the appointment of at least three independent non-executive Directors.

The Company had complied with the requirement that these should include one such Director with appropriate professional qualifications of accounting or related financial management expertise. Ms. Chan Oi Chong and Mr. Leung Yiu Man have the appropriate professional qualifications and experience in financial matters required.

The Company has received written annual confirmation from each independent non-executive Director of independence pursuant to the requirements of the Listing Rules. The Board considers that three independent non-executive Directors are independent in character and judgement and they also meet the independence criteria set out in Rule 3.13 of the Listing Rules.

獨立非執行董事

獨立非執行董事在董事會中擔當重要的角色，在董事會會議上作出獨立的判斷及仔細審視本集團表現。彼等的意見對董事會的決策舉足輕重，尤其對本集團策略、表現及監控事宜發表不偏不倚的意見。所有獨立非執行董事均擁有豐富學歷、專業及行業知識以及管理經驗，一直為董事會提供專業意見。獨立非執行董事就本集團業務策略、業績及管理發表獨立意見，從股東整體利益著眼，使本公司及其股東利益得到保障。

於截至二零二六年三月三十一日止年度，董事會一直符合上市規則對最少委任三名獨立非執行董事之最低要求。

本公司已遵守須有一名獨立非執行董事具備適當專業資格，或具備會計或有關財務管理專長之規定。陳愛莊女士及梁耀文先生具備所需之財務事宜方面的適當專業資格及經驗。

本公司已收到各獨立非執行董事根據上市規則之規定就本身之獨立性發出的年度書面確認。董事會認為三名獨立非執行董事在品格及判斷方面均為獨立，彼等亦符合上市規則第3.13條所載之獨立標準。

DIVIDEND POLICY

The Company has adopted a dividend policy that, in recommending or declaring dividends, the Company shall maintain adequate and sufficient cash reserves for future growth. The Board has the full discretion to declare and distribute dividends to the Shareholders, and any final dividend for a financial year will be subject to Shareholders' approval. In proposing any dividend payout, the Board shall also take into account, among other things, the Group's general financial position, capital and debt level, future cash requirements and availability of business operations, business strategies and future development needs, any restrictions on payment of dividends and any other factors the Board may consider relevant. Any payment of the dividend by the Company is also subject to any restrictions under the Articles and all applicable laws and regulations.

DELEGATION BY THE BOARD AND COMMITTEES OF THE BOARD

The overall management of the Group's operation is vested in the Board. The Board takes overall responsibility to oversee all major matters of the Group, including the formulation and approval of all policy matters, overall strategic development of the Group, monitoring and controlling the Group's operation and financial performance, internal control and risk management systems, and monitoring of the performance of the senior management. The Directors have to make decisions objectively in the interests of the Company and its shareholders as a whole.

The day-to-day management, administration and operation of the Group are delegated to the CEO and senior management of the Group. The delegated functions and work tasks are periodically reviewed. Pursuant to the levels of authority approved by the Board, the senior management executes day-to-day operations unless the subject matter exceeds the authority granted by the Board or relates to any matters specifically reserved to the Board, they would seek approval from the Board.

The Board has established (i) Nomination Committee (ii) Remuneration Committee and (iii) Audit Committee, with defined terms of reference. The terms of reference of the Board committees which explain their respective roles and the authority delegated to them by the Board are posted on the websites of the Stock Exchange and the Company. Directors' responsibility

The Directors acknowledge their responsibilities for preparing the financial statements of the Company are to give a true and fair view and comply with all applicable regulatory requirements and accounting standards. In preparing the consolidated financial statements for the year ended 31 March 2026, the Directors have selected appropriate accounting policies and applied them consistently, and made judgments and estimates that are prudent and reasonable. The Directors are not aware of any material uncertainties relating to events or conditions that may cast significant doubt upon the Company's ability to continue as a going concern as at 31 March 2026. Accordingly, the Directors have prepared the consolidated financial statements for the year ended 31 March 2026 on a going concern basis.

The Board is responsible for overseeing the preparation of annual financial statements which give a true and fair view of the Group's financial position, its financial performance and cash flows for the year. Management provides the Board with management accounts and updates on a monthly basis, with a view to giving a balanced and understandable assessment of the Group's performance, financial position, and prospects to enable the Board as a whole and each Director to discharge their duties. In preparing the financial statements for the year ended 31 March 2026, the Board:

- (a) adopted HKFRSs, which conform to the International Reporting Standards in all material respects;
- (b) selected suitable accounting policies and applied them consistently;
- (c) made prudent and reasonable judgements and estimates; and
- (d) ensured that the financial statements were prepared on a going concern basis.

In financial year ended 31 March 2026, the annual and interim results were published within 3 months and 2 months respectively after the end of the relevant periods to provide stakeholders with transparent and timely financial information.

The Group's risk management and internal control systems are designed to provide reasonable, but not absolute, assurance against material misstatement or loss; to manage prudently but not completely eliminate the risk of system failure. Systems and procedures are put in place to identify, manage and control the risks of different businesses and activities.

The internal control system is to maintain proper accounting records and to comply with relevant laws and regulations. The Group has its independent audit function, assisting the Board and management to conduct regular and independent review to ensure a sound internal control system is being implemented, maintained, and relevant regulatory requirements are complied with. On a yearly basis, the internal audit personnel will present a report to the Audit Committee relating to operational, financial and compliance aspects and will alert the management on the audit review findings or irregularities, if any, advise them on the implementation of necessary steps and actions to enhance the internal controls of the Group.

For the year ended 31 March 2026, the Audit Committee, as delegated by the Board, has reviewed the report provided by the Group's internal audit personnel and is satisfied the adequacy and effectiveness of the Group's internal controls, including financial, operational and compliance controls and risk management. It has also considered the adequacy of resources, qualifications and experience of staff of the accounting and financial reporting functions and their training programs and budgets.

During the year ended 31 March 2026, the Board has set up its risk management policy and risk appetite statement which clearly defines the types of risk that the Group is prepared to pursue, retain or tolerate. The risk management process includes: (i) setting objectives, identifying ownership of risks, and risks that could affect the achievement of objectives; (ii) analyzing the likelihood and impact of risks and evaluate the risk portfolio accordingly; and (iii) considering the risk responses and ensure effective communication to the Board/senior management and ongoing monitor the residual risks (if any). A risk register was maintained as a tool for documenting risks and actions to manage each risk on an ongoing basis.

During the year, the senior management is responsible for maintaining and reviewing the effectiveness of the Group's risk control. The risk control is implemented to minimize the risks to which the Group is exposed to during the day-to-day operation of business. The senior management designs, implements and maintains the risk control to safeguard the assets of the Group. It also involves making decisions regarding which risks are acceptable and how to address those that are not.

The Board has confirmed that a review of the effectiveness of the risk management and internal control systems was conducted and considers them effective and adequate.

於截至二零二六年三月三十一日止年度，董事會已制訂風險管理政策及風險偏好聲明，其明確界定本集團準備面對、保留或容忍的風險類型。風險管理程序包括：(i) 訂立目標、確定負責應對風險方及可能影響目標達成的風險；(ii) 分析發生風險的成數及其影響，並相應地評估風險組合；及 (iii) 考慮風險應對方案，並確保向董事會／高級管理層進行有效溝通，並持續監察餘下風險（如有）。現已存置風險登記冊，作為記錄風險及行動的工具，以持續管理各項風險。

於本年度，高級管理層負責維護及審視本集團風險監控的成效。實施風險監控旨在盡量減少本集團在日常業務營運中面對的風險。高級管理層設計、實施和維護風險監控措施，以保護本集團的資產。其中亦涉及就可接受的風險以及如何應對不可接受的風險而作出決定。

董事會已確認，已經對風險管理及內部監控制度的成效進行檢討，並認為相關制度為有效和足夠。

DISCLOSURE OF INSIDER INFORMATION

The Group acknowledges its responsibilities to ensure potential inside information being captured and confidentiality of such information being maintained until consistent and timely disclosure are made in accordance with the Listing Rules. The Group has an inside information policy with the procedures and internal controls for handling and dissemination of insider information as follows:

- the Group conducts its affairs with close regard to the disclosure requirements under the Listing Rules as well as the “Guidelines on Disclosure of Insider Information” published by the Securities and Futures Commission of Hong Kong in June 2012;
- the Group has implemented its policy on fair disclosure by pursuing board, non-exclusive distribution of information to the public through public announcements and the Company’s website;
- the access of information is restricted to a limited number of employees on a need-to-know basis such that employees who are in possession of inside information are fully conversant with their obligations to preserve confidentiality; and
- the Group has established and implemented procedures for responding to external enquiries about the Group’s affairs and only designated persons are authorised to speak on behalf of the Company when communicating with external parties such as the media, analysts or investors.

WORKFORCE DIVERSITY

The Group also continues to adopt employee diversity measures to promote the diversity at all levels of its workforce. All eligible employees enjoy the equal opportunities for employment, training and career development without discrimination. As at 31 March 2026, the Group had a total workforce (including senior management) of 58 full time employees, of which 53% are males, and 47% are females. While we believe our future employee recruitment should predominantly be merit-based and do not consider it appropriate to set any target gender ratio for our workforce, we recognize and embrace the benefits of having a diverse workforce, and will continue to enhance the diversity of our workforce, subject to availability of suitable candidates.

Therefore, the Group is committed to maintaining a high degree of transparency to ensure that the investors and the shareholders of the Company receive accurate, clear, comprehensive and timely information about the Group through the publication of annual reports, announcements and circulars. The Company has in place a shareholders' communication policy ("Shareholders' Communication Policy") to ensure that shareholders' views and concerns are appropriately addressed.

The Company also publishes all corporate correspondences and certain relevant group's policies on the Company's website www.getnice.com.hk. Shareholders and investors may also email their queries to the Company's email address: investor@getnice.com.hk, which will be handled by the Company's Investor Relations team. The Board maintains regular dialogues with investors and analysts to keep them informed of the Group's strategy, operations, management and plans. The Directors and the members of the various board committees attend and answer questions raised at the general meetings of the Company. Separate resolutions are proposed at the general meetings on each substantially separate issue.

The chairman of the general meetings of the Company explains the procedures for conducting a poll before putting a resolution to vote. The results of the voting by poll are then published on the websites of the Stock Exchange and the Company respectively.

The Board has reviewed the effectiveness and implementation of Shareholders' Communication Policy and was of the view that, through the above-mentioned measures and the procedures mentioned under section "Shareholders' Right and Investor Relations" below, the Shareholders' Communication Policy remained effective and was implemented effectively, to ensure that the Company maintains long-term effective and good communication with its shareholders.

The principal risks and uncertainties facing the Group include strategic, commercial, operational and financial risks.

Strategic risks

The Directors maintain a strategic plan together with a financial budget at the end of each financial year based on then knowledge to the external environments and a number of forecast and estimates. The Group would invest in capital expenditures or require additional working capital by way of equities or debts fund raising based on the strategic plan in order to cope with the market demand and competition. Given the rapid change of unforeseeable external environments in the financial industry and properties investment sector, the Group is facing significant strategic risks on its capital expenditures and working capital requirements when changing the strategic plans to adopt the unexpected changes of external environments.

Commercial risks

The Group is facing the keen competition by other securities brokers or financial institutions. To maintain the Group's competitiveness, the management uses cost leadership strategy as well as diversifying its business strategy to tackle other competitors.

Operational risks

Management regularly reviews the Group's operations to ensure that the Group's risk of financial or reputational losses, or inability to deliver services to customers, resulting from fraud, errors, omissions, failed internal processes, IT systems and compliance matters, are adequately managed. The Group has also established its own business continuity plan, including but not limited to implementation of cyber security control and comprehensive cyber testing programme, to protect the Group from risk of interruption to its business continuity.

Financial risks

The principal financial risks are set out in note 6 to consolidated financial statements heading "FINANCIAL INSTRUMENTS" – "Financial risk management objectives and policies".

Under the Companies Act (as revised) of the Cayman Islands, the share premium of the Company is available for distribution or paying dividends to shareholders subject to the provisions of its Memorandum and Articles of Association and provided that immediately following the distribution of dividends, the Company is able to pay its debts as they fall due in the ordinary course of business.

- (ii) The special reserve of the Group represents the following:

As set out in the prospectus of the Company dated 24 May 2002, a group reorganisation (the "Reorganisation") was completed on 16 May 2002, which principally involved the exchange of shares of the Company with all the issued share capital of Get Nice Incorporated ("GN Incorporated"). An amount of approximately HK\$123,337,000 represents the difference between the nominal value of the shares of the subsidiaries together with the net book value of a subordinated loan capitalised at the date on which they were acquired by the Company and the nominal amount of the Company's shares issued for the acquisition at the time of the Reorganisation prior to the listing of the Company's shares, as well as the difference between the consolidated shareholders' funds of the acquired subsidiaries and the nominal value of the GN Incorporated's shares issued for the acquisition at the time of the Reorganisation prior to the listing of the Company's shares.

As set out in the prospectus of GNFG (defined in note 43), a subsidiary of the Company, dated 24 March 2016 (the "Prospectus"), shareholders of the Company would be entitled to one share of GNFG for every 40 shares of the Company held on the Record Date (as defined in the Prospectus). An amount of approximately HK\$35,810,000 represents the difference between the proportionate share of the interest in GNFG and the net assets value on Record Date in relation to the distribution in specie arising from the listing of the shares of GNFG on 8 April 2016.

As set out in note 33(a), a group reorganisation was effective on 25 March 2025, all GNFG's shares other than those held by the Company (the "Scheme Shares") were cancelled and extinguished in exchange for the consideration for the cancellation and extinguishment of the Scheme Shares (the "Scheme Consideration"). The amount of approximately HK\$848,737,000 represents (i) the fair value of the Scheme Consideration of approximately HK\$340,356,000 which was subsequently recognised as share capital and share premium upon the issue of new shares on 3 April 2025 and (ii) the difference between the carrying amount of net assets of GNFG attributable to the holders of the Scheme Shares adjusted and the fair value of the Scheme Consideration of approximately HK\$508,381,000.

1. CORPORATE INFORMATION

Get Nice Holdings Limited (the “Company”) was incorporated in the Cayman Islands under the Companies Act (as revised) of the Cayman Islands as an exempted company limited by shares and its shares are listed on The Stock Exchange of Hong Kong Limited (the “Stock Exchange”). Its immediate and ultimate holding company is Honeylink Agents Limited, a company incorporated in the British Virgin Islands with limited liability of which the entire share capital is beneficially owned by Mr. Hung Hon Man, who is also a director of the Company. The Company’s registered office is located at P.O. Box 31119 Grand Pavilion, Hibiscus Way, 802 West Bay Road, Grand Cayman, KY1-1205, Cayman Islands and its principal place of business is located at Ground Floor to 3rd Floor, Cosco Tower, Grand Millennium Plaza, 183 Queen’s Road Central, Hong Kong.

The principal activity of the Company is investment holding. The principal activities of its subsidiaries are set out in note 43 to the consolidated financial statements.

The consolidated financial statements of the Company and its subsidiaries (collectively referred to as the “Group”) are presented in Hong Kong dollars (“HK\$”), which is also the functional currency of the Company.

1. 公司資料

2. PRINCIPAL ACCOUNTING POLICIES

Basis of preparation

These consolidated financial statements have been prepared in accordance with HKFRS Accounting Standards, which collective term includes all applicable Hong Kong Financial Reporting Standards (“HKFRSs”), Hong Kong Accounting Standards (“HKASs”) and Interpretations issued by the Hong Kong Institute of Certified Public Accountants (the “HKICPA”), accounting principles generally accepted in Hong Kong and the disclosure requirements of the Hong Kong Companies Ordinance (the “HKCO”). The consolidated financial statements also comply with the applicable disclosure requirements of the Rules Governing the Listing of Securities on the Stock Exchange (the “Listing Rules”).

All amounts have been rounded to the nearest thousand, unless otherwise indicated.

These consolidated financial statements have been prepared on a basis consistent with the accounting policies adopted in the 2025 consolidated financial statements except for the adoption of the following revised HKFRS Accounting Standards that are relevant to the Group and effective from the current year.

Adoption of revised HKFRS Accounting Standards*Amendments to HKAS 21: Lack of Exchangeability*

The amendments require an entity to apply a consistent approach to assessing whether a currency is exchangeable into another currency and, when it is not, to determining the exchange rate to use and the disclosures to provide.

The adoption of the amendments does not have any significant impact on the consolidated financial statements.

Basis of measurement

The measurement basis used in the preparation of these consolidated financial statements is historical cost, except for buildings, investment properties and investments, which are measured at revalued amounts or fair value, as explained in the accounting policies set out below.

2. 主要會計政策

計量基準

編製該等綜合財務報表所用之計量基準為歷史成本法，惟如下文所述會計政策所闡釋若干樓宇、投資物業及投資乃按重估金額或公允值計量除外。

Basis of consolidation

The consolidated financial statements comprise the financial statements of the Company and all of its subsidiaries. The financial statements of the subsidiaries are prepared for the same reporting period as that of the Company using consistent accounting policies.

All intra-group balance, transactions, income and expenses and profits and losses resulting from intra-group transactions are eliminated in full upon consolidation. The results of subsidiaries are consolidated from the date on which the Group obtains control and continue to be consolidated until the date that such control ceases.

Non-controlling interests are presented, separately from owners of the Company, in the consolidated statement of profit or loss and other comprehensive income and within equity in the consolidated statement of financial position. The non-controlling interests in the acquiree, that are present ownership interests and entitle their holders to a proportionate share of the acquiree's net assets in event of liquidation, are measured initially either at fair value or at the present ownership instruments' proportionate share in the recognised amounts of the acquiree's identifiable net assets. This choice of measurement basis is made on an acquisition-by-acquisition basis.

Allocation of total comprehensive income

Profit or loss and each component of other comprehensive income are attributed to the owners of the Company and to the non-controlling interests on the basis of existing ownership interests and the possible exercise of conversion of potential voting rights is not considered. Total comprehensive income is attributed to the owners of the Company and the existing non-controlling interests even if this results in the existing non-controlling interests having a deficit balance.

所有集團內公司間之結餘、交易、因集團內公司間之交易產生之收支及損益於綜合入賬時悉數對銷。附屬公司業績自本集團獲得控制權之日起直至有關控制權終止之日止綜合入賬。

非控股權益獨立於本公司擁有人並於綜合損益及其他全面收益表以及綜合財務狀況表之權益內呈列。於被收購方屬於現時擁有權權益並賦予其持有人於清盤時按比例分佔被收購方資產淨值之非控股權益，乃初步以公允值或現時擁有權工具應佔被收購方可識別資產淨值中已確認款額之比例計量。按逐項收購基準選擇計量。

分配全面收益總額

本公司擁有人及非控股權益按現有擁有權權益之基準分佔損益及各部分之其他全面收益，並無考慮可能行使轉換潛在投票權。即使會導致現有非控股權益出現虧絀結餘，全面收益總額仍歸屬於本公司擁有人及現有非控股權益。

Changes in the Group's ownership interest in a subsidiary that do not result in a loss of control are accounted for as equity transactions. The carrying amounts of the controlling and non-controlling interests are adjusted to reflect the changes in their relative interests in the subsidiary. Any difference between the amount by which the non-controlling interests are adjusted and the fair value of the consideration paid or received is recognised directly in equity and attributed to the owners of the Company.

When the Group loses control of a subsidiary, the profit or loss on disposal is calculated as the difference between (i) the aggregate of the fair value of the consideration received and the fair value of any retained interest determined at the date when control is lost and (ii) the carrying amount of the assets (including goodwill), and liabilities of the subsidiary and any non-controlling interests at the date when control is lost. The amounts previously recognised in other comprehensive income in relation to the disposed subsidiary are accounted for on the same basis as would be required if the parent had directly disposed of the related assets or liabilities. Any investment retained in the former subsidiary and any amounts owed by or to the former subsidiary are accounted for as a financial asset, associate, joint venture or others as appropriate from the date when control is lost.

Goodwill

Goodwill arising on an acquisition of a business is measured at the excess of the consideration transferred, the amount of any non-controlling interests in the acquiree (if applicable) and the fair value of any previously held equity interest in the acquiree over the acquisition date amounts of the identifiable assets acquired and the liabilities assumed of the acquired business.

Goodwill on acquisition of business is recognised as a separate asset and is carried at cost less accumulated impairment losses, which is tested for impairment annually or more frequently if events or changes in circumstances indicate that the carrying value may be impaired. For the purpose of impairment test and determination of gain or loss on disposal, goodwill is allocated to cash-generating units. An impairment loss on goodwill is not reversed.

On the other hand, any excess of the acquisition date amounts of identifiable assets acquired and the liabilities assumed of the acquired business over the sum of the consideration transferred, the amount of any non-controlling interests in the acquiree (if applicable) and the fair value of the acquirer's previously held interest in the acquiree, if any, after reassessment, is recognised immediately in profit or loss as an income from bargain purchase. Any resulting gain or loss arising from remeasuring the previously held equity interests in the acquiree at the acquisition-date fair value is recognised in profit or loss or other comprehensive income, as appropriate.

Subsidiaries

A subsidiary is an entity that is controlled by the Group. The Group controls an entity when it is exposed, or has rights, to variable returns from its involvement with the entity and has the ability to affect those returns through its power over the entity. The Group reassesses whether it controls an investee if facts and circumstances indicate that there are changes to one or more of the elements of control.

In the Company's statement of financial position which is presented in note 42 to the consolidated financial statements, investments in subsidiaries are stated at cost less accumulated impairment losses. The carrying amount of the investments is reduced to its recoverable amount on an individual basis, if it is higher than the recoverable amount. The results of subsidiaries are accounted for by the Company on the basis of dividends received and receivable.

在綜合財務報表附註42所載之本公司財務狀況表內，於附屬公司之投資以成本減去減值虧損入賬。倘投資之賬面值高於其可收回金額，則按個別基準削減至其可收回金額。附屬公司之業績由本公司根據已收及應收股息為基準入賬。

Property and equipment

Property and equipment, other than buildings, are stated at cost less accumulated depreciation and impairment losses. The cost of an item of property and equipment comprises its purchase price and any directly attributable costs of bringing the asset to its working condition and location for its intended use. Repairs and maintenance are charged to profit or loss during the period in which they are incurred.

Buildings are stated at revalued amount, being the fair value at the date of valuation less accumulated depreciation and accumulated impairment losses. Fair value is determined by independent valuations which are performed annually. Increases in valuation are credited to the property revaluation reserve. Decreases in valuation are first offset against increases on earlier valuations in respect of the same asset and are thereafter charged to profit or loss. Any subsequent increases are credited to profit or loss up to the amount previously charged and thereafter to property revaluation reserve.

Depreciation is provided to write off the cost less accumulated impairment losses of property and equipment over their estimated useful lives from the date on which they are available for use and after taking into account their estimated residual values, using the straight-line method, at the following rates per annum:

An item of property and equipment is derecognised upon disposal or when no future economic benefits are expected to arise from the continued use of the asset. Any gain or loss arising on derecognition of the asset (calculated as the difference between the net disposal proceeds and the carrying amount of the item) is included in profit or loss in the year in which the item is derecognised.

If a property occupied by the Group as an owner-occupied property becomes an investment property measured at fair value, the Group accounts for such property in accordance with the policy stated under “Property and equipment” up to the date of change in use, and any difference at that date between the carrying amount and the fair value of the property is accounted for as a revaluation surplus or deficit.

Investment properties

Investment properties are properties that are held by owner to earn rental income and/or for capital appreciation. These include properties held for a currently undetermined future use and properties that are held under operating lease, which satisfy the definition of investment property and carry at fair value.

Investment properties are stated at fair value at the end of the reporting period. Any gain or loss arising from a change in fair value is recognised in profit or loss.

An investment property is derecognised upon disposal or when the investment property is permanently withdrawn from use and no future economic benefits are expected from its disposals. Any gain or loss arising on derecognition of the asset (calculated as the difference between the net disposal proceeds and the carrying amount of the asset) is included in profit or loss in the year in which the item is derecognised.

Trading rights

Trading rights confer eligibility on the Group to trade on the Stock Exchange. The trading rights have no foreseeable limit to the period over which the Group can use to generate cash flows. As a result, the trading rights are considered by the management of the Group as having indefinite useful lives because they are expected to contribute to net cash inflows indefinitely. The trading rights will not be amortised until its useful life is determined to be finite. They will be tested for impairment annually and whenever there is an indication that they may be impaired.

The useful life of the trading rights is reviewed annually to determine whether the indefinite life assessment continues to be supportable. If not, the change in the useful life assessment from indefinite to finite is account for on a prospective basis.

Club memberships

Club memberships with indefinite useful life are stated at costs less any impairment losses. Impairments are reviewed annually or when there are any indications that the club memberships have suffered impairment loss.

Such accounts receivable are initially measured at their transaction price.

Recognition and derecognition

Financial liabilities are recognised when and only when the Group becomes a party to the contractual provisions of the instruments.

A financial liability is derecognised when and only when the liability is extinguished, that is, when the obligation specified in the relevant contract is discharged, cancelled or expires.

Classification and measurement

Financial liabilities are initially recognised at their fair value plus, in the case of financial liabilities not carried at FVPL, transaction costs that are direct attributable to the issue of the financial liabilities.

The Group's financial liabilities include accounts payable, accrued charges and other payables. All financial liabilities are recognised initially at their fair value and subsequently measured at amortised cost, using the effective interest method, unless the effect of discounting would be insignificant, in which case they are stated at cost.

Impairment of financial assets

The Group recognises loss allowances for ECL on financial assets that are measured at amortised cost, Mandatory FVOCI to which the impairment requirements apply in accordance with HKFRS 9. Except for the specific treatments as detailed below, at each reporting date, the Group measures a loss allowance for a financial asset at an amount equal to the lifetime ECL if the credit risk on that financial asset has increased significantly since initial recognition. If the credit risk on a financial asset has not increased significantly since initial recognition, the Group measures the loss allowance for that financial asset at an amount equal to 12-month ECL.

Measurement of ECL

ECL is a probability-weighted estimate of credit losses (i.e. the present value of all cash shortfalls) over the expected life of the financial instrument.

For financial assets, a credit loss is the present value of the difference between the contractual cash flows that are due to an entity under the contract and the cash flows that the entity expects to receive.

Lifetime ECL represents the ECL that will result from all possible default events over the expected life of a financial instrument while 12-month ECL represents the portion of lifetime ECL that is expected to result from default events on a financial instrument that are possible within 12 months after the reporting date.

Where ECL is measured on a collective basis, the financial instruments are grouped based on the following one or more shared credit risk characteristics:

- (i) past due information
- (ii) nature of instrument
- (iii) nature of collateral
- (iv) industry of debtors
- (v) geographical location of debtors
- (vi) external credit risk ratings

Loss allowance is remeasured at each reporting date to reflect changes in the financial instrument's credit risk and loss since initial recognition. The resulting changes in the loss allowance are recognised as an impairment gain or loss in profit or loss with a corresponding adjustment to the carrying amount of the financial instrument, except in the case of Mandatory FVOCI, the loss allowance is recognised in other comprehensive income and accumulated in the investment revaluation reserve (recycling).

Definition of default

The Group considers the following as constituting an event of default for internal credit risk management purposes as historical experience indicates that the Group may not receive the outstanding contractual amounts in full if the financial instrument that meets any of the following criteria.

- (i) information developed internally or obtained from external sources indicates that the debtor is unlikely to pay its creditors, including the Group, in full (without taking into account any collaterals held by the Group); or
- (ii) there is a breach of financial covenants by the counterparty.

Irrespective of the above analysis, except for accounts receivable from margin clients and loans and advances, the Group considers that default has occurred when a financial asset is more than 90 days past due unless the Group has reasonable and supportable information to demonstrate that a more lagging default criterion is more appropriate.

Assessment of significant increase in credit risk

In assessing whether the credit risk on a financial instrument has increased significantly since initial recognition, the Group compares the risk of a default occurring on the financial instrument as at the reporting date with the risk of a default occurring on the financial instrument as at the date of initial recognition. In making this assessment, the Group considers both quantitative and qualitative information that is reasonable and supportable, including historical experience and forward-looking information that is available without undue cost or effort. In particular, the following information is taken into account in the assessment:

- the debtor's failure to make payments of principal or interest on the due dates;
- an actual or expected significant deterioration in the financial instrument's external or internal credit rating (if available);

- an actual or expected significant deterioration in the operating results of the debtor; and
- actual or expected changes in the technological, market, economic or legal environment that have or may have a significant adverse effect on the debtor's ability to meet its obligation to the Group.

Irrespective of the outcome of the above assessment, except for accounts receivable from margin clients and loans and advances, the Group presumes that the credit risk on a financial instrument has increased significantly since initial recognition when contractual payments are more than 30 days past due.

Notwithstanding the foregoing, the Group assumes that the credit risk on a financial instrument has not increased significantly since initial recognition if the financial instrument is determined to have low credit risk at the reporting date.

Low credit risk

A financial instrument is determined to have low credit risk if:

- it has a low risk of default;
- the borrower has a strong capacity to meet its contractual cash flow obligations in the near term; and
- adverse changes in economic and business conditions in the longer term may, but will not necessarily, reduce the ability of the borrower to fulfil its contractual cash flow obligations.

As detailed in note 6 to the consolidated financial statements, the financial instruments determined to have low credit risk includes bank balances – client accounts and bank balances – general accounts.

Simplified approach of ECL

For accounts receivable other than margin clients and loans and advances without a significant financing component, the Group applies a simplified approach in calculating ECL. The Group recognises a loss allowance based on lifetime ECL at each reporting date and has established a provision matrix that is based on its historical credit loss experience, adjusted for forward-looking factors specific to the debtors and the economic environment.

Credit-impaired financial asset

A financial asset is credit-impaired when one or more events that have a detrimental impact on the estimated future cash flows of that financial asset have occurred. Evidence that a financial asset is credit-impaired include observable data about the following events:

- (a) significant financial difficulty of the issuer or the borrower.
- (b) a breach of contract, such as a default or past due event.
- (c) the lender(s) of the borrower, for economic or contractual reasons relating to the borrower's financial difficulty, having granted to the borrower a concession(s) that the lender(s) would not otherwise consider.
- (d) it is becoming probable that the borrower will enter bankruptcy or other financial reorganisation.
- (e) the disappearance of an active market for that financial asset because of financial difficulties.
- (f) the purchase or origination of a financial asset at a deep discount that reflects the incurred credit losses.

Write-off

The Group writes off a financial asset when the Group has no reasonable expectations of recovering the contractual cash flows on a financial asset in its entirety or a portion thereof. The Group has a policy of writing off the gross carrying amount based on historical experience of recoveries of similar assets. The Group expects no significant recovery from the amount written off. However, financial assets that are written off could still be subject to enforcement activities under the Group's procedures for recovery of amounts due, taking into account legal advice if appropriate. Any subsequent recovery is recognised in profit or loss.

Cash equivalents

For the purpose of the consolidated statement of cash flows, cash equivalents represent short-term highly liquid investments which are readily convertible into known amounts of cash and which are subject to an insignificant risk of changes in value. For classification in the consolidated statement of financial position, cash equivalents represent assets similar in nature to cash and which are not restricted as to use.

Rental income

Rental income under operating leases is recognised when the assets are let out and on the straight-line basis over the lease term. Variable lease payments that depend on an index or a rate are initially measured using the index or rate at the commencement date and subsequently adjusted when such index or rate changes. Such payments are recognised as income on the straight-line basis over the lease term. Other variable lease payments are recognised as income in the period in which the event or condition that triggers those payments occurs.

If a performance obligation is not satisfied over time, the Group satisfies the performance obligation at a point in time when the customer obtains control of the promised asset. Revenue is recognised on the following bases:

- Commission income for broking business is recorded as income at a point in time on a trade date basis;

For revenue recognised over time under HKFRS 15, provided the outcome of the performance obligation can be reasonably measured, the Group applies the output method (i.e. based on the direct measurements of the value to the customer of the goods or services transferred to date relative to the remaining goods or services promised under the contract) to measure the progress towards complete satisfaction of the performance obligation because the method provides a faithful depiction of the Group's performance and reliable information is available to the Group to apply the method. Otherwise, revenue is recognised only to the extent of the costs incurred until such time that it can reasonably measure the outcome of the performance obligation.

Interest income

Interest income from financial assets is recognised using the effective interest method. For financial assets measured at amortised cost or Mandatory FVOCI that are not credit-impaired, the effective interest rate is applied to the gross carrying amount of the assets while it is applied to the amortised cost (i.e. the gross carrying amount net of loss allowance) in case of credit-impaired financial assets.

Foreign currency translation

Items included in the financial statements of each of the Group's entities are measured using the currency of the primary economic environment in which the entity operates (the "functional currency"). The consolidated financial statements are presented in the currency of HK\$, which is also the Company's functional currency.

Foreign currency transactions are translated into the functional currency using the exchange rates prevailing at the dates of the transactions. Foreign exchange gains and losses resulting from the settlement of such transactions and from the translation at year-end exchange rates of monetary assets and liabilities denominated in foreign currencies are recognised in profit or loss. Foreign exchange gains and losses resulting from the retranslation of non-monetary items carried at fair value are recognised in profit or loss except for those arising on the retranslation of non-monetary items in respect of which gains and losses are recognised directly in equity, in which cases, the gains or losses are also recognised directly in equity.

The results and financial position of all the group entities that have a functional currency different from the presentation currency ("foreign operations") are translated into the presentation currency as follows:

- Assets and liabilities for each statement of financial position presented are translated at the closing rate at the end of the reporting period.
- Income and expenses for each statement of profit or loss and other comprehensive income are translated at average exchange rate and
- All resulting exchange differences arising from the above translation and exchange differences arising from a monetary item that forms part of the Group's net investment in a foreign operation are recognised as a separate component of equity.

Impairment of non-financial assets

At the end of each reporting period, the Group reviews internal and external sources of information to assess whether there is any indication that its property and equipment, intangible assets, deposits paid for acquisition of property and equipment and investment properties and the Company's investments in subsidiaries may be impaired or impairment loss previously recognised no longer exists or may be reduced. If any such indication exists, the recoverable amount of the asset is estimated, based on the higher of its fair value less costs of disposal and value in use. Where it is not possible to estimate the recoverable amount of an individual asset, the Group estimates the recoverable amount of the smallest group of assets that generates cash flows independently (i.e. cash-generating unit).

If the recoverable amount of an asset or a cash-generating unit is estimated to be less than its carrying amount, the carrying amount of the asset or cash-generating unit is reduced to its recoverable amount. Impairment losses are recognised as an expense in profit or loss immediately.

A reversal of impairment loss is limited to the carrying amount of the asset or cash-generating unit that would have been determined had no impairment loss been recognised in prior years. Reversal of impairment loss is recognised as an income in profit or loss immediately.

The accounting policy for recognition of the impairment loss for goodwill is stated in the accounting policy for goodwill in the earlier part of this note.

Borrowing costs

Borrowing costs incurred, net of any investment income on the temporary investment of the specific borrowings, that are directly attributable to the acquisition, construction or production of qualifying assets, i.e. assets that necessarily take a substantial period of time to get ready for their intended use or sale, are capitalised as part of the cost of those assets. Capitalisation of such borrowing costs ceases when the assets are substantially ready for their intended use or sale. All other borrowing costs are recognised as an expense in the period in which they are incurred.

The Group assesses whether a contract is, or contains, a lease at inception of the contract. A contract is, or contains, a lease if the contract conveys the right to control the use of an identified asset for a period of time in exchange for consideration.

As lessee

The Group applies the recognition exemption to short-term leases and low-value asset leases. Lease payments associated with these leases are recognised as an expense on a straight-line basis over the lease term.

Amounts payable by the Group that do not give rise to a separate component are considered to be part of the total consideration that is allocated to the separately identified components of the contract.

The Group recognises a right-of-use asset and a lease liability at the commencement date of the lease.

The right-of-use asset is initially measured at cost, which comprises:

- (a) the amount of the initial measurement of the lease liability;
- (b) any lease payments made at or before the commencement date, less any lease incentives received;
- (c) any initial direct costs incurred by the Group; and
- (d) an estimate of costs to be incurred by the Group in dismantling and removing the underlying asset, restoring the site on which it is located or restoring the underlying asset to the condition required by the terms and conditions of the lease, unless those costs are incurred to produce inventories.

The lease liability is initially measured at the present value of the lease payments that are not paid at the commencement date of the contract.

The lease liability is remeasured by using the original discount rate when there is a change in the residual value guarantee, the in-substance fixed lease payments or the future lease payments resulting from a change in an index or a rate (other than floating interest rate). In case of a change in future lease payments resulting from a change in floating interest rates, the Group remeasures the lease liability using a revised discount rate.

The Group recognises the amount of the remeasurement of the lease liability as an adjustment to the right-of-use asset. If the carrying amount of the right-of-use asset is reduced to zero and there is a further reduction in the measurement of the lease liability, the Group recognises any remaining amount of the remeasurement in profit or loss.

The Group classifies each of its leases as either a finance lease or an operating lease at the inception date of the lease. A lease is classified as a finance lease if it transfers substantially all the risks and rewards incidental to ownership of the underlying asset. All other leases are classified as operating leases.

The Group accounts for each lease component within a lease contract as a lease separately from non-lease components of the contract. The Group allocates the consideration in the contract to each lease component on a relative stand-alone price basis.

The Group applies the derecognition and impairment requirements in HKFRS 9 to the operating lease receivables.

Employee benefits

Short term employee benefits

Salaries, annual bonuses, paid annual leave and the cost of non-monetary benefits are accrued in the year in which the associated services are rendered by employees.

Retirement benefit costs

Payment to defined contribution retirement benefit scheme and the Mandatory Provident Fund Scheme are recognised as expenses when employees have rendered service entitling them to the contributions.

Long service payments

The Group's net obligation in respect of long service payments under the Employment Ordinance is the amounts of future benefit that employees have earned in return for their services in the current and prior periods. The obligation is calculated using the projected unit credit method and discounted to its present value and after deducting the fair value of any related assets, including those retirement scheme benefits.

The Group's employees, including directors, receive remuneration in the form of share-based payment transactions, whereby the employees rendered services in exchange for shares or rights over shares.

The fair value of services received determined by reference to the fair value of share options granted at the grant date is expensed on a straight-line basis over the vesting period or is recognised as an expense in full at the grant date when share options granted vest immediately, with a corresponding increase in equity.

When share options are exercised, the amount previously recognised in share option reserve will be transferred to share premium. When the share options are forfeited after the vesting date or are still not exercised at the expiry date, the amount previously recognised in share option reserve will be transferred to retained profits/accumulated losses.

Equity-settled share-based payment transactions with parties other than employees are measured at fair value of the goods or services received, except where the fair value cannot be reliably estimated, in which case they are measured at fair value of the equity instruments granted. In all cases, the fair value is measured at the date the Group obtains the goods or the counterparty renders the services.

Taxation

The charge for current income tax is based on the results for the period as adjusted for items that are non-assessable or disallowed. It is calculated using tax rates that have been enacted or substantively enacted by the end of the reporting period.

Deferred tax is provided, using the liability method, on all temporary differences at the end of the reporting period between the tax bases of assets and liabilities and their carrying amounts in the consolidated financial statements. However, any deferred tax arising from initial recognition of goodwill; or other asset or liability in a transaction other than a business combination that at the time of the transaction affects neither the accounting profit nor taxable profit or loss and does not give rise to equal taxable and deductible temporary differences is not recognised.

The deferred tax assets and liabilities are measured at the tax rates that are expected to apply to the period when the asset is recovered or the liability is settled, based on tax rates and tax laws that have been enacted or substantively enacted at the end of the reporting period.

Deferred tax assets are recognised to the extent that it is probable that future taxable profit will be available against which the deductible temporary differences, tax losses and credits can be utilised.

Deferred tax is provided on temporary differences arising on investment in subsidiaries except where the timing of the reversal of the temporary differences is controlled by the Group and it is probable that the temporary difference will not reverse in the foreseeable future.

Government grants

Government grants are recognised at their fair value where there is reasonable assurance that the grant will be received and all attaching conditions will be complied with. Where the grant relates to an asset, the fair value is credited to a deferred income account/recognised as a deduction from the carrying amount of the relevant asset and is released to profit or loss over the expected useful life of the relevant asset by equal annual instalments.

The benefit of a government loan received at a below-market rate of interest is treated as a government grant. The benefit of the below-market rate of interest shall be measured as the difference between the initial fair value of the loan and the proceeds received.

Related parties

A related party is a person or entity that is related to the Group.

- (a) A person or a close member of that person's family is related to the Group if that person:
- (i) has control or joint control over the Group;
 - (ii) has significant influence over the Group; or
 - (iii) is a member of the key management personnel of the Group.

4. CRITICAL ACCOUNTING ESTIMATES AND JUDGEMENTS

Estimates and assumptions concerning the future and judgements are made by the management in the preparation of the consolidated financial statements. They affect the application of the Group's accounting policies, reported amounts of assets, liabilities, income and expenses, and disclosures made. They are assessed on an on-going basis and are based on experience and relevant factors, including expectations of future events that are believed to be reasonable under the circumstances. Where appropriate, revisions to accounting estimates are recognised in the period of revision and future periods, in case the revision also affects future periods.

Key sources of estimation uncertainty

Loss allowance for ECL

The Group's management estimates the loss allowance for financial assets at amortised cost including accounts receivable, loans and advances, other receivables and Mandatory FVOCI by using various inputs and assumptions including risk of a default and expected loss rate. The estimation involves high degree of uncertainty which is based on the Group's historical information, recoverable amount of pledged properties and securities collateral, past collection history of borrowers, concentration risk of borrowers, the Group's actual loss experience, existing market conditions as well as forward-looking estimates at the end of each reporting period. Where the expectation is different from the original estimate, such difference will impact the carrying amount of the financial assets at amortised cost and Mandatory FVOCI. Details of the key assumption and inputs used in estimating ECL are set out in note 6 to the consolidated financial statements.

Fair value of investment properties/buildings at revaluation

The fair value of investment properties located in Hong Kong and the United Kingdom and building in revaluation model was determined by an independent firm of professional valuers and/or by the directors of the Company. The valuation performed was arrived at with reference to recent market transaction prices at the end of reporting period and/or market rental value for similar properties at similar locations with total fair value of investment properties and buildings approximately HK\$1,282,393,000 (2025: HK\$1,205,315,000) and HK\$53,474,000 (2025: HK\$58,704,000) at 31 March 2026 respectively. Favourable or unfavourable changes to recent market prices would result in (i) changes in the fair value of the Group's investment properties and corresponding adjustments to the amount of gain or loss reported in profit or loss; and (ii) change in the revaluation amount of the buildings of the Group and corresponding adjustments to the amount of gain or loss reported in other comprehensive income.

Tax losses

At the end of the reporting period, no deferred tax asset has been recognised in respect of certain tax losses of approximately HK\$273,130,000 (2025: HK\$266,683,000) due to the majority of the balances are subject to further approval by the local tax authority. In addition, the realisability of the deferred tax asset mainly depends on whether sufficient future profits or taxable temporary differences will be available in the future. In cases where the actual future profits generated are more than expected, a material recognition of deferred tax assets may arise, which would be recognised in profit or loss for the period in which such recognition takes place.

稅項虧損

於報告期末，由於大部分結餘須待地方稅務機關進一步批准作實，因此並無就約273,130,000港元（二零二五年：266,683,000港元）之若干稅項虧損確認遞延稅項資產。此外，變現遞延稅項資產主要視乎是否有足夠未來溢利或將來可供利用的應課稅暫時差異而定。倘未來實際產生的溢利多於預測，遞延稅項資產可能會出現重大確認，並會於有關確認發生期間的損益內確認。

5. CAPITAL RISK MANAGEMENT

The Group manages its capital to ensure that entities in the Group will be able to continue as a going concern while maximising the return to shareholders through the optimisation of the debt and equity balance. The capital structure of the Group consists of debt when applicable, and equity attributable to owners of the Company, comprising issued share capital as disclosed in note 33 to the consolidated financial statements respectively and reserves as disclosed in the consolidated statement of changes in equity. The management reviews the capital structure by considering the cost of capital and the risks associated with each class of capital. In view of this, the Group will balance its overall capital structure through the payment of dividends, new share issues as well as the issue of new debt or the redemption of existing debt. The Group's overall strategy remains unchanged throughout the year.

Certain group entities are regulated by the Hong Kong Securities and Futures Commission (the "SFC") and are required to comply with the financial resources requirements according to the Hong Kong Securities and Futures (Financial Resources) Rules (the "SF(FR)R"). The Group's regulated entities are subject to minimum paid-up share capital requirements and liquid capital requirements under the SF(FR)R. Management closely monitors, on a daily basis, the liquid capital level of these entities to ensure compliance with the minimum liquid capital requirements under the SF(FR)R. The Group's regulated entities have complied with the capital requirements imposed by the SF(FR)R throughout the years ended 31 March 2026 and 2025.

本集團管理其資本，以確保本集團之實體將能夠持續經營，並透過優化債務及權益結餘為股東帶來最大回報。本集團之資本架構包括債務（如適用）及本公司擁有人應佔權益，包含綜合財務報表附註33披露之已發行股本，以及綜合權益變動表披露之儲備。管理層考慮資金成本及各類資本之相關風險，從而檢討資本架構。有鑑於此，本集團將透過派付股息、發行新股以及發行新債務或贖回現有債務而平衡整體資本架構。年內，本集團之整體策略維持不變。

Market risk

Market risk can be described as the risk of change in fair value of a financial instrument due to changes in interest rates, equity prices or foreign currency exchange rates.

Interest rate risk

The Group is exposed to cash flow interest rate risk in relation to variable-rate bank balances. The Group currently does not have an interest rate hedging policy. However, the management monitors interest rate exposure and will consider hedging significant interest rate risk should the need arise.

Sensitivity analysis

The management considers that the Group's exposure to cash flow interest rate risk on variable-rate bank balances, as a result of the change of market interest rate is insignificant due to low interest rates on bank balances at the end of the reporting period, thus no sensitivity analysis is prepared for cash flow interest rate risk.

Other price risk

The Group is exposed to equity price risk through its investments in listed equity securities. The directors of the Company manage the exposure by closely monitoring the portfolio of these financial instruments. The fair value of these financial instruments will be affected either positively or negatively, amongst others, by the changes in the closing market prices of the relevant listed equity securities.

Sensitivity analysis

The sensitivity analysis has been determined based on the exposure to equity price risks at the end of the reporting period. If the prices of the respective listed equity instruments had been 10% (2025: 10%) higher/lower, and held other variables constant, the Group's profit for the year would increase/decrease by approximately HK\$11,420,000 (2025: HK\$7,621,000), as a result of changes in the fair value of listed equity securities.

市場風險

利率風險

本集團因可變利率銀行結餘而面對現金流量利率風險。本集團目前並無利率對沖政策。然而，管理層監察利率風險，並將於有需要時考慮對沖重大利率風險。

敏感度分析

管理層認為，由於報告期末銀行結餘的利率偏低，本集團因市場利率變動而產生的可變利率銀行結餘現金流量利率風險不大，因此並無就現金流量利率風險編製敏感度分析。

其他價格風險

The Group has certain exposures to foreign currency risk as some of its business transactions, assets and liabilities are denominated in currencies other than the functional currency, mainly British pound (“GBP”) and United States dollars (“US\$”).

The Group currently does not have a foreign currency hedging policy in respect of foreign currency transactions, assets and liabilities. The Group will monitor its foreign currency exposures closely and will consider hedging significant foreign currency exposures should the need arise.

Sensitivity analysis

The sensitivity analysis has been determined based on the exposure to equity price risks at the end of the reporting period. If exchange rate of GBP had appreciated/depreciated against the functional currencies of the respective group entities by 5.2% (2025: 1.1%) and all other variables were held constant, the Group’s other comprehensive income would increase/decrease by approximately HK\$31,543,000 (2025: approximately HK\$7,457,000) as a result of changes in the carrying amount of these assets.

Since the exchange rate of HK\$ is pegged with US\$, the Group does not expect any significant movements in the US\$/HK\$ exchange rates. The management considers the Group’s exposure on foreign exchange rate risk from US\$ is limited. Accordingly, no sensitivity analysis has been presented on the currency risk on US\$.

Credit risk

The carrying amount of financial assets recognised on the consolidated statement of financial position, which is net of impairment losses, represents the Group's exposure to credit risk.

The Group's maximum exposure to credit risk which will cause a financial loss to the Group due to failure to discharge an obligation by the counterparties arises from the carrying amounts of the respective recognised financial assets as stated in the consolidated statement of financial position.

The Group exposes to credit risk, which is the risk that a counterparty will be unable to pay amounts in full when due. Impairment allowances are made for losses that are expected at the end of the reporting period. Significant changes in the economy or environment of a particular industry segment could result in losses that are different from those provided for at the end of the reporting period. Management therefore carefully manages its exposure to credit risk. Accounts receivable from margin clients

The Group provides financing services only to recognised and creditworthy third parties. It is the Group's policy that all these margin clients are subject to credit verification procedures. The margin loans are secured by pledged marketable securities and margin facilities are set to ensure that certain proportion of the fair value of pledged marketable securities of the individual margin clients is higher than the corresponding outstanding loans.

The Group has concentration of credit risk as 60% (2025: 51%) of the total net accounts receivable from margin clients was due from the Group's ten largest margin clients.

No aging analysis is disclosed, as in the opinion of the directors of the Company, the aging analysis does not give additional value in view of the nature of business of securities margin financing.

The Group's customer base consists of a wide range of clients and the accounts receivable from margin clients are categorised by common risk characteristics that are representative of the customers' abilities to pay all amounts due in accordance with the contractual terms.

In estimating the ECL and in determining whether there is a significant increase in credit risk since initial recognition, whether the financial asset is credit-impaired and the amount of loss given default, the Group has taken into account the credit quality of margin clients, the collateral to accounts receivable balances ratio, amount of margin shortfall of margin clients and pledged marketable securities and adjusted for forward-looking factors that are specific to the debtors and general economic conditions of the financial industry, in estimating the probability of default of these financial assets, as well as the loss upon default in each case. There was no change in the estimation techniques or methodology made during the year.

Management has money lending policies in place and the exposure to the credit risk is monitored on an ongoing basis. The Group grants loans only to recognised and creditworthy third parties. It is the Group's policy that all these borrowers are subject to credit verification procedures. The credit verification procedures include assessment on the credit quality of the customer based on the customer's financial position, past experience and other factors such as security or collateral. Also, the Group has other monitoring procedures to ensure that follow-up action is promptly taken to recover overdue debts.

At 31 March 2026, the Group has concentration of credit risk as 80% (2025: 70%) of total loans and advances was due from the Group's five largest borrowers, within the money lending segment.

In estimating the ECL and in determining whether there is a significant increase in credit risk since initial recognition and whether the financial asset is credit-impaired, the Group has taken into account the historical actual credit loss experience of the borrowers and the financial position of the counterparties by reference to, among others, the background search for individual clients, amount of pledged assets, their management or audited accounts or available press information, adjusted for forward-looking factors that are specific to the debtors and general economic conditions of the industry in which the counterparties operate, in estimating the probability of default of these financial assets, as well as the loss upon default in each case. There was no change in the estimation techniques or methodology made during the year.

The Group has established a loan credit risk classification system and performs credit risk management based on loan classification in one of three categories of internal credit rating. The information about the ECL for the loan receivables at the end of the reporting period is summarised below. After considering the above factors, provision of net impairment loss of approximately HK\$30,874,000 (2025: HK\$20,684,000) was recognised during the year.

In estimating the ECL, the Group has taken into account the historical actual credit loss experience over the past years and the financial position of the counterparties by reference to, among others, their management or audited accounts and available press information, adjusted for general economic conditions and future prospects of the industry in which the counterparties operate and various external sources of actual and forecast economic information such as information published by economic expert reports, financial analysts and government bodies in estimating the probability of default of these financial assets, as well as the loss upon default in each case. The management of the Group considers the ECL of these financial assets to be insignificant after taking into account the financial position and credit quality of the counterparties.

In estimating the ECL and in determining whether there is a significant increase in credit risk since initial recognition and whether the financial asset is credit-impaired, the Group has taken into account the historical actual credit loss experience, financial information and adjusted for forward-looking factors that are specific to the counterparties and general economic conditions of the industry in which the counterparties operate, in estimating the probability of default of these financial assets, as well as the loss upon default in each case. There was no change in the estimation techniques or methodology made during the year.

After considering the above factors, no provision of impairment loss was recognised during the years ended 31 March 2026 and 2025.

As part of the measures to safeguard liquidity, the Group has maintained substantial stand-by banking facilities, diversifying the funding sources and spreading out the maturity dates.

At 1 April 2025, one of the properties with carrying value of approximately HK\$70,735,000 were transferred from property and equipment to investment properties upon change of its use to earn rental income and/or for capital appreciation. In the opinion of the directors, the estimated fair value of the properties at date of transfer amounted to approximately HK\$71,798,000 which is estimated by directors making reference to the valuation from Prudential Surveyors (Hong Kong) Limited (“PSL”), an independent professional qualified valuer.

At 31 March 2026, the property interests in leasehold land and the buildings thereon (including the whole or part of undivided share in the underlying land) in Hong Kong, which are reported as property and equipment with net carrying value of approximately HK\$366,593,000 (2025: HK\$455,340,000) at the end of the reporting period, are held by the Group as the registered owner. Those property interests were acquired from the previous registered owners by making lump sum payments at the upfront. Except for the variable amounts to be charged by the government subsequently that are reviewed regularly with reference to the rateable values, for example, there are no ongoing payments to be made under the terms of the land lease. At the end of the reporting period, the remaining lease term is about 21 years (2025: 22 years).

The buildings of the Group with carrying amount of approximately HK\$53,474,000 (2025: HK\$58,704,000) are stated at fair value under revaluation model.

The buildings of the Group were valued at 31 March 2026 by PSL (2025: PSL), an independent professional qualified valuer, on direct comparison approach based on price information of comparable properties and adjusted to reflect the condition and locations of the buildings. PSL is not connected with the Group, and has appropriate qualifications and recent experience in the valuation of similar properties in the relevant locations.

於二零二六年三月三十一日，香港租賃土地及其上樓宇的物業權益（包括相關土地的全部或部分不可分割份額）由本集團作為登記業主持有，該權益於報告期末入賬為賬面淨額約為366,593,000港元（二零二五年：455,340,000港元）的物業及設備。該等物業權益乃以前期一次性付款方式向前登記業主收購。除政府其後會參照應課差餉租值定期檢討所收取的浮動金額外，例如，根據土地租賃條款，並無持續付款。於報告期末，餘下的租賃期約為21年（二零二五年：22年）。

本集團賬面值約53,474,000港元（二零二五年：58,704,000港元）的樓宇以重估模式按公允值呈列。

本集團之樓宇乃由獨立專業合資格估值師測建行（二零二五年：測建行）於二零二六年三月三十一日按照直接比較法，根據可資比較物業的價格資料進行估值並作出調整以反映樓宇的狀況及位置。測建行與本集團並無關連，其具備合適之資格及最近對有關地點類似物業之估值經驗。

In estimating the fair value of the buildings, the highest and best use of buildings is the current use. In estimating the fair value of the Group's buildings, the management of the Group uses market-observable data to the extent it is available. Where Level 1 inputs are not available, the management of the Group engages third party qualified valuers to perform the valuation of the Group's buildings. At the end of each reporting period, the management of the Group works closely with the qualified external valuers to establish and determine the appropriate valuation techniques and inputs for Level 3 fair value measurement. The management of the Group would first consider and adopt Level 2 inputs where inputs can be derived from observable quoted prices in the active market. When Level 2 inputs are not available, the management of the Group would adopt valuation techniques that include Level 3 inputs. Where there is a material change in the fair value of the assets, the causes of the fluctuations will be reported to the directors of the Company.

One of the key unobservable inputs used in valuing the buildings is the unit sale rate ranging from approximately HK\$3,000 to HK\$26,000 per square foot (2025: HK\$4,000 to HK\$31,000 per square foot), taking into account age, location and other individual factors such as size and levels of building. An increase/decrease in the unit sale rate would result in increase/decrease in fair value measurement of the buildings.

Buildings are classified as Level 3 under fair value hierarchy at 31 March 2026 and 2025. There were no transfers into or out of Level 3 during years ended 31 March 2026 and 2025.

If the buildings under property and equipment had not been revalued, they would have been included in these consolidated financial statements at historical cost less accumulated depreciation and accumulated impairment losses of approximately HK\$61,286,000 (2025: HK\$68,139,000).

No leasehold land and buildings have been pledged to secure banking facilities granted to the Group during the years end 31 March 2026 and 2025.

All of the Group's investment properties located in Hong Kong and the United Kingdom interests held under leases to earn rentals or for capital appreciation purposes are measured using the fair value model and are classified and accounted for as investment properties.

Certain investment properties are leased to independent third parties for a term of 0.5 to 5 years (2025: 1 to 5 years), which had an initial non-cancellable lease term of 0.5 to 3 years (2025: 1 to 3 years). Some leases provide the lessees with options to renew the leases upon expiry at new terms. The tenant also bears the management fees and amounts charged by the government such as the rates levied on the investment properties.

The details of the lease income from operating leases are set out in note 7 to the consolidated financial statements.

The investment properties are subject to residual value risk. The lease contracts, as a result, include a provision on residual value guarantee based on which the Group has the right to charge the tenant for any damage to the investment properties at the end of the lease. Besides, the Group has purchased insurance for certain investment properties to mitigate the loss that may arise from accidents or physical damages of the properties.

36. MAJOR NON-CASH TRANSACTION

During the year ended 31 March 2026, the Group entered into sale and purchase agreements with six independent third parties to acquire seven investment properties and two subsidiaries at a consideration of HK\$52,700,000 and HK\$13,500,000 respectively. The consideration was settled by loan and advances and margin receivables balance of HK\$29,500,000 and HK\$36,700,000 respectively. Details of the acquisition of subsidiaries are set out in note 37 to the consolidated financial statements.

37. ACQUISITION OF A SUBSIDIARY

On 24 October 2025, the Group entered into sale and purchase agreements with three independent third parties to acquired 100% equity interest of Keen Perfect Limited (“Keen Perfect”) and Wealth Famous Development Limited (“Wealth Famous”) at a consideration of HK\$5,800,000 and HK\$7,700,000 respectively. The consideration was settled through the loan and advances and margin receivables balance owed by the independent third party and his related parties. The principal activity of Keen Perfect and Wealth Famous is property holding. The acquisition was completed on 28 November 2025. Upon completion of the acquisition, Keen Perfect and Wealth Famous became wholly-owned subsidiaries of the Group.

In the opinion of the directors, the acquisition does not constitute business combination as defined in HKFRS 3 (Revised) “Business Combinations”. Therefore, the acquisition has been accounted for as acquisition of assets during the year.
