UNAUDITED RESULTS OF SUZHOU QINGYUE FOR THE QUARTER ENDED 31 MARCH 2026

This announcement is made by the Company pursuant to Rule 13.09 of the Listing Rules and the Inside Information Provisions under Part XIVA of the SFO.

Suzhou QingYue, which shares are listed on the Science and Technology Innovation Board of the SSE and in which the Group has an equity interest of about 28.08%, announced on 29 April 2026 its unaudited results for the quarter ended 31 March 2026. The loss attributable to the owners of Suzhou QingYue for the quarter ended 31 March 2026 amounted to approximately RMB32 million (equivalent to approximately HK\$37 million), as compared with a loss attributable to the owners of Suzhou QingYue of approximately RMB16 million for the quarter ended 31 March 2025.
