Remarks (if any):

The Company has adopted an RSU Scheme, which took effect as of March 1, 2014, to issue 30,200,000 ordinary shares of the Company in aggregate to identified individuals. To satisfy the grant of shares under the scheme, 14,107,500 ordinary shares of the Company were issued in aggregate on October 23, 2015, and 10,200,000 ordinary shares of the Company were issued in aggregate on December 18, 2018. The details of the scheme are available in the Company's 2018 annual report published on April 26, 2019.

At the annual general meeting held on June 8, 2018, the shareholders resolved to grant a general mandate to repurchase up to 146,928,073 ordinary shares in the open market from time to time. During the period from March 29, 2019 to April 12, 2019, the Company repurchased a total of 20,973,000 shares, which were cancelled on April 29, 2019.
