The Company has adopted an RSU Scheme, which took effect as of March 1, 2014, to issue 30,200,000 ordinary shares of the Company in aggregate to identified individuals. To satisfy the grant of shares under the scheme, 14,107,500 ordinary shares of the Company were issued in aggregate on October 23, 2015, 10,200,000 ordinary shares of the Company were issued in aggregate on December 18, 2018 and 14,000,000 ordinary shares of the Company were issued in aggregate on September 3, 2019. The details of the scheme are available in the Company's 2020 annual report published on April 28, 2021.
