DELAY IN DESPATCH OF CIRCULAR

Reference is made to the announcements dated 22 January 2018, 6 February 2018, 2 March 2018, 23 March 2018, 20 April 2018 and 25 May 2018 issued by ORIENT VICTORY TRAVEL GROUP COMPANY LIMITED (the “**Company**”) in relation to the Acquisitions (the “**Announcements**”).
