On 28 November 2014, the Company entered into a convertible bonds agreement for the issue of 9% unlisted convertible bonds due 2016 with each of the following subscribers: (a) China Life Insurance (Overseas) Company Limited in the principal amount of HK\$800 million which are convertible into 4,000,000,000 new Shares; (b) Cross-Strait Capital Limited in the principal amount of HK\$32 million which are convertible into 160,000,000 new Shares; (c) VMS Private Investment Partners III Limited in the principal amount of HK\$160 million which are convertible into 800,000,000 new Shares; (d) Strait Capital Service Limited in the principal amount of HK\$800 million which are convertible into 4,000,000,000 new Shares; and (e) Strait CRTG Fund, L.P. in the principal amount of HK\$700 million which are convertible into 3,500,000,000 new Shares. Besides, the Company also entered into a convertible bonds agreement for the issue of 9% unlisted convertible bonds due 2018 with the following subscriber: (a) China Life Insurance (Overseas) Company Limited in the principal amount of HK\$700 million which are convertible into 3,500,000,000 new Shares. Upon conversion of all the convertible bonds at the initial exercise price of HK\$0.20 per share, 15,960,000,000 new shares of the Company will be issued.
